There are 4 NHA's in Leitrim which will be directly affected by the ban- the areas are Cashel Bog, Corracramph Bog, Cloonageeher Bog and the bogs along the Rinn River – there are a further 2 NHAs which straddle the Leitrim/Longford border- Aghnamona Bog and Wooddown Bog- which will also be affected by the ban. The ban, which is due to come into effect at the end of 2013, would result in an almost total cessation of turf cutting in the South Leitrim area and will cause a lot of anger within communities who have been harvesting turf on their bogs for generations".
