**IF YOU ARE FEELING WELL**

If you are feeling well, carry on with your normal routine.

Follow the advice on how to protect yourself and others from coronavirus and other infections such as flu.

Avoid spending time with people who are ill with a cough, high temperature, or breathing problems.

If you develop symptoms of coronavirus:

#### Kilkenny Day 11<sup>th</sup> October, 2020

Kilkenny County Council was delighted to host Kilkenny Day, 2020. Kilkenny people at home and abroad used their imagination and ingenuity to join in, while those at home got out and about in a very safe socially distanced way.

Over 40 events both physical and virtual took place right across the county;

Online events garnered a huge response from followers including the "Kilkenny Conversations" series of interviews conducted by Edward Hayden.

The response of the schoolchildren of the county to Kilkenny Day – from Mooncoin to Lisnafunchin – to the 1,000 Bikes to School was phenomenal. The hope now is that the younger generation have been inspired to make their journeys to school healthier and kinder to the environment.

The Young Soldier *Thomas Woodgate* from Mill Street, Callan, Co. Kilkenny was only 14 years old when he died in October 1918. He was the youngest official Irish casualty from the 26 Counties who died as a result of enemy fire in World War 1-1914 - 1918. The Kilkenny Great War Memorial Committee unveiled a new sculpture dedicated to Thomas Woodgate at the Courthouse on the 11<sup>th</sup> October, 2020.



We can confirm that this first Kilkenny Day will not be the last. The support from our local communities and businesses throughout the City and County was remarkable so we hope to use this years event to build on an even bigger and better event in our 2021 calendar.

#### ROADS

##### NATIONAL ROADS

###### Kilkenny Major Schemes:

###### N25 Glenmore to Waterford Scheme

The scheme is within the concluding stage of Phase 2 - Option Selection. A preferred route corridor is expected to be announced in early Q1 2021.

###### N24 Waterford to Cahir Scheme

Arup and Partners Ireland Ltd are working in the early stages of this project which take approximately 60 months. Their brief is to bring the scheme through the statutory processes. (*Planning, CPO, etc.*)

###### Kilkenny Minor Schemes

A number of minor schemes are progressing through various stages in conjunction with TII on the national road network.

###### N24 Tower Road

Planning approval for the proposed scheme was secured in 2019. Approval of the Compulsory Purchase Order for the scheme was given by An Bord Pleanála on the 5<sup>th</sup> August 2020. We are presently undertaking the administrative procedures necessary to give effect to that decision. It is expected that construction will commence in 2021.

###### N77 Ballyragget to Ballynaslee

A planning application under 177AE and a Compulsory Purchase Order application will be submitted to An Bord Pleanála in the coming weeks for the above project.

###### N24 Carrick Road

The section of N24 proposed to be improved is rural in nature and located immediately North West of the village of Mooncoin in County Kilkenny. The overall length of the scheme is 1.9km. We are currently preparing the necessary documentation to make an application to An Bord Pleanála for approval under 177AE and also

Compulsory Purchase Order approval for the scheme. It is expected that the application will be made in the early part of Q1 2021.

###### OTHER

###### N76 Callan By-Pass to Ballymack and Cuffesgrange Pavement Project

A major pavement project involving improvement to 5.05km including drainage improvements, road markings, etc has been completed on the N76.

###### Castlecomer Footbridge

The preparation of construction tender documents is on-going with a view to going to tender in December 2020 or early Q1 2021. The main construction works will take place during the summer 2021 with works completed by Q4 2021.

#### FORWARD PLANNING

##### City & County Development Plan

Updates on the process of the City & County Development Plan are provided on the dedicated portal for the draft plan at [Ourplan.Kilkenny.ie](http://Ourplan.Kilkenny.ie).

##### South East Greenway

Government announced funding of approximately €15.5 million for the South East Greenway, incorporating the Kilkenny Greenway, which is the current estimated cost being provided for the project over 2021/2022. The increase in grant aid recognises the challenges faced by Councils nationally in finding the matched funding for significant capital projects during the current COVID crisis. The original grant aid was €8 million to deliver the Kilkenny Greenway Project. The Minister's announcement provides for €9 million in 2021 with the remainder of the current estimated cost being available in 2020. It is estimated that the South East Greenway will take 18 months to complete and will be due to open during 2022.

##### North Quays Project:

Government has announced funding of €110 million for the overall North Quays Project in Waterford which will see the relocation of the train station in Waterford to the North Quays site along with a bridge to link the North Quays to the South Quays around the Clock Tower. This bridge will also link the Waterford Greenway with the Kilkenny Greenway which also recently received additional national funding to enable its early delivery. All going to plan the Kilkenny Greenway will open for use in 2022. This project is a very significant investment in the South East and South Kilkenny will benefit directly from the announcement with the following four projects located in Ferrybank and Belview included in the announcement:

**Belmont Link Road:** The provision of this road, linking from the Abbey Road to the Belmont Road, will support building of houses by opening

up lands for development and facilitating the planned population growth for the Greater Waterford City in a compact manner.

**Abbey Road - Greenway Connectivity:** The Kilkenny Greenway benefitted from an announcement of a significant increase in grant aid on Monday and today's announcement provides for additional connection points to the Kilkenny Greenway. This will give greater access and facilitate usage of the Greenway in Ferrybank as a smarter travel option for people living and working in the area. It will also provide greater connectivity to schools in the area.

**Abbey Road & Belmont Road Improvement Works:** The delivery of this project will enhance the approaches to the North Quays and will accommodate cycling infrastructure.

In addition, there is funding for works on **the Port Road:** The planned upgrade works will provide access to open up additional lands for development. This work is considered critical if Belview Port is to grow to its full potential.

##### Masterplans

In a parallel process a number of masterplans for the areas of Loughmacask, St Canice's Campus (*the former St. Canice's Hospital*) and the Fairgreen area of the City are being prepared. This work was impacted by Covid 19. Work is continuing with the preparation of these masterplans with the first of these, Loughmacask, being the furthest advanced. Members will be briefed before any draft masterplans are placed on public display.

##### Graiguenamanagh Local Area Plan

A draft joint Local Area Plan for Graiguenamanagh and Tinnahinch has been finalised. It was agreed with Carlow County Council that the plan will be placed on public display for 8 weeks from mid November 2020.

##### Conservation

Projects availing of the Built Heritage Investment Scheme and the Historic Structures Fund nearing completion.

#### Building Control

A total of 286 valid Commencement Notices were received in 2020 up to the end of October. This compares with 264 commencement notices for the same period in 2019.

#### Taking in Charge

Works are ongoing on the following estates:

- The Green, Ballyfoyle.
- Friary Walk, Callan.
- Roseleigh, Mooncoin
- Banagher Court, Piltown.
- Rath Ullard, Kilkenny City

#### Vacant Sites

- There are currently 30 sites on the Vacant Sites Register. A total of 19 of these are now liable for the 7% levy. The Council was in the process of issuing payment demands in March, however that process was halted following the Government's Emergency Order. The process will recommence to ensure compliance with statutory deadlines. Two sites have had their levy discharged to date.

- The number of cancelled entries due to site activation or improvement now stands at 13 sites.
- As part of the annual review of sites around the county, survey work has commenced and a number of sites are being assessed for addition to the Register for 2021.

#### PARKS

##### Parks & Playgrounds

The new Ferrybank park and playground opened to the public on the 12<sup>th</sup> of October. It has been very well received by the local community and has been extremely busy demonstrating it was a much needed facility for the area. The playground boasts an activity trail, zipline, swings and slides and the centrepiece being a large ship unit with a variety of play elements incorporated. An adult gym zone is located immediately beside the playground so parents and children can enjoy the facilities at the same time. A ball wall is placed out in the open parkland to allow for informal ball games.

The park is being jointly funded by the Department of Housing, Planning, and Local Government (50%), Kilkenny County Council (25%) and Waterford City & County Council (25%).

The new park and playground will be maintained by the Parks Department and added to our weekly inspection regime. The local Tidy Towns Association have kindly offered to assist in litter picking to help keep the park in good condition.

#### Woodstock Gardens

The installation of a new adventure play area is now complete. The new play area will almost double the playground space for adventure play with children encouraged to play in the woods with sand, wood and other natural elements. The activity trail will add another element in the gardens for families to enjoy and also help to minimise wear and tear on more formal parts of the gardens. This project is funded through the Sports Capital scheme.



Local artist Gill Campden is currently painting a mural of a Victorian scene on the wall of the conservatory which houses the tea room. The tea room has had a full refurbishment while it was closed during the Covid Restrictions and we look forward to opening a new and improved facility in 2021.

With Christmas approaching plans are being put in place to make Woodstock part of YuleFest. There will be some fun festive installations set in the woods similar to the Cats trail for Kilkenny Day and the conservatory will be decorated in a Victorian Christmas theme.



#### Outdoor Recreation Infrastructure Scheme (ORIS)

Works under the current round of ORIS Measure 1 funded schemes are now complete. Applications under this heading can attract funding up to €20,000 plus match funding. The projects completed this year included the following:

- Freshford Loop Walk - surface upgrade
- Kilkenny Outdoor Activity Trail - Marketing of amenities including flyers and brochure development;
- Tory Hill, Mullinavat - Improvement works to existing walking trail.
- Woodstock Estate, Inistioge - Social media marketing campaign to promote Woodstock Garden and Trails within the estate.

Of the two ORIS Measure 2 funded schemes which can attract funding up to a maximum of €200,000, plus match funding, works are expected to commence at Poulanassy Waterfall before year end. Whilst in Graiguenamanagh the reconstruction of the Silaire Wood boardwalk along the River Barrow along with the rehabilitation of the existing woodland trails is nearing completion and it is anticipated that this wonderful amenity will reopen to the public in December. Apart from the nuts and bolts the new boardwalk is made from 100% recycled plastic, made from a mixture of blended plastic from household items such as bottle caps, plastic film and margarine tubs.





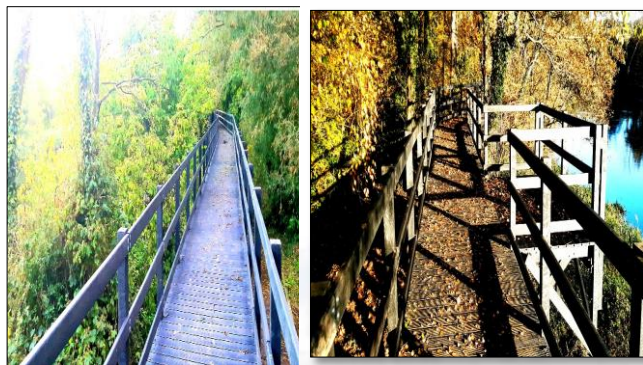

#### 2020 Call for new applications under the Outdoor Recreation Infrastructure Scheme

The scheme is open to all Local Authorities and a number of other State Agencies, and funding is allocated via a competitive process based on the quality of the applications put forward. To this end, we endeavor to ensure highest quality applications are put forward.

The funding applications are divided into following three categories:

**Measure 1:** Grant available €20,000 and Local Authorities can submit a maximum of 5 applications.

**Measure 2:** Grant available €200,000 and Local Authorities can submit a maximum of 3 applications.

**Measure 3:** Grant available €500,000 and Local Authorities can submit a maximum of 1 application.

(10% Match funded must be provided by the Local Authority)

At the end of September, the following new Measure 1 applications were submitted to the Department of Rural and Community Development:

Applications are currently being prepared for Measure 2 and 3 schemes which must be submitted by the end of November. The schemes that will be submitted under same include:-

- Creation of Biodiversity and Recreational Countryside Park at Dunmore – Measure 3
- Woodstock Estate- Continuation of Loop Trail improvements -Measure 2
- Castlecomer Discovery Park – Upgrade Tree Top Walk – Measure 2
- Westcourt Callan - Continuation of Moat Field Loop Trail – Measure 2

#### South East Greenway

Works are at advanced stage on the rail lifting contract on the South East Greenway which runs from Ferrybank in South Kilkenny to New Ross, terminating at Mount Elliot. Rails and sleepers are now lifted over approximately 80% of the track. The rails and sleepers are being collected at Rosbercon at the old railway station and returned to CIE to their central yard in Portlaoise. The railway sleepers are considered hazardous waste due to the presence of creosote and will be safely disposed of by CIE after collection.

In the urban section of the Greenway in the Ferrybank area, screen fencing is being erected shortly to address concerns over security and privacy due to the proximity of the old railway line to back gardens, in particular in the Ard Glas area. Preparation works are underway to install sections of screen fencing where very open views are possible into rear gardens.

The lifting of rails and sleepers will clear the way for construction of the Greenway which is anticipated to commence in 2021. The route covers a distance of 24km in total, much of this travelling through rural south Kilkenny, terminating at Ferrybank from where in future it will link with the Waterford Greenway. The Greenway will pass through some very scenic countryside in south Kilkenny. At Carrickcloney there will be views of the new Rose Fitzgerald Kennedy Bridge and the river Barrow. In New Ross the Greenway will bring visitors through the 600-metre-long Mount Elliot tunnel having crossed the River Barrow over the Redbridge. From here there are stunning views up and down the River Barrow.

Two Part 8 planning applications for Greenway Car Parks to facilitate access to the Greenway at Raheen, New Ross and Ballyverneen, Glenmore are listed for decision by the Elected Members. These applications were on public display in the Ferrybank Area Office, County Hall Planning Office and in New Ross Municipal District Offices.

Tender documents for the engagement of consultancy services to prepare a route selection and design options report with respect to pedestrian and cyclist connectivity from the Greenway to the villages of Glenmore and Slieverue were issued at the end of October. An application to cover the cost of the professional fees associated with same was submitted by Trail Kilkenny to Kilkenny LEADER Partnership and supported by the Council.



## ENVIRONMENT

### Draft Horse Bye Laws 2020

Kilkenny County Council has advertised its intention to make Bye Laws for the Control of Horses in the County of Kilkenny and to make provision for the Control, Welfare and Licensing of Horses. These Bye Laws will also incorporate horse exclusion zones within Kilkenny City.

These Bye Laws, if adopted, will replace the Control of Horses Act, 1996, Horse Bye Laws 2015. The Draft Bye Laws are currently available for public inspection at a number of Council offices throughout the County. They are also available on the Council's website and free of charge from the Environment Section.

Written submissions on the Draft Bye Laws are invited and should be sent to the Environment Section. Submissions may also be made online on the consultation portal of Kilkenny County Council at <https://consult.kilkenny.ie>

### Halloween Bonfires

In conjunction with a public awareness and safety campaign on the dangers of bonfires and fireworks Enforcement Officers from the Environment Section carried out numerous inspections around the City and County in the lead up to Halloween to detect any stockpiled material that may be used for illegal bonfires.

On the whole people seemed to be complying with the advice given and only small amounts of materials were detected.

#### Carlow/Kilkenny Dog Shelter



The 2019 Annual National Dog Statistics, based on returns from all Local Authorities, were recently published. Compared with the national statistics the number of dogs euthanised in the Carlow/Kilkenny Dog Shelter is very favourable when compared with the rest of the Country in that the percentage of dogs euthanised national was 4.4% compared with 0.75% for Carlow/Kilkenny.

This is despite the fact the national figures show a reduction of 8% in the number of dogs entering LA run shelters whereas in the Carlow/Kilkenny Shelter the number dogs taken in increased by 45%.

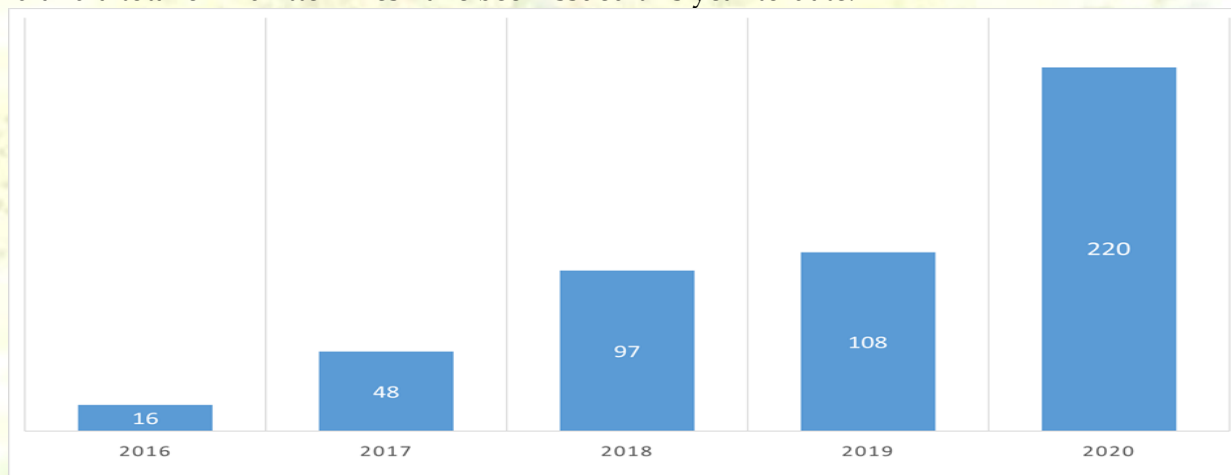
In line with HSE/Government guidelines on essential services the Carlow/Kilkenny Dog Shelter and Dog Warden Services has remained open to the public but by appointment only. Further information is available at [www.kilkennycoco.ie](http://www.kilkennycoco.ie)

#### Environmental Complaints

The number of complaints logged and investigated by Environment staff this year to-date has seen a significant increase on 2019 figures with 1,127 cases logged for 2020 compared with 957 during the same period last year, representing an 18% increase for the year and a 29% increase since Covid-19 restrictions were introduced.

The nature of these complaints range from littering, illegal dumping, water quality, noise, abandoned cars and odours from controlled and illegal burning and farm activity. However, the majority continue to be related to littering and illegal dumping.

Despite the restrictions imposed due to Covid-19, our Enforcement Officers remain very active on the ground and a total of 220 litter fines have been issued this year to-date.

#### Summary of the waste inspections completed under our RMCEI plan for 2020

The restrictions put in place to combat the spread of Covid-19 has impacted on planned inspections that require site visits and/or meetings with landowners. However, Environment staff have endeavoured to carry out as many inspections as possible and indeed in some cases have exceed yearly targets for particular inspection requirements. To facilitate the continuation of our inspection regime, protocols were put in place, since restriction were introduced, to safe guard members of the public and staff.

A summary of some of the inspections undertaken to date is provided in the below table:

#### Environmental Education

All primary schools received their Climate Change Pack during An Taisce "Climate Change Week". The pack included climate change themed educational resources, biodiversity resources from the Heritage Officer and a newsletter providing resource links to assist their environmental studies this autumn.

Due to the closure of schools in March, An Taisce were late processing some Green School applications. Kilkenny County Council is delighted to inform members that the Presentation Secondary School, Kilkenny and Listerlin NS recently received notification of their Green Flag Awards for Litter and Waste. This is in addition to St. Senans NS in Kilmacow who also received their first green flag. Congratulations to all three schools as it takes a lot of work to achieve this award. An online Green Schools information evening took place on the 19<sup>th</sup> of October for green school co-ordinators. An Taisce emphasised the programmes flexibility and provided guidance on how to progress the programme with Covid restrictions in place. These activities completed by the Environmental Awareness Officer are actions of Kilkenny County Council's Climate Change Adaptation Strategy and the Southern Region Waste Management Plan 2015-2020.

#### Home Energy Saving Kits

Cathaoirleach Cllr Andrew McGuinness took time out of his busy schedule in October to launch the Home Energy Saving Kits which are now available to borrow from every library branch in the County. The kit assist householders to detect potential energy savings and will be a great asset for tidy towns groups and schools who wish to borrow the kit to explore energy conservation. Kits are available as part of the library service click and collect and book and browse services which are operational at Covid restrictions level 4 and below. This initiative is an action of Kilkenny County Council's Climate Change Adaptation Strategy 2019-2024.



#### The Acorn Project

Kilkenny County Council sponsored a day's workshop by Kilkenny Forest School, Slí na Coille allowing Thomastown Scouts to have a day of nature connection which included acorn picking. Inspired by the story 'Every oak begins with an Acorn', the scouts learned about the valuable ecosystem of the woodland and the 150 acorns that the scouts collected will become part of the Acorn Project tree nursery which the scouts will develop later in the season.



All Tidy Town groups registered with the Council's Tidy Town Forum were contacted and invited their members to collect acorns on an individual basis this autumn in their own locality. Storage advice was provided and it's hoped a spring tidy towns outdoor forum will take place in Q1 of 2021, creating an acorn nursery with the assistance of the Kilkenny Forest School in Woodstock Gardens. This will be coupled up with a Forest Therapy Walk, a wellbeing exercise to connect mindfulness with nature. The collaboration with The Acorn Project is an action associated with Kilkenny County Councils Climate Change Adaptation Strategy 2019-2024.

#### Irish Business Against Litter IBAL

Kilkenny City has once again been deemed cleanest of 40 towns and cities surveyed by business group Irish Business Against Litter (IBAL). Kilkenny topped the IBAL litter rankings for a record 5<sup>th</sup> time. An Taisce, who conduct the surveys on behalf of IBAL, praised Kilkenny saying "Again Kilkenny comes up shining! The series of interconnecting laneways between the streets and medieval area were excellent – this is often not the case in other towns / cities throughout the country."

Kilkenny County Council acknowledges the combined efforts of outdoor staff, garden staff and volunteers who continuously patrol the city to ensure the city looks its best. The Environment Section leads both enforcement and education initiatives to ensure everyone plays their part in keeping Kilkenny litter free.

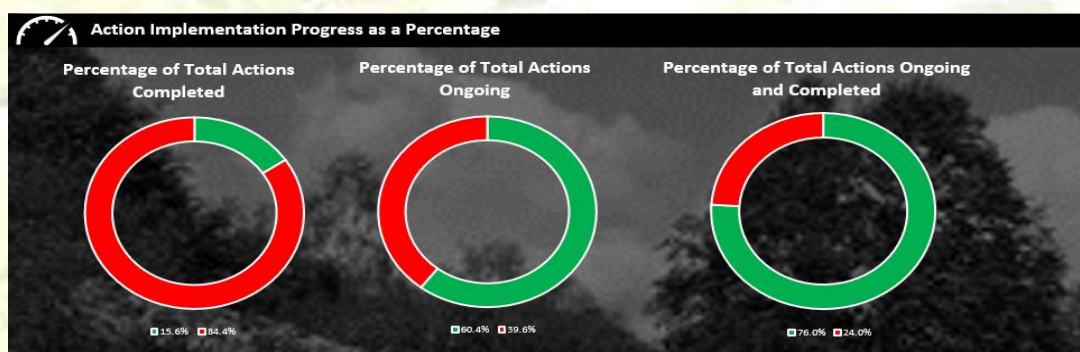
A two-week radio campaign ran on KCLR at the beginning of the restriction 5 lock down to remind dog walkers to clean up after their dogs, this campaign ran from the 28<sup>th</sup> of October to the 7<sup>th</sup> of November.

#### Virtual Waste Roadshow

Kilkenny County Council in collaboration with the Southern Waste Region Office is preparing a virtual waste roadshow which will take place between the 23<sup>rd</sup> – 27<sup>th</sup> of November. The week will see the debut of the Dunmore Recycling Centre promotional video and will mark the launch of a Paint Smarter Campaign, an EPA funded waste prevention project collaboration between Waterford, Kilkenny & Carlow Local Authorities. Each day will carry a specific theme, a schedule will be issued to elected members when its finalised. DIY tips will be shared throughout the week by Marianne @the revamp tramp who is a furniture up-cycler. As it's a virtual roadshow, it would be greatly appreciated for elected members to share posts and films across their social media when content is loaded up on Kilkenny County Councils social media platforms. This will ensure a greater audience reach throughout the City, County and hopefully further afield!

#### Kilkenny Climate Change Adaptation Strategy 2019 -2024 (CCAS)

The Environment Section has completed the annual review of the Kilkenny Climate Change Adaptation Strategy and submitted the findings of same to the Eastern & Midland Climate Action Regional Office and the DCCAE. To date, 15% of the 96 actions have been completed with another 60% having commenced in the past 12 months.

A review was also undertaken of the CCAS Sub-action Plan which was developed in December of 2019. This Sub-action Plan targeted 235 specific actions derived from the 96 main actions within the CCAS. In total, and despite the challenges faced by the organisation around Covid-19, of the 235 sub-actions 185 have commenced and or completed, representing 79% of the total.

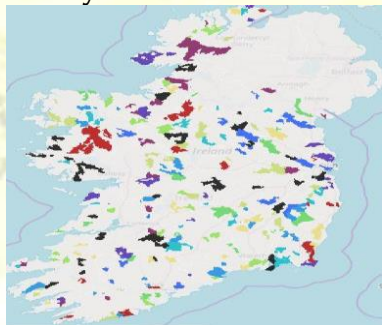
#### LAWPRO – Local Authorities Water Programme

The Bregagh is one of 190 Priority Areas for Action across the country. From its source near Dreelingstown, the Bregagh River flows into the River Nore beside the Abbey Quarter development in Kilkenny City.

#### Priority Areas for Action



The River Basin Management Plan (2018-2021) has identified a number of our waterbodies for focussed action to improve water quality. These are the **Priority Areas for Action (PAA)** listed in Appendix 2 of the Plan. This is part of a new and collaborative approach engaging all stakeholders, specifically at a local level. The process involves scientific assessment of existing information followed by stream walks in the catchment to better understand the issues and develop locally appropriate solutions. Nationally, there are 190 priority areas for action covering 726 water bodies.

## COMMUNITY

### Kilkenny Integration Strategy

The Kilkenny Migrant Integration Strategy is being finalised. The process has taken longer because of the Covid 19 restrictions. The final stages of the plan involve the agreement of lead agencies on actions in the plan. Once this step is finalised the plan can then go forward to the full Council for approval.

### Town & Village Health Checks

The tender process has commenced for undertaking 5 health checks in the following areas Castlecomer, Goresbridge, Urlingford/Johnstown Mullinavat and Thomastown. It is expected that the health check will be started in January 2021 and completed by April 2021.

### Town & Village Projects – Accelerated Measures

Work is progressing well on projects in Inistioge, Castlecomer, Callan and Graiguenamanagh which were awarded funding under the Accelerated Measures. The Community Team are also linking with communities in the 4 district towns regarding the provision of Christmas lights, another project which received funding under this stream.

### CLÁR 2020

The Department of Rural and Community Development have awarded Kilkenny €77,000 under the CLAR grant scheme. The scheme is for designated CLAR areas as defined due to rural depopulation.

The following schemes were successful.

- (i) Muckalee Community Creche, Completion of community Car Park and associated works, serving the Community Creche and National School. €50,000
- (ii) Coolagh Church and Community Hall, Safety measures and access improvement along the junction of the R698. €27,000

### SICAP Plan 2021

The LCDC is in the processing of overseeing the 2021 SICAP Plan for Kilkenny. The budget remains the same at €631,889. The SICAP Sub-group of the LCDC is responsible for developing the plan in partnership with CKLP. The Final Plan will be approved by the LCDC.

### Kilkenny Resettlement Programme 2018-2020

The final stages of the Kilkenny Resettlement Programme are in train. The programme has been supported by Respond with a resettlement worker. The worker will finish in January 2021. There is general agreement that an interagency structure should remain in place to ensure gaps in meeting the needs of families can continue to be coordinated. The SICAP 2021 plan is looking to add additional supports to families.

### Kilkenny One-parent Families

The One-parent families steering group will be launching the Voice and Visibility research and Action Plan by the end of November 2021. This is a key action outlined in the LECP.

### Healthy Kilkenny

The Healthy Kilkenny Programme has allocated Mental Health Grants to a total of €32,000. Grants averaged between €2,500 and €5,000. The recipients include -Social Farming (in Callan), Foroige, Transgender Equality Network, Amber Women's Refuge, Open Circle Women's Arts Collective, South East Regional Family Support Network for support packs to families in Kilkenny, The Mill FRC in Urlingford and LikelinkK.

This grant is part of a programme from the Government of Ireland, implemented through Sport Ireland and its network of Local Sports Partnerships to support the sports sector during the COVID-19 pandemic. This scheme is designed to support clubs, which do not have the finances to implement COVID-19 related protocols.

High potential companies and their innovations can progress onto Enterprise Ireland's Agile Innovation or Research and Development grant support to develop a company's innovation pipeline. This one-to-one practical mentoring programme will be led by Laurence Knell of Strategic Innovation Partners Ltd, an experienced strategy, innovation and leadership consultant.

#### **'BRIGHTSTART' PROGRAMME**

The BrightStart South East Start-Up programme has been designed to help new start-ups define their business idea and have a step by step action plan to deliver their business goals in this changing business world. What sets the BrightStart programme apart is that high potential start-ups will be given the opportunity to pitch their idea to Enterprise Ireland, South East Business Innovation Centre and their Local Enterprise Office to apply for accelerated grant support and services which can fundamentally boost a start-up business's growth potential. Topics include Female-Led Start-Ups, Green Technology Start-Ups, New Normal (Brexit/Covid-19 innovations) Start-Ups and Remote Working Start-Ups.

Each sector will have a dedicated webinar focusing on start-up supports and entrepreneurial culture required for successful business development growth. After the webinar businesses will have completed essential work that will frame the strategic thinking for their business. Mentoring support will be provided to assist participants to develop a prioritised action plan for the business concept. This plan will form part of the pitch to funding agencies to apply for accelerated grant aid and business supports.

Kilkenny County Council were successful under the Town & Village Renewal Scheme 2020 -

We continue to be cognisant that the current Level 5 restrictions have closed our museums, galleries our hotels, pubs and restaurants and restricts our movement at the current time. This is an extremely difficult time for businesses and the tourism and hospitality sector have been one of the most severely impacted sectors in our economy.

#### FIRE SERVICES

##### Capital Projects

A new fire engine for Callan was handed over to Kilkenny County Council's Fire Service for training familiarisation with Callan Fire Brigade in October 2020. The new fire engine will be "on the run" in the coming days.

##### Fire Safety Certificates

101 applications for fire safety certificates were received up to 3rd November 2020. This was a 16% increase in 2019 applications for the same period last year.

##### Fire Services Acts 1981 and 2003

To date Fire Prevention staff have made 36 inspections of premises both to provide advice and to enforce legislation. As of 3rd November 2020, 83 Licence Applications were processed under Section 24 of the Fire Services Acts 1981 & 2003.

##### Fire Brigade Operations

Fire Brigades responded to 690 turnouts up to the 31st October 2020. The same period last year we responded to 631 turnouts.

##### Rhyme Rag Poetry Workshops for TY students

## FINANCE

The expenditure by service division to the end of October is set out in table 1. Total Expenditure for the ten months to the end of October was €83.66m compared with the annual budget of €83.6m. The expenditure under development management includes a sum of €8.6m relating to the restart grants. This expenditure was not included in the budget but is fully funded by the Department of Business, Enterprise and innovation.

The bank overdraft facility was utilised six times during the ten month period to the end of October 2020. The earlier payment by Government Departments of grant monies including the Local Property Tax allocation has assisted cashflow since the beginning of the Covid-19 crisis.

The audit of the 2019 Annual Financial Statements commenced on 13<sup>th</sup> July. The audited statements will be presented to Council later in the year on completion of the annual audit by the Local Government Auditor.

### Rates Revaluation

The Valuation Office conducted a revaluation of all commercial properties throughout County Kilkenny to come into effect for the year 2018 as part of its ongoing programme to revalue all such properties within the State.

The following is an update on appeal outcomes and outstanding appeals:

- 197 Rate Customers appealed their valuation to the Valuation Tribunal.
- Total value of rate demand under appeal is €4.5m, 22.6%
- 165 appeals have been completed to date (28 *withdrawn*)
- 132 of the 165 appeals have resulted in a reduction in rates income, 4 confirmed the decision of the revaluation, 1 resulted in an increase in rates income & 28 were withdrawn.
- Income lost to date = €768,642
- 32 appeals outstanding
- If this trend continues the total loss will be in the region of €1m.

### **Impact of Covid-19 on Council Finances**

Covid-19 is presenting serious financial challenges as all income streams have been impacted. In October, Government announced that the waiver on commercial rates for businesses impacted was being extended by another three months to nine months covering the period to the end of December 2020. The estimated compensation arising is €8.3m. This leaves a balance of approximately €2m to be collected on commercial rates. The estimated shortfall on income from goods and services has now increased to €2m due to the impact of the current lockdown. Additional costs arising from Covid-19 are estimated at €5m. Submissions have been made to Government on these issues seeking compensation for the losses being incurred.

Expenditure in a number of areas in the 2020 budget totalling €2.35m has been deferred until further clarity is obtained regarding the income loss for the year. The current estimate on the target savings is €1.8m as the planned savings in housing will not be achieved due to the pressures on maintenance and housing grants.

There is a significant risk that the Council will incur a deficit for 2020 based on the current projections in the absence of additional compensation from Government.

### **Budget 2021**

The budget process for 2021 has already commenced. As already stated the Covid-19 crisis is presenting unprecedented financial challenges for the Council in the current year and will continue to do so into 2021. All income streams are and will be impacted for the foreseeable future. The statutory Budget meeting for the Council is fixed to take place at 3pm on Friday, 27<sup>th</sup> November.

### **Re-Start/Restart Plus Grants**

The Restart Grant Plus Grant Scheme closed as of 31st October, 2020. Kilkenny County Council has received 1,243 Restart Grant Plus applications. The Restart Team has approved and paid 1,096 applications totalling €5,855,298. This is in addition to 966 applications processed under Restart 1 with a total payment of €2,948,925 bringing the total paid to date to €8,804,223.

The Restart Team is currently processing the 30% top up for all Restart Grant Plus applications and appeals in relation to Restart Grant 1. Appeals arise where eligible businesses failed to apply for Restart Grant 1 before the early cut off closing date of 22nd July. There is no application for the appeal process and the Restart Team will be in contact with eligible applicants who have applied for Restart Grant Plus or businesses who contacted the Restart Team directly.

### **Rates Waiver**

As part of the support measures for businesses announced by Government a waiver on commercial rates for the nine months to the end of December is being provided for eligible businesses. The waiver will take the form of a credit in lieu of rates.

The Finance Department is currently working on the application of the waiver across the eligible accounts. Credit in lieu of rates will be applied to eligible accounts and customers will be notified by letter in the next week.
