If you are feeling well, carry on with your normal routine.

Follow the advice on how to protect yourself and others from coronavirus and other infections such as flu.

Avoid spending time with people who are ill with a cough, high temperature, or breathing problems.

#### ST. PATRICK'S DAY



The St. Patrick's Festival Kilkenny 2021 was programmed and planned in line with COVID-19 Government regulations. This necessitated designing, creating and producing a new 'virtual festival model'. The inputs and resourcing achieved to achieve this was both unprecedented and extensive. The quality programme resulted in record-high viewers and engagement numbers.

For the very first time St. Patrick's Festival Kilkenny 2021 took place virtually on the 16<sup>th</sup>/17<sup>th</sup> March, 2021. Programming the new festival model was extensive and resulted in: 5 broadcasts providing 7 hours of content, involving 20 acts, 19 local businesses, 18 local organisations, 5 schools, 4 twinned-town Mayors, 3 marching bands, 2 presenters and 40 individual and family submissions.

The broadcasts were watched by 6,500 people on the day and nearly 14,000 people in total (including Wolfwalkers in concert with Kíla on other channels). 14 'Get Involved' events took place in the 4 weeks leading up to the festival, involving 11 different organisations and engagement from over 4,000 people (excluding physical Destination Greening and Seanfhocail engagement). The majority

of the events and interaction with the audience were through social media, St. Patrick's Festival website and Youtube.



Since the beginning of St. Patrick's Festival Kilkenny 2021 Facebook videos have been viewed 38,900 times and the Youtube videos have made 37,300 impressions.

Media and Social Media impact: People participated, watched and engaged from around the world. The festival received record national media coverage and online mentions internationally.

All of the social media pages have increased their number of followers/likes and website traffic has increased.

## ROADS

### NATIONAL ROADS

#### N24 Waterford to Cahir Scheme

Phase 1 of the project is now complete. We are awaiting approval from TII to progress to Phase 2 which is imminent. Specific information on the scheme can be accessed on the website [N24waterford2cahir.ie](http://N24waterford2cahir.ie)

#### N25 Glenmore to Waterford Scheme

The scheme is within the concluding stage of Phase 2 – Option Selection. The final report is gone back to the Peer Review Team. We are expecting to announce the preferred route following approval from the Peer Review Team shortly.

#### Castlecomer Footbridge

The contract for construction of Castlecomer Footbridge has been awarded to Kenny Civils & Plant Ltd. The main construction works will be undertaken during the summer months and the bridge is expected to open in November 2021.

#### N77 Pavement Works

Works are ongoing from the Baun Roundabout on the ring road to Hennebry's Cross. Lagan are the main contractors on the project. The project is 3.4km and is expected to be completed by end of April 2021.

#### Capital Maintenance

Additional monies were received outside the roadworks scheme for projects on national routes in March 2021.

- N77 Ballyragget Village Pavement Rehabilitation Works **€101,000**
- N77 Ardaloo -Jeninstown Pavement Rehabilitation Works **€140,300**

#### National Maintenance/Repairs

Three projects have been submitted for upgrade works along the Ring Road in Kilkenny City. We are currently waiting on final approval of the works.

- Improvement to Steps from Ring Road to Ballyfoyle Road **€27,000**
- Upgrade of footpath between Hebron and Johnswell Road roundabout **€48,000**
- Upgrade of footpath between Johnswell and New Orchard Road roundabout **€49,600**

### NON-NATIONAL ROADS

Kilkenny received an allocation of €16.8m for upkeep/maintenance and associated works of non-national roads for 2021. The allocation has been divided up between the Municipal districts and the works have been approved by the Elected Members. The full roadworks scheme 2021 is before the Members for consideration at this meeting.

#### Essential Repairs\Pavement Works

Essential Pavement Works have been taking place over the last 4 weeks in each of the Municipal District areas. Each MD is completing 5/6 roads per week. It is expected that in excess of 20km of pavement improvements on local roads will be completed by end of month.

#### Active Travel

A very welcome allocation has been announced for 2021 totalling €4.3 million covering 26 no projects around the City and County. The focus of the funding is to develop high quality, safe walking and cycling infrastructure in rural towns and villages. €2.46 million is allocated to the rural Municipal Districts with €1.87 million for Kilkenny City. It will be important going forward to have approved Mobility Plans in place in our towns to attract this type of investment.

#### FORWARD PLANNING

##### City & County Development Plan

The statutory public consultation on the draft Kilkenny City and County Development Plan concluded on the 12th of March 2021. A total of 460 submissions were received.

These submissions are now being summarised and the Chief Executive will respond to the issues raised in a report to be issued to the Council Members within the statutory 12 weeks.

##### Joint Graiguenamanagh/Tinnahinch Local Area Plan

The Chief Executive's Report on the Draft Joint Graiguenamangh/Tinnahinch Local Area was approved by Members at the Callan-Thomastown Municipal District meeting on the 10<sup>th</sup> of March. The CE's report was subsequently brought to the Plenary Council meeting on the 15<sup>th</sup> March, where the meeting resolved to put the Material Alterations out on display for a period of four weeks.

The Carlow CE's report was discussed at the Carlow Council meeting on the 8<sup>th</sup> March. The Material Alterations are currently being screened for potential impacts on Natura 2000 sites and once that process is concluded, the Material Alterations report and Environmental Reports will be put on display as resolved.

##### Masterplans

Work is continuing with the preparation of Masterplans for the areas of Loughmacask, St Canice's Campus (the former St. Canice's Hospital) and the Fairgreen area of the City. These were also impacted by Covid 19. Loughmacask is the furthest advanced.

A draft Master Plan will be presented to Members in the coming weeks before any draft is placed on public display. St. Canice's Campus and the Fair Green area will recommence after.

#### Taking in Charge

All non-essential construction works are closed during current Level 5 restrictions. Therefore, the timelines in the agreed programme for Taking in Charge have been adversely impacted due to Level 5 Restrictions.

#### Vacant Sites

There are currently 32 sites on the Vacant Sites Register, two of which are under appeal to An Bord Pleanála.

The number of cancelled entries due to site activation or improvement now stands at 16 sites. The Council continues to implement the Vacant Site Levy in accordance with the provisions of the Act.

#### PARKS

##### South East Greenway



The rail and sleeper lifting works have now been completed. Final site clearance work will recommence when current Level 5 restrictions are lifted. Current Level 5 restrictions are also impacting on engagement with landowners however we are in the final stages of reaching agreement on accommodation works. The main construction of the 24km Greenway is being awarded in a number of Lots. The first 2 Lots have been tendered. Works are due to commence on 19<sup>th</sup> April, 2021.

Further contracts will be awarded as the detailed design is finalised and the landowner accommodation works are agreed in each Lot. There will be a number of planning applications progressed in the coming weeks for: an access ramp down on to Greenway from Abbey Road railway bridge; and temporary construction compounds for construction Lots.

The public engagement process for the selection of a suitable site for the proposed Ferrybank Car Park has now concluded. While there is still further investigative work to be undertaken on the preferred site for the Ferrybank Car Park, the Council is satisfied with the solution, especially as it will be accessible from the proposed new Link Road from the Belmont Road to the Abbey Road.

#### **Parks & Playgrounds**

With the coming of Spring weather has improved and with longer days the playgrounds County wide have been extremely busy. It is great to see so many able to play outdoors while social distancing. Probably one of the busiest is the playground at the new park in Ferrybank.

An application has been submitted for a new Multi Use Games Area for Ferrybank Park as the ground is suffering wear and tear due to usage. If we are successful in this application to the Sports Capital Fund a new all-weather ball games area will be installed facilitating ball games year-round.

The local Tidy Towns group in Ferrybank has very kindly come together to assist the Parks Department in picking litter in the park and playground. The litter situation has been very challenging so we are grateful for this assistance. In addition, a local waste disposal company Kollect have sponsored some bins for the park and are emptying them on a weekly basis free of charge. We hope this generous sponsorship plus the efforts of Parks Department staff and Tidy Towns volunteers will enable us to maintain the park litter free.

In April a new General Operative will be commencing work with the Parks Department. This new role will cover a number of sites across the County including the Moat Field in Callan, Silaire Wood in Graiguenamanagh and Ferrybank Park. The new staff member will also team up with our other General Operative as required to assist in many miscellaneous jobs in parks and playgrounds.

The annual playground repair programme is well under way across the county with the focus on the older playgrounds where play equipment is showing signs of wear and tear. The Thomastown playground has just been repainted and shortly a new piece of equipment will be installed. Woodstock playground will also be painted and we will be installing a new piece of equipment in Castlcomer Discovery Park playground as Covid restrictions allow. Repairs have also been carried out in Kells playground and shortly works will commence on the playground in Windgap to improve ground conditions.

Works will also commence on Piltown playground as soon as the Covid restrictions permit construction works to recommence. The site, located to the rear of the old Garda Station, on the Main Street, is an attractive riverside location. The playground will be developed by the local community with assistance from the Parks Department and funding from the Community and Cultural Capital Facilities Scheme. Included in the proposal is a sensory garden which will be of great interest to those with sensory processing issues such as autism but also be an attractive place to sit and enjoy the space beside the river.

#### **Woodstock Gardens & Wider Estate**

An application to National Parks and Wildlife has recently been made for a management plan for the control of Cherry Laurel in Woodstock. This is an extremely aggressive evergreen shrub which out competes other native vegetation by creating a very dark forest floor and under which little else

grows. If successful we intend to work with Coillte who own the wider woodland to develop a plan to work towards the eradication of this invasive species and make conditions favourable for native species to thrive again. This will be an ongoing programme over many years as it is a very persistent shrub and highly adapted to the woodland setting.



Kilkenny County Council recently received funding of €200,000 under the Outdoor recreation Infrastructure Scheme (ORIS) for phase two development works of the Woodstock Loop Walks project. This funding will be used to continue the development of the very successful Loop walks to the Waterfall in the south east of the estate with connections back to the gardens via 'The American Road'. This project will offer a further 2km approx. of loop walk options, travelling for some of its length along the South Leinster Way and connecting to the woodland walks within the more formal gardens.

Easter weekend and additional daylight hours will see the opening hours at Woodstock extended to 7pm. The refreshment service from the coffee van will also be available at weekends until June after which we will have a facility on site 7 days per week. As soon as Covid restrictions allow we will open our new and improved tea rooms housed in the conservatory.

In celebration of St Patricks Day, Woodstock 'went green' with the entrance lit up for the festive period.

#### **Amenity Grants**

The Amenity Grant Scheme was advertised in February and the closing date for receipt of applications was 12<sup>th</sup> March 2021. 182 applications have been received, an increase of 16 on 2020. The main objective of the scheme is to encourage and aid small-scale works to improve the local environment and encourage community involvement in the upkeep and maintenance of public amenities. In 2021 there will be an increased focus on supporting pollinators through projects which are funded. Community groups will be encouraged to manage amenities in a more sustainable manner in line with the pollinator plan which the council has adopted and in line with actions set out in the Council's Climate Action Policy. This is already evident from the applications being received.

The applications are currently being assessed by Parks Staff and a recommendation will be brought to the May Council meeting.

#### **Sustainable Grassland Management**

The Parks Department is working with the Heritage office and the Area offices to reduce mowing where possible across the County in an effort to increase the biodiversity of grass verges and parklands providing a valuable source of food and habitat for insects in particular our

pollinators. The Kilkenny Ring Road will now be cut on the city side of the city only with the exception of maintaining sightlines at roundabouts.

The large meadows at Dukesmeadows and Bishopsmeadows have been managed with an annual cut yearly for some years now, providing an incredible habitat in the City Centre. Short mown paths are cut through the longer meadow grass to allow access for the public. Other areas are being examined for this approach in consultation with residents in fact many residents' groups are approaching the Parks Department with a view to managing their estates in a more sustainable manner. The Parks Department are happy to provide advice to resident's groups to assist in pollinator projects.

#### Walking Trails

In partnership with Trail Kilkenny the Parks Section assisted with the upgrade of a section of trail which is part of the Nore Valley Walk. The large volume of people using this walk, which is an extension of the River Nore Linear Park at Lacken, coupled with a sustained wet period of weather at the end of last year, has meant the surface had deteriorated in recent months. The new surface will better withstand inclement weather and help absorb the impact of many visitors using the walk. The upgrades were funded by the Department of Rural and Community Development under the Walks Scheme.

#### Kilkenny Biodiversity & Recreation Countryside Park



A funding application to the Department of Rural and Community Development under the Outdoor Recreational Scheme (ORIS) was unsuccessful. Subsequent feedback on the application from the Department was positive and a second application will be submitted when the next call for Measure 3 ORIS applications is announced later this year. Other alternative funding streams to this deliver this project will also be investigated to maximise the potential of securing funding for same.

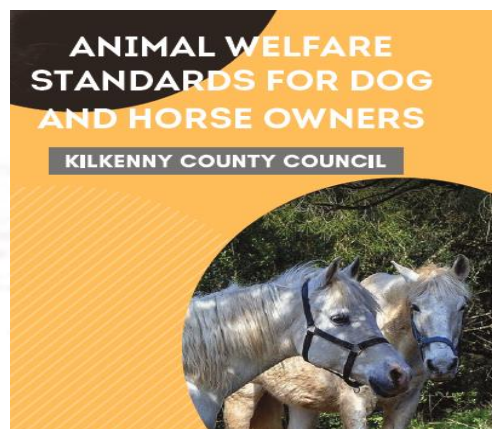
#### Horse Bye Laws

Kilkenny County Council Control of Horses Bye Laws were adopted at the March Council meeting and will come into effect from 1<sup>st</sup> May 2021. The new Bye-Laws provide that horse (owners as before), excepting in limited circumstances, will be required to have a licence to keep a horse. This is to control the number of horses and prevent them causing a nuisance, annoyance or injury to the public or damage to property. The new Bye-laws also update the provisions on how horses should be kept, stabled and cared for and the procedure for seizure of horses where they are not under adequate control.

The main new provision in the revised Bye-laws is the introduction of horse exclusion zones in identified areas in the central core of Kilkenny City, as a public safety and animal welfare measure. The streets around the City core such as Dean Street and Green's Bridge are not exclusion zones, so horse owners have alternative routes to get from one side of the City to the other. The Gardai have confirmed support for the introduction of the exclusion zones. As part of the consultation process on the new Bye-laws, the Gardai reported a number of incidents where they had to respond to public safety, traffic and animal welfare concerns involving horses in the City Centre in the last 2 years.

The issue of horse control generally and in particular the drafting of the new Bye-laws has also been a regular topic of discussion at Joint Policing Committee (JPC) Meetings in recent years. The Council also launched the revised "Animal Welfare Standards for Dog and Horse Owners" Booklet developed by the Council's Animal Welfare Standards Committee. The Committee was established by the Council to advise and make recommendations to address issues relating to the welfare of dogs and horses. The Standards Booklet provides advice and

guidance on responsible dog and horse ownership.



#### Casual Trading Bye Laws

Kilkenny County Council has seen a sharp increase in the demand for spaces under the Casual Trading Bye Laws. These Bye Laws are currently being reviewed. As part of this process the Council is also keen to highlight the opportunities that may be available in relation to Casual Trading along the South East Greenway once it opens. The public will be afforded the opportunity to submit their views once the Public Consultation period begins.

#### Decarbonisation Zone

The Government's Climate Action Plan 2019 provides that each local authority should develop a Decarbonisation Zone (DZ) similar to the demonstrator/pilot in Portlaoise. A Decarbonising Zone (DZ) has been defined as "a spatial area identified by the local authority, in which a range of climate mitigation, adaptation and biodiversity measures and action owners are identified to address local low carbon energy, greenhouse gas emissions and climate needs to contribute to national climate action targets."

The Department of Environment, Climate and Communications have issued a Circular requiring all local authorities to designate a DZ by the end of this month (April) and then put in place an implementation plan (to include proposed projects) by year end. The DZ must be either within an

urban area of not less than 5,000 population OR a rural area of not less than 4km<sup>2</sup>. This matter has been briefly discussed at the recent meetings held of both SPC1 and SPC4. The Council will designate a DZ in accordance with the Dept Circular and develop an implementation plan for the DZ with the relevant SPCs for approval of the Council before the end of the year. It should also be noted that a new Climate Action Bill is being progressed by Government that when enacted (*expected later this year*) will require local authorities to put in place Climate Action Plans outlining how they plan to reduce carbon emissions in line with the programme for Government commitment of 7% per annum by 2030.

#### Environmental Complaints

The increasing trend (*experienced during 2020*) in the number of complaints being received by Environment staff for investigation is continuing for 2021 with 453 cases logged to date compared with 346 for the same period last year (an increase of circa 30%). The nature of these complaints range from littering, illegal dumping and water quality through to abandoned cars. However, the vast majority continue to be related to littering and illegal dumping. Despite the restrictions imposed due to Covid-19, our Enforcement Officers remain very active on the ground while adhering to Government and HSE guidelines.

#### Graveyard Grants

The closing date for receipt of applications under the Graveyard Grants Scheme was 26<sup>th</sup> March last. Following a recommendation from SPC 4, the Council approved amendment to the criteria for the scheme to include the cost of insurance costs as an eligible expenditure item for inclusion in grant claims.

The grant contributes towards the cost of:

- Graveyard maintenance, including appropriate works to help pollinators;
- Graveyard recording schemes;

- Heritage studies of graveyards; and
- Costs associated with providing Public Liability Insurance (from 2021).

The applications are being currently assessed.

#### Bag It, Bin It Campaign

Kilkenny, Carlow, Wexford and Waterford City and County Councils have jointly launched the “Bag It, Bin It” campaign. This collective collaboration is to promote a simple message that dog walkers must be responsible and bag and bin their dog waste.



The campaign will run over a 12-month period and has a series of elements including social media adverts, radio campaigns and a primary education pack to be launched in the autumn. Over the summer, a number of pilot community initiatives will also be rolled out to help foster public participation. The campaign logo will soon become a familiar sight throughout the county.

#### National Spring Clean

An Taisce continued to accept registrations for the National Spring Clean from individuals and family units who wished to litter pick within their 5km area as per Covid-19 restrictions. Registrations can be still be completed online via [www.nationalspringclean.org](http://www.nationalspringclean.org). As at the end of March, over 100 registrations were recorded for County Kilkenny, and this is mirrored by the high volumes of calls being received in the Environment Section from community members seeking litter picking supplies and requesting the Council to dispose of bags of litter. Litter picks like the one in Gowran represents the types of activity which is being seen across the county.

**Online Community Courses in Collaboration with The Heritage Office**

The Heritage Office collaborated with the Environment Section to deliver a “Sustainable Gardening” course throughout March which was primarily aimed at Tidy Town groups as it was identified as being especially beneficial to groups who want to strengthen both their Sustainability and Biodiversity competition categories. Due to the success of the course, with full attendance every week, the participants will be offered a place on the next course, which is a step-by-step guide to growing a sustainable vegetable garden: topics covered will include growing from seed, pricking out seedlings, taking cuttings and much, much more. Both courses fall under initiatives in the All Ireland Pollinator Plan, the Council’s Waste Prevention Programme and Kilkenny’s Climate Change Adaptation Strategy.

**Waste Prevention Grant 2021**

This grant scheme aims to support and encourage communities to take steps on waste prevention, re-use and repair activities and encourages partnership between local businesses, schools, charities and voluntary groups. Funded as part of the Council’s Waste Prevention Programme, it supports the policy objectives with our Climate Change Adaption Strategy. This grant scheme will be advertised in early April and the max funding per application is €500.

**LAWPRO Update**

LAWPRO’s catchment scientists were scheduled to commence local catchment assessments in 11 Priority Areas for Action (PAA’s) in 2021 but this work is now delayed due to COVID 19 restrictions.

**Green GAA Initiative with LAWPRO & Irish Water**

The GAA Green Clubs programme will see 45 clubs and two regional venues participate in a 12-month initiative to assist the GAA, LGFA and Camogie Association develop a sustainability toolkit for all their units. LAWPRO and Irish

Water are providing support on the water theme of the initiative. Two clubs in the SE Region are participating, including James Stephens.

**Climate Action - Woodland Creation Scheme**

Under the 2020 Programme for Government (PFG) the Climate Action Regional Offices (CAROs) have been tasked to work with public bodies to review land availability for planting. This initiative is being progressed in partnership with the Department of Agriculture, Food & the Marine (DAFM) and Local Authorities. Kilkenny County Council is very keen to be involved in this initiative and the Environment Section identified a number of potential sites through a desk top survey for consideration under the Woodland Creation Scheme. A Working Group comprising of various members across the organisation was formed to review the suitability of the lands identified. The Environment Section and a Forestry Advisor from Teagasc have inspected the potential sites and a report detailing the findings and recommendations will be prepared.

**Decarbonisation Zones**

The National Climate Action Plan (CAP) provides that each local authority should develop a Decarbonisation Zone (DZ) similar to the demonstrator/pilot in Portlaoise. According to the CAP, a Decarbonising Zone (DZ) is “a spatial area identified by the local authority, in which a range of climate mitigation, adaptation and biodiversity measures and action owners are identified to address local low carbon energy, greenhouse gas emissions and climate needs to contribute to national climate action targets.” Local authorities must designate a DZ by the end of April and then put in place an implementation plan (to include proposed projects) by year end. The DZ must be located either within an urban area of not less than 5,000 population or a rural area of not less than 4km<sup>2</sup>.

**ISO 50001**

it had been successful in attaining ISO 50001 accreditation. ISO 50001 is an internationally recognised energy management standard and those organisations that have achieved the standard must provide evidence that they have put in place rigorous energy efficiency systems and procedures. Kilkenny County Council over the years already had in place good systems that was a huge help in securing accreditation. The Council has a well established Energy Team with membership drawn from right across the organisation and had achieved the 33% public sector energy efficiency target by the end of 2019. ISO 50001 will help the Council achieve the more ambitious energy efficiency targets going forward.

## COMMUNITY

### CLÁR

This scheme was announced on Monday 15<sup>th</sup> March by Minister Heather Humphries. The CLÁR scheme is a targeted investment programme for rural areas that aims to provide funding for small infrastructural projects in areas that experience disadvantage through rural depopulation. The Scheme was advertised by Kilkenny County Council on 24<sup>th</sup> March, 2021. Closing date for receipt of applications is 23<sup>rd</sup> April, 2021.

Goresbridge, Thomastown, and Mullinavat. The Town / Village Health Check will also seek to establish Town Teams in each location to shape and take forward these plans.

The series of Health Checks will seek to gather information concerning the current economic, social, environmental and physical situation of the town. The study will analyse the strengths and weaknesses of each settlement based on factors such as the range and quality of activities in the town, its mix of uses, its accessibility to people living in the area, and its general appearance and safety.

A series of dedicated online information events will be held in early April to discuss the project with each of the communities in the towns and villages. In light of COVID-19 restrictions, the sessions will take place digitally via Zoom.

#### FINANCIAL ASSISTANCE

A total of €137,000 in direct financial assistance was approved for 5 manufacturing /export service businesses located throughout the County since the start of the year. This assistance is linked to the projected creation of 36 jobs over the next three years.

#### GREEN FOR MICRO

#### LUNCH & LEARN



Thirty three businesses attended an online briefing on the range of supports available through the Local Enterprise Office and the Council's Small Business Assistance Scheme for Covid (SBASC) held on March 24<sup>th</sup>. The aim of the event was to promote the wide range of services available from the LEO including financial but also programmes such as LEAN, Green and mentoring as well as providing information on the newly announced SBASC Scheme for businesses.

#### LEAN FOR BUSINESS

During March, 5 businesses attended a one to one clinic on how LEAN could help their business. In 2021, 3 businesses have commenced projects on Lean for Micro mentoring programme in order to assist them to review their processes to become more competitive and innovative. There are two types of LEAN support available to Kilkenny based businesses.



**LEAN START:** this programme is more focused for smaller companies with targeted LEAN needs and wanting to adapt their current business into the LEAN Processes. Businesses are eligible to receive support for a maximum of 3 consultancy days. Lean Start is available to all businesses across sectors in Kilkenny.

**LEAN FOR MICRO:** Businesses will be eligible to receive support for a maximum of 5.5 consultancy days. Lean for Micro is available to eligible companies who employ up to 10 employees in the manufacturing sector and/or have the potential to export / internationally trade.

The Aim of the scheme is to provide support to individual hospitality and tourism businesses towards the cost of equipment to provide additional outdoor seating and facilitate these businesses to increase their outdoor dining capacity for the Summer of 2021 in a regulated and accessible manner.

The scheme is funded by Fáilte Ireland and administered by Kilkenny County Council.

#### Digital Upskills sessions for Kilkenny Art Practitioners

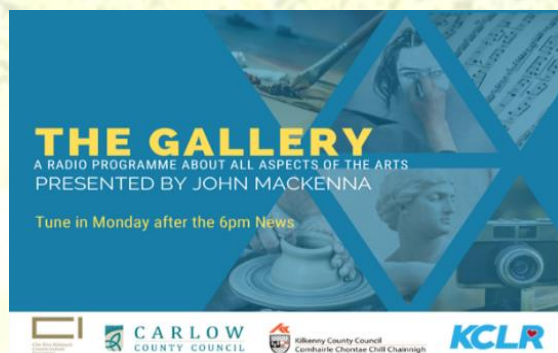

- support positive ageing and mitigate the negative impact of social cocooning and social distancing

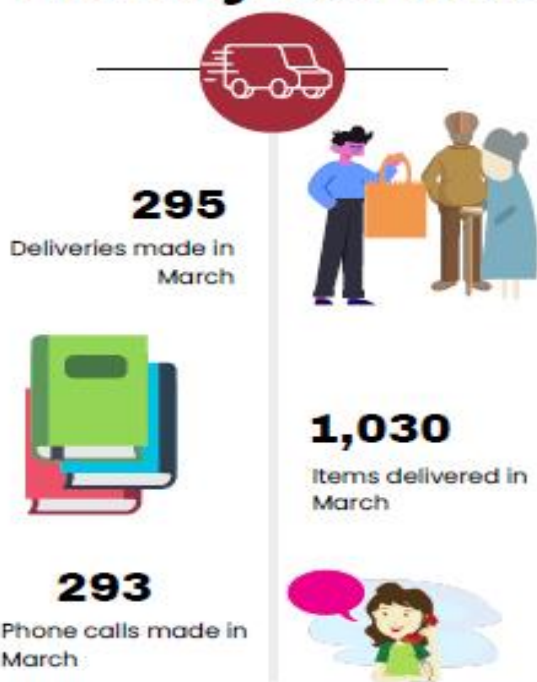

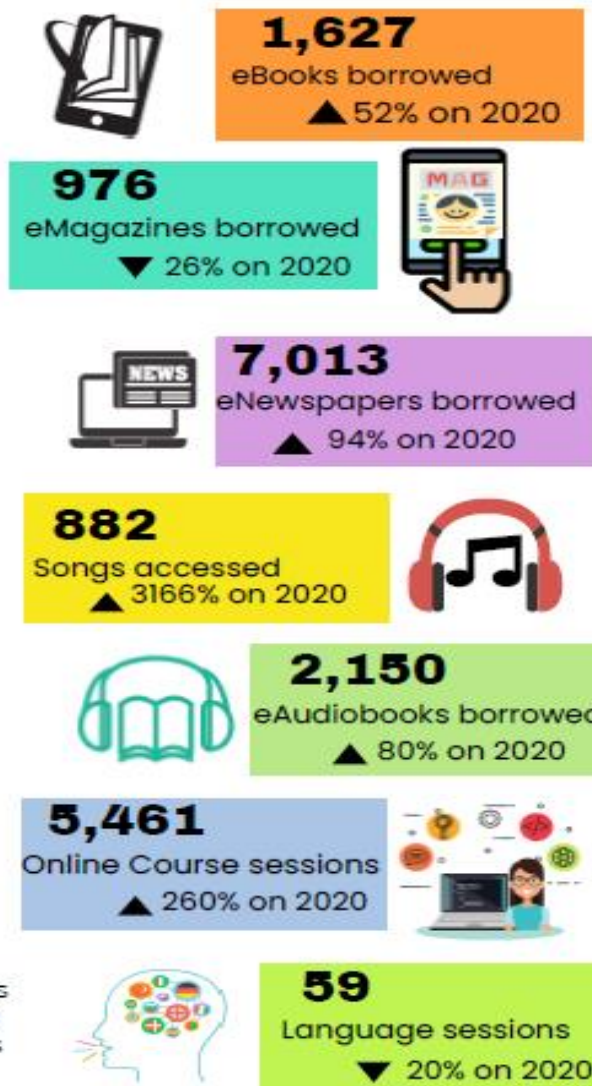

This is part of our ongoing development of literacy resources under the National Right to Read Literacy Programme for County Kilkenny and our commitment to supporting children and families with ASD needs.

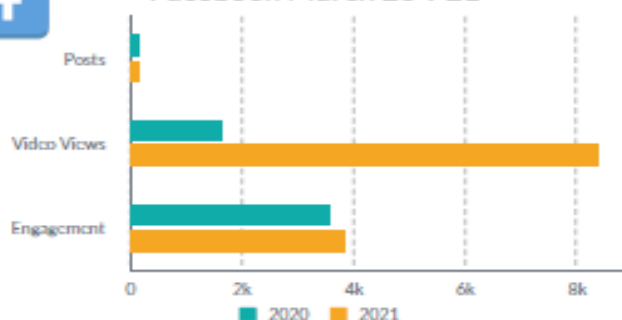

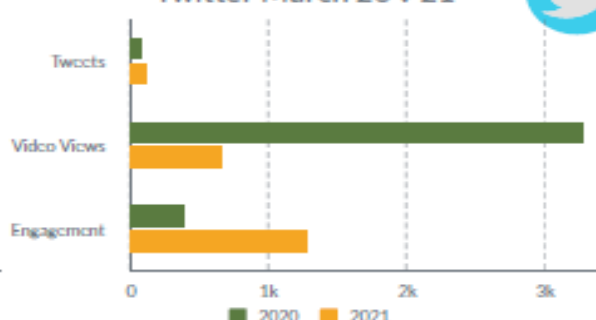

The bank overdraft facility was un-utilised for the year to 31<sup>st</sup> March, 2021. The unaudited Annual Financial Statements for 2020 will be brought before the members at the April Council meeting.

### Rates Revaluation

Further to Revaluation 2017, 197 customers with a total rate demand value of €4.5m appealed their new valuation to the Valuation Tribunal. To date, 184 appeals have been completed. 144 of the 184 appeals have resulted in a decrease in rates. Income lost to date stands at €832,784. If this trend continues the total loss of income may be in excess of €1m once all appeal decisions have been made by the Tribunal.

### Rates Waiver 2021

On the 27<sup>th</sup> January, the Department of Housing, Local Government & Heritage issued details of a three-month Commercial Rates Waiver to be applied for the first quarter of 2021. The Department has further extended the waiver to cover quarter 2 providing a total of six months credit in lieu of commercial rates for eligible businesses. The 2021 Rates Waiver Scheme has modified criteria and accordingly is a separate standalone waiver scheme from the scheme that applied in 2020. Credit in lieu of commercial rates will be applied to the rate accounts of all eligible businesses closed by or badly impacted by Level 5 Restrictions and the Rates Section will communicate with eligible and ineligible businesses this month.

**Small Business Assistance Scheme (SBAS)**

The Department of Enterprise Trade & Employment has recently launched the Small Business Assistance Scheme for COVID (SBASC) which is intended to target those businesses with operating costs that do not qualify for the COVID Restrictions Support Scheme (CRSS) operated by the Revenue Commissioners. The key eligibility criteria of the are:

A business must:

- Be a sole trader, a company, self-employed, or a partnership;
- Have a minimum turnover of €50,000 for each ratable premises;
- Not be owned or operated by a public body;
- Not eligible for/be in receipt of CRSS for the period for which the grant covers or eligible for Fáilte Ireland's Business Continuity Scheme or the Music Entertainment Business Assistance Scheme (MEBAS) of the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media.
- Operate from a building, or similar fixed physical structure on which business rates are payable (mobile premises, or premises which are not permanently fixed in place, do not meet the definition of business premises nor do premises on which no rates are payable);
- Must have a current eTax Clearance Certificate from the Revenue Commissioners.
- The turnover of the business over the claim period 1st January to 31st March 2021 is estimated to be no more than 25% of the average weekly turnover of the business in 2019; or the estimated average weekly turnover of the business in 2020, for businesses that commenced after 1st November, 2019 and
- The business intends to resume trading in full once Government restrictions are eased.
- Have 1 - 250 employees and a projected turnover of less than €25 million in 2021;

In relation to the verification of the €50,000 turnover requirement, applicants will be required to upload their most recent financial or trading accounts or the relevant section of their most recent Revenue income tax Form 11, which verifies turnover in excess of €50,000.

The scheme covers the period 1 January 2021 to 30 June 2021. Each eligible applicant will receive a payment of €4,000 with an additional payment of €4,000 from May 2021 to applicants continuing to meet the scheme eligibility criteria. The closing date for applications for the initial grant under SBASC is 21<sup>st</sup> April, 2021 and businesses can apply on line at [www.kilkennycoco.ie](http://www.kilkennycoco.ie).
