CORPORATE

CIVIC RECEPTION

A Civic Reception was held for Patrick Rafter on Monday, 25th April, 2022.



ABBEY QUARTER

Following agreement in February to carry out a review of the Abbey Quarter Masterplan, the tender process to procure the Consultants to carry out the review is underway.

The Council will be kept informed and there will be public consultation engagement when a draft is agreed.

Brewhouse including Horse Barrack Lane and Brewhouse Courtyard

Work on the redevelopment of the Brewhouse building (by Kilkenny Abbey Quarter Development Ltd) is now completed. Glanbia Ireland have commenced the fit out of their office space and they expect to have staff working in the building in August 2022.

O'Neill Foley Accountants have completed their fit out work and their staff moved into the new offices on 16th May. This represents a very significant milestone for the Abbey Quarter development.

The Brewhouse project included the development of the Public Realm area of Horse Barrack Lane and the Brewhouse Courtyard, with these projects being part funded by the Urban Regeneration & Development Fund and the European Regional Development Fund. These areas were formally opened by Minister Darragh O'Brien on 16th May.











Building 7

Kilkenny Abbey Quarter Development Partnership has applied for planning permission for the development of the first of the new buildings on the abbey Quarter site. This building (Building 7 in the Abbey Quarter Masterplan) is located beside the Brewhouse Building and forms the boundary to the remaining two sides of the Brewhouse Courtyard. The Building will include retail and commercial spaces at ground floor level, with office space in the upper floors.



Mayfair Library

Work is continuing on the redevelopment of the Mayfair Building as the new City Library. Some delays have been encountered to date on site due to difficulties with procurement of materials, as is being experienced throughout the construction sector at present. It is expected that the project will be completed in Spring 2023.





The redevelopment of the Mayfair Building includes the completion of the landscaping works to Horse Barrack Lane and the development of a pedestrian plaza area between the building and Parliament Street.







Tea Houses

Conservation work on the Tea Houses on Bateman Quay has been completed. Tenders are now being sought from interested parties to lease and operate the buildings. commenced in August, with the works expected to take approx. 6 months to complete. The building will be made available for reuse by private operators and it is expected that expressions of interest from interested parties will be sought before the end of the year.



This project is funded by the Urban Regeneration & Development Fund.

Urban Park & Street

Work on the preparation of the detailed design and tender documents for the Urban street and park project is substantially completed. This project will go to tender following formal confirmation of funding for the project through the Urban Regeneration & Development Fund.

The Urban park, which will be centred around St Francis Abbey, will be the central focus of the Abbey Quarter development, while the development of the street will open up the former Brewery site for the development of new buildings.






The project is part funded by the Urban Regeneration and Development Fund, with some funding for the street element of the project provided by the European regional Development fund.

Abbey Quarter Conservation Plan

A DRAFT Conservation Plan for the Heritage Structures on the Abbey Quarter site including St Francis Abbey, the City Walls, Evans Turrett and St Francis Well has been prepared in conjunction with the Office of Public Works, the National Monuments Service and the Heritage Council. Public Consultation on the DRAFT Conservation Plan will commence in early June.





The preparation of the Conservation plan has been part funded by the National Monuments Service through the Community Monuments Fund.

Temporary Car & Coach Park

Work on the development of the temporary car & coach park on the Abbey Quarter has commenced, with these works expected to be completed in June 2022. The development provides 7 coach parking spaces, which will be a significant addition to tourist facilities in the city.

ROADS

Major Projects

(Included in NDP-Funded by TII)

N24 Waterford to Cahir Scheme

The public consultation No 2 on Alternatives & Options started on the 3rd of May in Mooncoin Hall and continued for the week in Clonmel, Cahir and Carrick on Suir. Large numbers attended each of the venues to view the options and meet the Project team. The closing date for submissions on this phase (alternatives and options) is the 20th May.

Minor Projects

(Not included in NDP-Funded by TII)

N24 Tower Road (Safety Scheme)

Approval to proceed to tender has been requested from TII. Once approval is received it is expected that the scheme will go out to tender in Q2 2022 with a view to construction commencing during Q3 2022. An allocation of €3m was received for 2022 to allow the scheme proceed to construction. The overall outturn cost for the project is expected to be circa €10m.



N77 Ballyragget to Ballynaslee

An allocation of €500K was received for 2022 which will fund progression to preparation of contract documents and potentially provide for some land acquisition. The overall outturn cost for the project is expected to be circa €10m.

N24 Carrick Road:

An allocation of €150K was received for 2022 which will fund progression to statutory approvals stage (177AE Planning Approval and Compulsory Purchase Order Approval which is likely to be submitted to An Bord Pleanála in May 2022. The overall outturn cost for the project is expected to be circa €10m.

Other

Kilkenny Ring Road Extension

Consultants are continuing to work on the SAR report (*Strategic Assessment Report*) for above project. This report will be ready in Q2 2022 for submission to the Department for consideration to proceed with the design and planning.

Speed Limits

The proposed draft Speed Limit Review Public Consultation was advertised in the Kilkenny People dated 6th May 2022. The documents are available for public viewing in each of the Municipal District offices, County Hall and City Hall and are also available on Consult.ie. Submission can be made up until the 10th June, 2022.

PARKS/SPECIAL PROJECTS

Parks & Playgrounds

Maintenance continues around the County in our playgrounds and parks to present them to a high standard. This month the focus was on the replacement of parts of old or worn play equipment.

Changes in our grass cutting regime, to help and encourage our pollinators was very evident over the past number of weeks with an abundance of dandelions and daisies on display, with locations such as the Kilkenny Ring Road and Graiguenamanagh Relief Road looking particularly good.

To support the Ukrainian Refugees currently accommodated in the St. John of God's Convent, Kilkenny, the Parks Department has developed a proposal to maximise the outdoor space within the grounds of the convent to afford the residents an opportunity to better interact with their outdoor surroundings in a safe and comfortable envirnoment. With the support of the Sister's of St. John of God, works will be undertaken in the area on the southside of the convent and will include the installation of outdoor seating, play equipment and raised vegetable beds (the residents having themselves expressed an interest in getting involved in the latter). It is expected that works will be completed before the end of May.

Amenity Grants

The 2022 amenity grants scheme application closing date was the 25th of March. All applications are now being assessed and will be

brought before the May meeting of the County Council for approval by Elected Members. Final numbers are expected to be up on last year's applications as the fund grows in popularity and as more estates are taken in charge. The fund for 2022 is set at €140,000. This will be distributed to groups across the County to enable them to maintain their own outdoor recreational spaces. The range of works typically involve tree planting, grass cutting, planting flowers, erecting signage and many other amenity type projects.

Woodstock Gardens

Springtime in the gardens has been busy with an abundance of pruning and planting jobs to be completed before the summer season. The Winter Garden has been the focus of much of the attention with topiary planting needing pruning to maintain the formal shapes typical of the Winter Garden.

Work has also commenced on improving access to the gardens under the Outdoor Recreation Infrastructure Scheme (Phase Three) and the Disability Participation and Awareness Fund. These funds will assist in making Woodstock more accessible and inclusive for all with measures to include the construction of new and upgrade of existing pathways, the purchase of a mobility buggy, which will accommodate wheelchairs, along with improvements to the playground including introduction of new accessible play equipment.

Improvements will also be made in the car park with the provision of designated disabled car parking spaces and an improved access to the path network and formal gardens from there.

South East Greenway

The landscaping of sections of the South East Greenway over Lots 1 and 3 has been completed. This includes an area from Rosbercon to Ballyverneen, Glenmore. The emphasis has been on re-establishing native planting and where appropriate allowing natural recolonisation on embankments.

The Greenway is an important wildlife corridor in the countryside and will be managed sensitively to ensure this is prioritised. Landowner agreements on the accommodation works for Lots 4 – 7 continue to progress. Works continue on the preparation of the detailed design and tender documents for Lot 4 (New Ross to Mount Elliott) and Lot 5a (Ferrybank to Luffany) and Lot 5b (Luffany to Aylwardstown).

It is intended that Tender Documents for Lots 5a will be advertised later this Month.

2022 Call for new applications under the Outdoor Recreation Infrastructure Scheme (ORIS)

In mid-February, The Department of Rural & Community Development announced a call for new applications under ORIS. The scheme is open to all Local Authorities and a number of other State Agencies and funding is allocated via a competitive process based on the quality of the applications put forward. To this end, we are endeavoring to ensure the highest quality applications are put forward.

The funding applications are divided into following four categories:

Measure 1: grant available €30,000 and Local Authorities can submit a maximum of 7 applications, (*Increased by €10,000/application on previous years*).

Measure 2: grant available €200,000 and Local Authorities can submit a maximum of 3 applications.

Measure 3: grant available €500,000 and Local Authorities can submit a maximum of 1 application.

Project Development: grant available €50,000 and Local Authorities can submit a maximum of 2 applications (*An increase on 1 application last year*).

(10% Match funding must be provided by the Local Authority)

The deadline for the submission of Measure 1 & Project Development Applications was the 18^{th} April 2022 and the following applications were submitted on behalf of Kilkenny County Council.

Forward Planning

City & County Development Plan:

Following adoption of the City & County Development Plan 2021-2027 in October 2021, the Minister for Planning, Local Government and Heritage issued a Draft Direction in relation to certain renewable energy elements of the Plan. After a period of public consultation, the written submissions or observations in respect of the Draft Direction were forwarded to the Office of the Planning Regulator in December 2021, who has subsequently made a recommendation to the Minister on the matter.

Masterplans:

The preparation of the Masterplan for the HSE's St. Canice's Campus is ongoing. Loci consultants are assisting the Project Steering Committee in the drafting of the Masterplan. Several workshops were held during December 2021 and January 2022 to progress design concepts around land use and movement. Following consultation with the HSE on these concepts, a plan will be drafted. Once a draft plan is available, it will be presented

to the Council and HSE before it is placed on public display.

Work is continuing on the preparation of a Masterplan for Loughmacask. An initial draft Masterplan was prepared and was internally reviewed. The Environment Section were consulted in relation environmental to assessments associated with the draft Masterplan and their comments are now being incorporated into the assessments. Once the environmental assessments are progressed, and the iterative process of modifying the draft Masterplan is finalised, all the documentation will be presented to Members prior to public display. This item is on the agenda for the upcoming Kilkenny Municipal District meeting.

The preparation of the Fair Green Masterplan will recommence following public display of the two other draft Masterplans.

Work has commenced on the preparation of a masterplan for Urlingford Town Centre. The consultants have been appointed and an intial meeting was held between them and the Planning Authority and they are now working on this masterplan.

Active Land Management

- There are 13 sites on the Derelict Sites Register at present.
- There are 29 sites on the Vacant Sites Register and the number of cancelled entries due to site activation or improvement stands at 18 sites.
- The 2021 levy is now due for qualifying sites and payment demands were issued during February and early March. Owners now have the right of appeal to An Bord Pleanála.

 Revised valuations of the 8 2019 sites have recently been undertaken and the owners were notified of these.

For 2022, the emphasis will be on the activation of sites currently on the Register, the pursuit of levies due and ongoing monitoring.

Conservation

The **Historic Structures Fund (HSF)** provides an opportunity for home owners to apply for funding for large scale repair works to protected structures. The national budget for the fund has increased from €3 million in 2021 to €4million in 2022. The table below details the successful projects submitted by Kilkenny County Council.

The Built Heritage Investment Scheme (BHIS) encourages applications for repairs to historic fabric of protected structures and proposed protected structures. A total of 17 projects that made applications under the BHIS have been approved funding totalling €171,600 this year and will now commence in the coming weeks.

Site meetings between the Conservation Officer, the applicant and the applicant's agent have already commenced. The works include thatch, render, roof and roof features repair.

Historic Towns Initiative 2022 (HTI): Following a successful application, €10,000 has been secured from the Heritage Council. This funding is specifically for the appointment a conservation architect to work with owners of a minimum of three buildings located in Upper Bridge Street, Callan. This will provide the basis for returning vacant residential floorspace back into use in the street.

A Heritage Stewardship Fund: €15,000 has been secured from the Heritage Council. The application focuses on the Early Medieval Town Houses in Kilkenny and follows collaboration to

date between the Conservation Office and the Built Heritage Unit and the National Monument Service of the Department of Housing, Local Government and Heritage.

ENVIRONMENT

Climate Action

The Department has recently confirmed that there will be an official announcement in the coming weeks with regard to resources dedicated to Climate Action for each Local Authority.

For Kilkenny County Council, there will be an additional three staff employed which will include the Community Climate Action Officer and the Climate Action Specialist Officer who will be the lead on the preparation and development of the Climate Action Plan for the Council.

It is expected that towards the last quarter of 2022, the Minister will sign the Order requesting Local Authorities to commence the preparation of their Climate Action Plan for the next five years. In the interim, the Council will be commencing the process and working with the 3CEA in ensuring that the required baseline data is captured and accurately assessed.

Bike Week

This year, Bike Week in Kilkenny celebrates sustainability in our communities. Bike Maintenance workshops will take place in different venues around the County. Cycling enthusiasts who share a passion for hurling are being encouraged to leave the car behind on match day at Nowlan Park on Saturday, May 21, for the eagerly-anticipated clash with Wexford. There will be goodies on arrival for those who travel on two wheels.

A Cycle to Work Breakfast takes place on Wednesday, the 18th May, for local employers who want to find out more about promoting cycling in the Workplace. The week culminates in Bike Fest, a free family festival in Kilkenny County Hall on Sunday, the 22nd May. Activities include Family Cycles, E-Bike Trials, Foraging Cycles, Balance Bike and Off-Road Zones, Obstacle Courses, a Wellbeing Area and lots of hands-on workshops from local food and craft producers. The Bike Fest will open with a Slow Roll through the City, leaving County Hall at 12 noon on Sunday, 22 May, returning to join in the Bike Fest celebrations.

Environment Complaints

All complaints are logged on the CRM (Customer Relations Management) System. The number of complaints being received & logged by Environment staff for investigation for the first four months of 2022 is 351 compared with 575 for the same period last year (i.e. down circa 39%). The nature of these complaints ranges from littering, illegal dumping, water quality and abandoned cars. However, the vast majority continue to be related to littering and illegal dumping.

Waste, Recycling & Collection

Bring Banks Usage

The Council provides and manages 46 Bring Centres across the City and County and a total of 740 tonnes of recyclables were collected from our Bring Centres in the first 4 months of 2022. This represents a 19%

decrease on the same period last year and is mainly due to the full re-opening of society following the Covid 19 pandemic. Loughboy Shopping Centre (with 46.16 tonnes collected YTD), Lidl Loughboy (with 45.49 tonnes collected YTD) and Graiguenamanagh (33.85 tonnes collected YTD) is the busiest bring centres outside of the City. Environment staff are continuing to work very closely with our service providers to ensure the collection service is in keeping with demand, especially around long weekends and holiday periods. Kilkenny County Council is looking to increase the number of recycling centres in the County this year and is currently in discussions with the Tidy Town committee's with regard to suitable locations in towns and villages across the County.

Kilkenny County Council has recently awarded the contract for textile recycling to Textile Recycling Limited (TRL) for the next 2 years following a tender process. The new clothes banks are currently being rolled out across our bring bank centres all over the County.

Dunmore Civic Amenity Site 2022

Approximately 6,500 customers visited Dunmore during the month of April, resulting in 5.9 tonnes of Cardboard, 5.8 tonnes of Plastic, 7.7 tonnes of Paper and 18.7 tonnes of WEEE (Waste Electrical & Electronic Equipment) being sent from the site for recycling. With spring in full flight, the site received 31.5 tonnes of green waste which was sent for composting.



Household Electrical Collection Days

Councils Waste Prevention Programme

Bicycle Initiative for Ukranians

As Ukrainians continue to come to Kilkenny and settle into their new accommodation, their needs are being considered and one solution to transport is being addressed by a community collaboration funded by the Council's Waste Prevention Programme. Collaborating with the Leader Partnership, the Civil Defence, the Council's Cycling Officer and the Kilkenny City Men Shed a scheme has commenced to bring unused bicycles back into circulation. Donated bikes are repaired and serviced at Kilkenny's Mens Shed and then are being provided to communal hubs and to new residents now living throughout the County.



Deposit, Return Scheme Demonstration Day

Voice Ireland will be coming to The Parade on Thursday, the 19th of May to demonstrate how the national deposit return scheme machines will work. This scheme is due to be rolled out nationally by the end of the year.



National Spring Clean

Registrations for the 2022 An Taisce's National Spring clean are now closed. This year saw over 100 groups registered on the national registration for County Kilkenny. The Environment Section provide support to groups who are completing litter picks in their own local area by supplying litter picking supplies and assistance with litter removal after litter picking. Events will continue throughout the summer.

Picker Pals



Picker Pals and Kilkenny County Council is hosting a monthly competition to encourage classes that are participating in Picker Pals to show how the programme is running in their classroom. The first winning classroom was from Piltown National School who sent in an example of one pupils account of his litter picking adventure.

There are 35 classes participating in the Picker Pals programme this year throughout the City and County. The programme provides a litter picking kit to participating classrooms and provides an opportunity for each pupil to borrow the kit over a weekend and tell the class their findings the following week. This programme will see over 1,000 families being involved in weekend litter picking adventures over the course of the programme. Voice Ireland who runs the programme in Ireland also provides classroom supports throughout the year.



Tidy Towns

The first Tidy Towns Forum took place in Kells on the 2nd of April. Kells Tidy Towns kindly hosted the event and took Tidy Town Representatives for a guided tour of their village showcasing numerous projects which have been completed over the years. This provides an opportunity for volunteers from different Tidy Town Groups across the County to meet, share ideas and get advice on different aspects of their activities.

Plans are currently underway to take the next forum out of the County to visit an award winning location which is particularly strong on biodiversity.



Animal Welfare

JJ Tobin Veterinary Officer continues to carry out monthly inspections at the Dog Shelter to ensure the site is operating efficiently and effectively. Up to end of April this year, 113 dogs have been dealt with in the Carlow/Kilkenny dog shelter, with 77 of these dogs rehomed by the shelter and by charities. There were 4 dogs remaining at the shelter at the end of April.

Medieval churches receive funding for conservation

Kilkenny County Council has secured €196,200 from the Department of Housing, Local Government and Heritage to help conserve and protect three medieval churches and graveyards (Grangefertagh, Clomantagh, Dunkitt) under the Community Monuments Fund 2022. The works will be overseen by the Environment Section and Heritage Office. It will help protect them from the impacts of climate change and keep them safe for current and future generations to access and appreciate.

Clomantagh

€85,000 for urgent works to stabilise and conserve the 13thC church ruin including its distinctive double bell-tower, walls, doors and windows of the church.

Dunkitt

€85,000 for urgent works to stabilise and conserve the late 12th/early 13thC church and the adjacent graveyard boundary wall.

Grangefertagh

€26,200 to prepare a Conservation Management Plan for the medieval church and graveyard which will provide a vision, policies and actions to help protect and conserve the site for future generations

The Chief Executive outlined the future development plans for the site and then proceeded to Cakeface to meet other LEO supported companies - Kay Lyng of KKajoux Jewels; Miriam Cushen, Cushendale Woollen Mills and Eilis Gough, Mileeven Fine Foods. Rory and Laura Gannon also provided the Minister with a tour of their nearby cookery school and coffee roastery.



Presentation of Student Enterprise Programme Awards to Successful Students

On Wednesday 27th April, the Local Enterprise Office Kilkenny presented the Student Enterprise Programme Awards to successful finalists in the Set Theatre, Kilkenny. Invited guests included the successful students, their proud parents, teachers and school principals, the Cathaoirleach Cllr Fidelis Doherty, Mayor Cllr Andrew McGuinness, Cllr Pat Fitzpatrick and Fiona Deegan, Head of Enterprise. Further to our Awards ceremony, the winners of the County Student Enterprise Awards in all categories were considered for inclusion in the National Finals to be held in The Helix on 18 May 2022.

In the "My Entrepreneurial Journey" competition whereby students interview and mapped out the life of an entrepreneur and what is required, Saoirse Walsh from Grennan College was presented with the Junior Category while Ned O'Meara from Coláiste Éamann Rís was awarded the Intermediate Category. Both will go forward to represent Kilkenny at the next stages of their respective competitions.

While in the "Most Creative Business Idea" competition, senior level students were asked to come up with an inventive business idea based around the theme of 'Fitness and Wellbeing Innovations', Maria Salvans from Loreto Secondary School was presented with her award.

In the Junior Category, the student who will represent Kilkenny in the next stages of the competition is Ciara Ryan from "Sew Stylish" at St. Brigid's College, Callan. Ciara's business creates uniquely designed multifunctional hair scrunchies with a discrete zip pocket that can be used to hide/store money, lip gloss or keys, but can also still be used to tie your hair up.

In the Intermediate Category, twin brothers Adam and Liam Doyle, from Coláiste Éamann Rís with their painting service business "Twin Painters" will be representing Kilkenny. In the Senior Category of the competition, Kilkenny representatives going forward to the next stages of the competition will be Presentation Secondary School students Aoibhinn Morrissey and Louise Hearne with their business "Sea Ya later". They identified a need in the market to develop and sell a natural based tan remover.

2022 Activities:

- €288,470 in direct financial assistance has been approved for 12 manufacturing/export service businesses located throughout the County. This assistance is linked to the projected creation of 39 jobs over the next three years.
- €224,885 in Business Expansion Grant assistance awarded to 8 existing businesses with forecasted new job creation of 35 jobs. Business Expansion grants assist businesses trading greater than 18 months to make investment in growing their businesses and employment numbers.
- €35,610 in Priming Grant (Start-up assistance) to 1 new business.
- €27,975 awarded in feasibility study grants to 3 businesses.
- 4 Technical Assistance for Micro Exporter grant awarded totalling €7,320. This scheme supports businesses to explore their export market opportunities.
- 11 Businesses have commenced LEAN one to one consultancy programmes to investigate possible resource efficiencies and process improvements their businesses.
- TBusiness have commenced the LEO Building Better Business LEAN programme. This programme is about building a stable, secure, and sustainable business that is agile enough to face economic challenges. This programme is centred on the belief that waste exists in all processes and while it is a practical, hands on programme but not focusing on the obvious ways of looking at problems and opportunities. It is about finding ways to do things faster, better, and together as a team.
- 9 business have been approved a Trading Online Voucher totalling €17,990 to support the enhancement of their online trading capacity.
- 5 Green for Micro Grant awarded totalling €11,070. This scheme supports businesses to become greener and more environmentally friendly.
- 2 applicants have been supported to make loan applications to the Micro Finance Ireland loan fund.


Plans for Horizon Irish Open

FIRE SERVICES

Capital Projects

Engagement with agencies / groups such as Age Friendly Counties Programme (Kilkenny), An Garda Síochána, Muintir na Tíre, the Irish Farmers Association (IFA), ICA, Neighbourhood Watch Schemes, Active Retirement Groups, St Vincent De-Paul, HSE, Local Community Alert Groups, Local Text Alert Groups and Twilight is key to improving and continuing to deliver fire safety awareness in our communities.

Brigades carried out a number of fire safety presentations e.g. . Home Fire Safety Checks (HFSVs) are a significant element of our Community Fire Safety strategy. Fire service personnel call to houses by appointment and give fire safety advice to the occupants. A HFSV is usually carried out by two uniformed operational fire service personnel. The primary aim of these HFSVs is to reduce the numbers of fires, deaths and injuries in the home by firstly preventing fires occurring and to ensure that when fires do occur, the occupiers are given early warning, and they know how to react quickly and safely.

Resumption of the Primary Schools Fire safety programme is underway and a number of schools have been visited recently. Thomastown Fire Brigade held a road safety demonstration at Colaiste Cois Siuire, Mooncoin for their Transition Year students.

Visual Artists Mentoring Programme – Meet the Mentors

This programme is part of Kilkenny Arts Office's Artists Supports Programme 2022 and provides an opportunity for artists to meet face-to-face with a specialist mentor who has expertise in their artform to discuss and develop their artistic practice. The four mentors are Eamonn Maxwell, curator, Pauline O'Connell, visual artist, Ann Mulrooney, artist and curator and Aisling Prior, curator.

Successful artists will receive six mentoring sessions over the period of May to November 2022.

Knitted Together

Our 2022 Knitted Together project is up and running and once again our Kilkenny makers have come through for us with offers to knit and crochet either squares or blankets for the project. Knitted Together is focusing on in-person and intergenerational learning for 2022.

Meet up hubs are being rolled out across the City and County. This year's project also involves a number of the Kilkenny Men's Sheds and they will be making stools for which covers and cushions will be made by those knitting and crocheting.

Local Live Performance Scheme

April Sounds saw us host a series of concerts in St Canice's Cathedral & the Medieval Mile Museum the weekend of 8th / 9th & 10th April/. The concerts were in aid of the Red Cross Ukraine and Unicef who are running emergency appeals. This beautiful & uplifting series combined local and national acts in two of our most wonderful Kilkenny venues. St Canices Cathedral hosted Lisa O' Neill, Rónán Ó Snodaigh and Myles O'Reilly, Arrivalists & Bríd Lyons.

The Medieval Mile Museum Series included Seamus & Caoimhe Uí Fhlatharta, Niamh Regan I Gary O' Neill, Ailbhe Reddy & Elise. A total of €5,682 was raised for UNICEF and the Irish Red Cross Ukraine appeals. A further €1,500 was generously donated by April Sounds artists and audiences over the weekend for Kilkenny Civil Defence Urgent Appeal for the Ukraine community in Kilkenny.

Platform31

The final selection has been made for the **PLATFORM** national Professional 31 Development programme. This year's successful applicant is a playwright. Platform 31 is a national professional development opportunity for artists across art forms to be supported to investigate how they might develop their practice or make work in a different way. It is designed to support and enable career development for 31 mid-career artists - one artist will be selected from each of the 31 local authorities around Ireland. programme will provide coaching, advisory support and networking opportunities for participating artists, introducing them to a pool of critical thinkers to share their work and

encouraging a national conversation about creating work in local contexts.

Creation 21

This programme is focussed on performing artists at all stages of their careers and across a range of disciplines (dance, theatre, circus, spectacle, performance art, street arts), and aims to develop their practice, deepen their network, learn and showcase work. The project offers artistic development opportunities through national and International residencies, mentoring, coaching, residencies and 'in-progress' presentation opportunities.

There are 11 artists taking part in the residency programme with one artist from each participating County Arts Service: Wexford, Waterford, Kilkenny, Carlow, Wicklow, Kildare, South Dublin, two from Dublin City and one from Catalonia and another from the Balearics.

They encompass a broad scope of experience from senior to emerging artists to ensure a collaborative blend which will be to the benefit of all involved. To date the group have engaged in Professional development workshops and residencies working collaboratively to develop their practices. They are currently undertaking a residency in Catalonia.

Public Art Butler Gallery

Based on the construction cost of this project a budget of €50,000 was allocated for a Per Cent for Art piece. Three artists were invited to submit proposals and a selection committee was convened in March. Isabel Nolan was the successful artist and the project is progressing.

Mayfair Library

As part of the Mayfair Library Development and to preserve the social heritage of this former ballroom an exhibition space will be developed so that it appropriately reflects this unique and rich social history.

Visual Arts Ireland has agreed to project manage the Mayfair Library Per Cent for Art project and this is also progressing well.

Bookville Festival

The Bookville Festival is progressing well with all authors and artists selected to perform this year. The Bookville exhibition this year will take place in the Watergate Theatre Gallery and a number of illustrators have been selected for the show.

Poetry Broadsheet Publication

The Kilkenny Poetry Broadsheet editor Elaine Feeney has made her selection of poems for this year's edition of the Broadsheet. She selected 14 poems from a total of 108 poems. Elaine Feeney lectures at The National University of Ireland, Galway, where she is also a founding member of the Tuam Oral History Project.

She has published three poetry collections including *The Radio was Gospel & Rise.* Feeney wrote the award-winning drama *WRoNGHEADED* commissioned by the Liz Roche Company.

Elaine said of her selection: This selection of poems all moved me in some way, in a distinct aesthetic, a family moment, a snapshot of something frozen in time, family, relationships, love, loss, and all the in-between.








Ukrainian supports



Inflation is having a significant impact on the cost of delivering all services and on the delivery of the capital programme. This issue will be kept under review as we go through the year. The bank overdraft facility was not utilised in the four-month period to the end of April. The Local Government Auditor has commenced the Audit for 2021.

Rates Revaluation

Further to Revaluation 2017, 197 customers with a total rate demand value of €4.5m appealed their new valuation to the Valuation Tribunal. To date 191 appeals have been completed. The following is a breakdown of the appeal outcomes to date:

Decrease in Revaluation on Appeal	150 cases
Appeal Withdrawn	33 cases
Increase in Revaluation on Appeal	1 case

The total annual Income lost to date stands at €841k.

Targeted Rates Waiver Quarter 1, 2022

On 12th October, 2021 a targeted commercial rates waiver to support certain sectors was agreed by Government for the final quarter of 2021. An extension of this waiver for a further period of three months for the first quarter of 2022 was agreed by Government in December, 2021. The extended waiver took the form of a credit in lieu of rates. The terms and conditions relating to eligibility and administration of the extended waiver remained the same as those outlined in Circular Fin 20/2021 "Targeted Commercial Rates Waiver Final Quarter 2021.

The broad categories of businesses the credit in lieu of rates applied to were as follows:

- Hospitality, including restaurants and cafes;
- Leisure;
- Miscellaneous entertainment;
- Certain tourism related categories; and
- Airports.

The value of the waiver is the equivalent value of 25% of the annual rate bill for 2022 for eligible categories of business. The waiver (Jan to March) was applied to eligible rate accounts by the Rates Section as a credit in lieu of rates in the value of €748,378 in March and eligible businesses were notified by letter.
