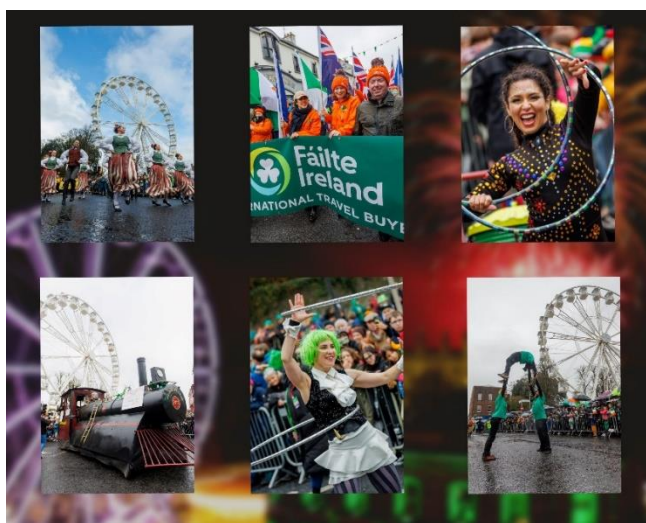

CORPORATE



Kilkenny's St. Patrick's Festival was this year a five-day event bursting with excitement and

entertainment including fire-shows, fairground attractions, circus acts, drum workshops, street entertainment and concluded with an amazing fireworks display in Kilkenny Castle Park. The City proudly hosted marching bands from across the US who got an opportunity to perform at Kilkenny Castle and through the medieval streets of Kilkenny.



Along with the St. Patrick's Day celebrations, Kilkenny Tradfest Festival celebrated its tenth anniversary of Irish traditional and folk music, singing and dancing with over a dozen headline concerts by major Irish artists, including Stockton's Wing, Scullion, the Kilfenora and Tulla Céilí bands and upcoming stars including Emma Langford, Lisa Lambe and the Bonnymen. Over the course of the festival, visitors enjoyed over 90 free music sessions as people had the chance to see the cream of local and national talent in the informal settings of the City's best old and newer hostelrys on the TradTrail.



Kilkenny City's St. Patrick's Day Parade defied the weather odds as the public once again flocked to the sides of the Marble City's streets to witness and play their part in a vibrant, multicultural and hugely colourful celebration of the national holiday.

It is estimated that crowds of 20,000 lined the streets to see the 1,500 local people participating in the Parade. Representing community, school, sports clubs and cultural groups, it took over an hour to pass the main reviewing stand at the junction of Patrick Street and the Parade.

Kilkenny hosted the Mayors of our twin towns, Malbork in Poland and our long-standing arrangement with Morêt sur Loing in France. Kilkenny was also selected by Fáilte Ireland as the place they brought a hugely important group of international tourism buyers, as part of their Meitheal programme and we were very reassured that the future attractiveness of our tourism industry benefited hugely from what those visitors saw and heard over the weekend.



The presence of Gabe Sadlier of Travelzoo travel and media company, broadcasting live to 28 million viewers from the Parade to the USA on Thursday 16th March, including to the major US TV networks, was an incredible achievement for our small City where he commented live on CNN, FOX and other channels that our City is the best place to visit, outside of Dublin.

To see texts and WhatsApp messages coming in from Kilkenny people all over the world saying how proud they were to see the City getting such incredible exposure on international media channels is surely an indication as to how far we have come with our St. Patrick's Festival. The work of our festival committee and of the Festival Director, Marian Flannery and her small team has made this all a reality.

Of course, we had Edward Hayden as our Grand Marshall. Edward has been a great friend of our festivals for years and a fantastic ambassador for Kilkenny at all times. The live broadcast by Virgin Media, with their Ireland AM show on Thursday morning highlighting all aspects of the City and the festival added even more to the excellent media coverage we got from our local print and radio media outlets.

We never rest on our laurels as planning for the 2024 festival will commence in the near future. We hope to be back bigger and even better next year.

ROADS

MAJOR PROJECTS

(Included in NDP- Funded by TII)

N24 Waterford to Cahir Scheme

The Design Team is working on corridor options. The Project Liaison Officer (PLO) is continuing to work with landowners to agree access to facilitate the completion of the preliminary ground investigation works. Although investigation works commenced in November 2022, the works were suspended in December 2022 due to saturated ground conditions as a result of consistently poor weather. The works will recommence in March 2023 and are due to be completed in April 2023. The findings of these investigations will input into The Preferred Transport Solution. This was scheduled to be put on public display at the end of Q2 2023, however this is now scheduled to take place in Q4 of 2023.

MINOR PROJECTS

(Not included in NDP-Funded by TII)

N24 Tower Road (Safety Scheme)

The tender in respect of construction of the scheme was awarded to Wills Bros Ltd, Co. Mayo on the 1st December 2022. Construction commenced on the 16th January and due to positive weather conditions at the start of the year construction is presently marginally ahead of schedule. Substantial completion is expected by the end of 2023.

N77 Ballyragget to Ballynaslee

The formal Notice to Treat under CPO procedures issued to all affected landowners and occupiers in mid-September 2022 and a follow up reminder issued in December 2022. Responses to same continue to be received and will be evaluated in consultation with landowners and their representatives. The preparation of contract documents is on-going and it is expected that the

tender will be issued in early Q3 2023. The overall outturn cost for the project is expected to be in excess of €10m.

N24 Carrick Road

Simultaneous applications to An Bord Pleanála for 177AE Planning approval and Compulsory Purchase Order Approval were made on the 25th November 2022. The public consultation period for both ran until the 20th January, 2023.

To note Kilkenny County Council is aware of 5 objections to the Compulsory Purchase Order Approval application. If these are not withdrawn, there will be an oral hearing in respect of this scheme. There were also 5 objections to the 177AE planning application. It is a matter for An Bord Pleanála if there is a requirement for an oral hearing. A final decision with or in the absence of an oral hearing is not expected until Q3 2023.

OTHER

Pavement Schemes

The N10 Danesfort Pavement Improvement Scheme commenced construction during November 2022 and was completed in March 2023. Final snagging of the completed scheme is on-going.

The N77 Georges Tree to Dunmore West (*Phase 1 Ardloo Junction North*) Pavement Improvement Works has been awarded. The works are expected to start towards the end of Q2 2023 and is weather dependent.

The design work is ongoing in respect of the N76 Callan By Pass Pavement Scheme and the N77 Suttonsrath Pavement Schemes are on-going. It is intended to have these awarded for construction in 2023. The Callan By Pass scheme in particular is complex given its semi urban location.

National Road Bridge Works

The tenders have been received by Kildare County Council in respect of the N10 Ossory Bridge Rehabilitation Scheme. Kildare County Council are project managing N10 Ossory Bridge Rehabilitation Scheme under a Section 85 agreement on behalf of Kilkenny County Council. The works will entail significant works to the approaches and parapets of the bridge structure and will provide a significant enhancement of the existing substandard shared surface facilities across the structure.

Tender award procedures for the successful contractor are on-going and subject to tender award works will commence towards the end of Q2 2023.

Progress on the Kilkenny County Climate Action Plan

Work is continuing on gathering baseline data and putting supports in place to inform and support the delivery of the Kilkenny County Council Climate Action Plan by the statutory deadline of 23rd February, 2023.

This includes:

- An Inventory of Greenhouse Gases omitted in County Kilkenny in 2018 (2018 is the baseline year against which we will measure our targets)
- A Climate Change Risk Assessment – identifying the main risks from climate change to the delivery of Council services
- Appointment of consultants to undertake a Strategic Environmental Assessment (SEA) and Appropriate Assessment (AA) of the Climate Action Plan.
- Schedule of all stages in the preparation of the Climate Action Plan.
- On-going participation in the national [Local Authority Climate Action Training](#) programme by relevant staff, including Green Public Procurement, Climate Action Plan Preparation etc.
- Recruitment of sanctioned staff for the Climate Action Team
- Working with the South East Energy Agency regarding energy and emissions reduction in local authority buildings and facilities
- Supporting the SEAI [Sustainable Energy Communities Programme](#) in the County.



Recommended Minimum Criteria for Environmental Inspections (RMCEI)

Our 2022 inspection data has been submitted to the EPA. A synopsis of the data returned is captured in the Table below:

Our 2023 RMCEI plan has also been submitted to the EPA. The plan has over 4,300 inspections to be completed for the year ahead. Our staff are now using the National Environmental Management Information System (NEMIS) for inputting their inspections in 2023. The focus for this year will be on the National Enforcement Priorities which cover Waste, Air, Noise and Water.

Environment Complaints

All Environment complaints received are logged on the CRM (*Customer Relations Management*) System. The number of complaints being received and logged by Environment staff for investigation for the first three months of 2023 was 241 compared with 264 for the same period last year. The nature of these complaints ranges from littering, illegal dumping, water quality and abandoned cars. The vast majority continue to be related to littering and illegal dumping. Whilst every effort is made to bring unacceptable environmental practice into compliance, Environment Enforcement staff continue to manage significant enforcement cases progressing through prosecution cases.

WASTE, RECYCLING & COLLECTION

Bring Banks Usage

The Council provides and manages 46 Bring Centres across the City and County. A total of 533 tonnes of recyclables were collected from our Bring Centres so far this year. This represents an 1.5% increase on the same period last year. Loughboy Shopping Centre (44.36 tonnes collected YTD), LIDL Johnswell Road (37.09 tonnes collected YTD) and Newpark Shopping Centre (35.68 tonnes collected YTD) are the busiest locations in the City and Graiguenamanagh (31.22 tonnes collected YTD) is the busiest outside of the City. Environment staff are continuing to work very closely with our service providers to ensure the collection service is in keeping with demand, especially around long weekends and holiday periods.

LITTER AWARENESS



On Friday 24th March, 2023, schools and workplaces participated in Lets Team Up to Clean Up Together for Kilkenny. All other groups were able to pick a time suitable to themselves over the rest of the weekend.

Kits were assembled by Council staff, army personnel in St Stephens Barracks and junior packs were assembled with the assistance from the CBS Secondary. Kit distribution was completed by the assistance of Elected Members, staff, Area Offices and community hubs across the County. 160 adult kits and 30 junior kits were prepared for the event weekend which were provided to groups who had registered for the first time.



Some groups decided to hold their clean ups on an alternative weekend, others due to the health and safety limitations, preferred opting for the National Spring Clean. Regardless, this initiative definitely saw a lot more litter picking over the designated weekend and it was reflected accordingly in local media.

Animal Welfare



At the end of March there were 106 dogs handled by the Carlow/Kilkenny Dog Shelter. Of the 106 dogs 89 - were strays and there were 9 surrenders. There were 39 dogs re-homed by the shelter and 36 dogs transferred to charities for rehoming along with 17 dogs being reclaimed by their owners.

Calls in relation to dog control have increased from the public who are now more active in reporting incidences of loose dogs and in particular restricted breeds.

BURIAL GROUNDS

Columbarium Wall Garden St. Kieran's Cemetery

The construction of the Columbarium Wall and all associated site works is almost complete at St. Kieran's Cemetery. A total of 100 niches will be available within the Columbarium Wall units in the Garden, with the option to add more units subject to future demand. We are now waiting on ESB to connect up street lighting at three locations surrounding the Columbarium Wall in order to try and reduce anti-social behaviour.

Community Monuments Fund

Kilkenny County Council have submitted three projects for capital funding under the Community Monument Fund for 2023:-

- Butler Gallery complex/garden medieval wall
- Grangefertagh historic church and graveyard
- Thomple historic church and graveyard

Further funding is currently being applied for projects at Tubrid and Rathpatrick historic churches and graveyards for proposed conservation works and repairs. Vegetation removal has recently taken place on both Tubrid and Rathpatrick historic churches which will enable Conservation Engineers to carry out an assessment with a view to carrying out future conservation work.

Graveyard Grants

The closing date for the Graveyard Grants Scheme 2023 was Friday 24th February, 2023. There have been over 40 applications received. Each application will be assessed by the Environment Section in the coming weeks. The grant may contribute towards the cost of:

- Graveyard maintenance, including appropriate works to help pollinators
- Graveyard recording schemes
- Heritage studies of graveyards
- Costs associated with providing Public Liability Insurance.

PARKS & SPECIAL PROJECTS

Kilkenny Countryside Park

Work is progressing well on Phase 1 of the new Kilkenny Countryside Park at Dunmore, with significant progress made on the construction of the viewing area and the various trails which traverse the remediated landfill. The road widening along the Bleach Road access to the new parking area is now substantially complete and works pertaining to the provision of the 17 car and 60 bicycle parking area has also progressed well over recent weeks.



On the eastern side of the Park progress has also been made on the installation of the ball wall (see image below) and the fencing for the dog friendly enclosure has also commenced. With the agreement of the Dunmore Community Committee works has also started to prepare the Dunmore Community Carpark for the opening of the Park. This carpark is linked to the Park via a very attractive off-road trail, an old “Mass Path”, that was upgraded last year in anticipation of the delivery of the new Park. This Phase of the project is being funded under Measure 3 of the Outdoor Recreation Infrastructure Scheme.

In conjunction with the above, we are continuing to try to identify potential suitable funding streams to deliver Phase 2 of the project which will include the installation of play and exercise equipment, fun elements within break-out amenity spaces, additional trail development and interpretation signage that tell the story of the site from waste landfill to an area rich in biodiversity.



South East Greenway

Works are progressing well to ready the section of the Greenway between New Ross and Glenmore for opening to the public this summer. These works include public light duct installation, fencing, preparation of the temporary carparks at Rosbercon (see image below) and Glenmore, installation of 2 controlled crossings, signage installation and the completion of final snagging items.

The opening date for the above section is expected in June and a definitive date will be announced in the coming weeks.

The works tender for Lot 5A, a 5km section from Ferrybank to Luffany, was advertised on the Official Journal of the European Union (OJEU) in March. The closing date for tender submissions is the 21st April. It is anticipated, subject to the necessary TII approvals that the successful contractor will be appointed for the works contract in July. The tender period for this section of the Greenway is estimated to be 12 months. Included under this contract is the installation of the public lighting within Lot 3 and the construction of the permanent carpark at Glenmore.



The focus of the Design Team has now switched to the preparation of the detail design for Lot 4 - Red Bridge and Mountelloitt Tunnel and Lot 5b Curraghmore to Aylwardstown and it is anticipated that Lot 4 will be the next tender to be advertised.

The Road Design Office recently completed the Greenway land transfer mapping to facilitate the transfer of same from CIE to the respective local authorities. This mapping has been issued to CIE who are currently reviewing same.

Woodstock Gardens

Staff are preparing to undertake a significant replanting of the central spine herbaceous borders within the Walled Garden. In 2022, the box hedging delineating the borders became infested with box blight and was removed along with the herbaceous planting. The latter being in need of rejuvenation.

In the coming weeks, the herbaceous borders shall be refreshed with new planting that was popular in the Victorian era. The planting theme will also have a strong focus on pollinator friendly plants which will provide a valuable food source for our important pollinators.

Plans are also being progressed to roll out the food and beverage offering for the coming tourism season. The offering will include hot and cold drinks, cakes, scones, sweets and ice-creams which will be served from the glass conservatory Tea Room, Woodstock Coffee Truck and Ice-cream parlour. Interviews for seasonal staff were held recently and it is expected these positions will be filled in the coming weeks.

Making Woodstock More Inclusive For All

On foot of securing funding in 2022 under the Disability Participation and Awareness Fund and Outdoor Recreation Infrastructure Scheme, significant efforts are being made to make the Woodstock offering more inclusive for people with reduced mobility. Under these funding streams, dedicated disabled and age friendly parking bays have been provided and two new wheelchair inclusive play components, in the form of a Play Tower and See-saw, are currently being installed. These new play elements will afford wheelchair users the opportunity for play immersion with peer and families groups.



In addition to the above, we are expecting delivery of our new wheelchair accessible electric buggy over the coming weeks. During peak season this vehicle will be available to wheelchair users who wish to travel from the carpark to the Tea Room, giving same the opportunity to take in the gardens on route.

National Tree Week

National Tree Week 2023 took place from the 19th to 26th of March. Kilkenny County Council undertook a number of planting projects during the week to celebrate this national initiative.

We were delighted to support planting initiatives such as that undertaken at James Stephens Army Barracks, Woodstock Gardens, Freshford and Ballyragget. In total 300 native saplings will be planted under this initiative in a bid to increase tree canopy cover and promote biodiversity and climate resilience.



Parks and Playgrounds

Staff play a key role to ensure our playgrounds are maintained to a high standard and any defects identified are remedied in a timely manner. Over the month of March, repairs were carried out in a number of playgrounds across the County namely Coon, Castlecomer, Graiguenamanagh and Paulstown.



Under the Anti-Litter/Anti-Graffiti Programme, both the Environment and Parks Section worked closely to resolve a localised issue in Ferrybank Park. In order to reduce the incidents of graffiti on a particular wall within the park we engaged with *Street Art Ink* who painted a mural on same titled 'Biodiversity & the Environment'. Under this initiative, the artists engaged undertook a workshop with a local youth group who then assisted the artists with the painting of the mural. The hope is by getting some of the young people who make use of the park involved it will create a sense of ownership of same and in turn hopefully reduce the likelihood of future incidents of graffiti.

Amenity Grants

The closing date for the submission of amenity grant applications for 2023 was the 31st of March. The applications received will be assessed over the coming weeks and a recommendation prepared for Council.

FORWARD PLANNING

Masterplans:

Abbey Quarter

The process of reviewing the Abbey Quarter Masterplan commenced in October 2022. A public survey on the Abbey Quarter went live for 4 weeks and closed on 16th December. A further online public consultation event took place on the 18th of January to inform the public of the survey results and of the review process. The meeting was well attended and valuable inputs were received. The consultants are currently working on the draft plan and it is anticipated that it will be published later in April for a series of public consultation events. It is anticipated that the process will be completed in the second quarter of 2023.

St. Canice's Campus

A final meeting took place with the HSE project working group on the draft spatial framework. This framework is now being considered by the HSE and once approved will be brought to the Municipal District Members. It will then be placed on public display for a round of public consultation.

Loughmacask

The draft Loughmacask Masterplan was placed on public display from the 26th August, 2022 to the 28th October, 2022. Three public information sessions on the draft were held in September and October and a total of 182 submissions were received during the consultation timeframe. A workshop was held with the Kilkenny City MD on the 10th February, 2023. The Interim Chief Executive's report was presented to the Municipal District Members at their meeting on the 20th March, 2023. Also on the 20th March the Plenary Council resolved to accept the recommendations and to put the changes arising from the Interim Chief Executive's report on display for a further period of at least 4 weeks. Once Environmental screenings have been completed, the amended Masterplan will be placed on display. This will happen during the month of April. It will then revert back to the Council for final consideration and adoption.

Urlingford

The Council's Consultants indicated that the Urlingford Town Centre Masterplan is being finalised. The draft plan once received will be presented to the Municipal District Members before being placed on public display. A public workshop on this draft plan is planned once the draft plan is on display.

Ballyragget/Paulstown/Kilmacow

Work has commenced on the preparation of Masterplans for the settlements of Ballyragget, Paulstown and Kilmacow. Three public meetings, one for each town, took place 18th, 19th and 20th of January 2023. With due consideration of inputs from these meetings the Consultants are currently drafting the three Masterplans, which are expected in May 2023. The draft plans will be presented to the respective Municipal Districts prior to them going on public display.

Taking in Charge

Progress to date in 2023:

Works are almost complete in the Paddocks, Gowran and works continuing in Ogenty, Gowran.

- *Abbeygate, Ferrybank* - works almost completed by developer.
- *An Choill Rua, Paulstown* - developer arranging to complete remaining works
- *Ogenty, Gowran* - Castlecomer Area office have commenced works
- *Rioch Court, Kilkenny* - Kilkenny Area office proceeding with works
- *The Greens, Thomastown* - developer continuing to progress works.
- *Kilkenny Internal Road* - developer to complete works.
- *Lakeside, Kilkenny* - all works completed - to go to initiation stage shortly.
- *College Park, Callan Road* - works not yet commenced
- *Greenoaks, The Fairways* - developer to complete works

E-PLANNING

Kilkenny County Council volunteered to be part of the pilot project for the roll out of E-Planning nationally. E-Planning is now available as part of the planning application process in Kilkenny County Council. Users must register on the e-planning portal at:

<https://planning.localgov.ie/en/local-government-ireland-planning-system>, where after they can then make a

planning application, submit documentation online with the application and submit further information later if required. The status of applications can be viewed quickly and easily. Paper applications are still accepted and the same timelines apply to both an online application and a paper application.

Fifty seven percent (57%) of planning applications are now being made through e-planning. There has been positive feedback from both agents and members of the public that the service is quick and easy to use.

Active Land Management

The Draft Maps of land in scope for the Residential Zoned Land Tax were published on the 1st November. A total of 25 submissions were made to the process, 4 of which include re-zoning requests. Determinations were made on each of these submissions, and landowners were notified of the determinations at the end of March 2023. Landowners now have an opportunity of appeal to An Bord Pleanála. A Final Map of lands in scope for the tax will be published by December 2023.

There are 29 sites on the Derelict Sites Register. Notices of valuations were served on 5 property owners in March and these can be appealed to the Valuation Tribunal. Funding was announced in the third round of URDF specifically to address long term vacancy and dereliction and measures to utilise this funding are being examined.

There are 24 Vacant Sites on the Vacant Sites Register and the number of cancelled entries due to site activation or improvement is 23. Payment demands for 2022 will issue shortly. The Vacant site levy will be replaced by the Residential Zoned Land Tax in 2024, but any outstanding levies will remain due to the Council.

Conservation

The Conservation Office manages all protected structures in Kilkenny County and City. These structures are recognised for the following special interest: Architectural, Historical, Archaeological, Artistic, Cultural, Scientific, Technical, Social.

Built Heritage Investment Scheme: 16 grant applicants successfully acquired funding from a total of 18 applications. The applicants have accepted the grant offer and work will commence once methodologies are agreed with the Conservation Office. Table 1 shows the successful applicants.

Historic Structures Fund: 6 applications were received. 5 projects were selected and forwarded to the Department of Housing, Local Government and the Heritage (DHLGH) for consideration. The DHLGH have decided to support 1 project:

- Repair works to the Church of the Immaculate Conception, Kilkenny Street, Castlecomer, Co. Kilkenny, to the value of €37,000

Heritage Stewardship Funding 2023: The Conservation Office successfully acquired funding of €30,000 from the Heritage Council under this scheme. The project involves the laser scan, photogrammetry and building interpretation of two 16th century buildings in Parliament Street. The project will create a high-

resolution record of these structures and increase awareness of Kilkenny's nationally significant 16th century townhouses, and in the long term will add to the offering of the Medieval Mile in Kilkenny City.

Funding awarded for County Heritage Plan Grant 2023

Kilkenny County Council has been awarded €37,500 under the Heritage Council County Heritage Plan grant. This funding will be for a Heritage Awareness and Engagement Campaign to support the priorities of the Heritage Office and a Data Collection Programme to conduct surveys of the holy wells and mass paths of County Kilkenny in 2023.

Decade of Centenaries Programme 2023

Kilkenny County Council received an allocation of €50,000 from the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media under the Decade of Centenaries Programme. Applications made under the public grant scheme to commemorate events/people/life in County Kilkenny in 1923 and reflecting on the whole Decade 1912-1923 have now been assessed and awarded. The 2023 programme will include a diverse range of projects from across the County including a lecture series organised by South Kilkenny Historical Society; *Come Back* a short film by Kevin Hughes, theatre and film projects by Ita Morrissey and Gillian Grattan; and a City walking tour by Larry Scallan retracing the steps of those involved in the Civil War in Kilkenny in 1923 and the sites associated with these events. Along with these community projects, Kilkenny County Library have organised an engaging programme of lectures, podcasts and children's events to engage members of the public with the events of 100 years ago. Lastly, the Heritage Office will run an oral history project to record unheard memories and the legacy of the revolutionary

period in Kilkenny. We will also produce a retrospective booklet to document all of the projects, events and activities funded by the Decade of Centenaries Programme through Kilkenny County Council over the past ten years.



Application for funding made to the Irish Walled Towns Network

The Heritage Office has applied for funding for interpretation of the City Walls of Kilkenny under the Heritage Council ITWN grant scheme. The aim of the project is to design and install information plaques on 5 key sections of the Kilkenny City walls. This is Phase 1 of a larger project to develop a trail of Kilkenny City walls. Phase 2 will involve installation of further plaques and development of a trail route and information.

Citizen science kits available in Kilkenny Libraries

Kilkenny Library Services are making ecology equipment freely available for citizens looking to join the fight against biodiversity loss. The initiative, a partnership between Kilkenny County Library and the Heritage Council is designed to assist an increasingly engaged public, many of whom are eager to contribute to the preservation of our biodiversity but who lack the tools to do so. It is expected that the kits will be used by students looking to conduct their own studies, amateur ecologists wishing to produce their own biodiversity action plans and by community groups such as Tidy Towns, River Trusts and Field Clubs who want to gather information to bolster local biodiversity projects.

Kilkenny County Council: Urban Action for Cancer Prevention

Kilkenny County Council and Healthy Kilkenny are proud to be participating in a project called 'UcanACT - Urban ACTION for cancer prevention: adult and senior citizens practice physical activity within public urban green spaces to prevent cancer diseases' (2022-2025). This initiative is an intersectoral project funded by the European Union, and involves collaborations with 7 partners. There are 3 associations of physiotherapists, two academic partners, one Local Authority and one non-profit organisation. They all will bring their expertise and knowledge to the successful development of the project outcomes. The three pilot territories for implementation includes: Kilkenny (Ireland), Bologna (Italy), and Munich (Germany).

The 7 Project Partners are:

- The European Foundation for physiotherapy and physical activity (Belgium),
- Outdoor Against Cancer (Germany),
- University of Sevilla (Spain),
- University of Bologna (Italy),
- Italian Association of physiotherapists (Italy),
- Irish Society of Chartered Physiotherapists (Ireland),
- Kilkenny County Council (Ireland)

The overall objective of 'UcanACT' is to engage adult and senior citizens to participate in regular physical activity as a tool for cancer prevention within public urban green spaces. Kilkenny County Council will lead out on the development and implementation of a Citizen Engagement Strategy which will inform policies on methods of citizen engagement, stakeholder involvement and how citizens can be empowered to undertake physical activity in Public Urban Green Spaces.

The other main objectives of the project involve; the development of a Physical Activity App to support adult and senior citizens willing to practice cancer-preventive physical activity within public urban green spaces by providing them and other users (physiotherapists, health professionals, family members and caregivers) physical activity programmes. Additionally, physiotherapist students and qualified physiotherapists will be provided training on the App and the physical activity intervention.

The project will include three target groups living in Kilkenny City:

- Age 50+ who never had a diagnosis of Cancer (*primary prevention*)
- Age 50 + who have a diagnosis of cancer (*secondary prevention*)
- Age 50+ in recovery from cancer or had a previous diagnosis of cancer in the past

Kilkenny County Council will work in Collaboration with the Irish Society of Chartered Physiotherapists (ISCP) to recruit Citizens in Kilkenny to participate in physio-led exercise programmes in three selected Public Urban Green Spaces in Kilkenny City. The programmes will be rolled-out in 2024 and the App will be trialled by Citizens in Kilkenny. Kilkenny County Council will also undertake a communications campaign to promote physical activity for all Kilkenny Citizens with the aim to increase awareness of physical activity and achieving a lifelong approach to health and wellbeing.

In achieving the objectives and health outcomes of this project, Kilkenny County Council will work closely with local services and agencies; Cois Nore, Dragon Paddlers, South East Community Healthcare, HSE, Public Participation Network and Newpark Family Resource Centre.

Young People & the Arts

Due to the change in the secondary school art curriculum the Arts Office has designed a pilot programme providing secondary school teachers with effective teaching and learning resources to support Post Primary Art teachers in their implementation of this new curriculum for the junior and senior cycle.

The Arts Office have partnered with JCT, (the dedicated CPD support service from the Department of Education) in order to execute this programme. This pilot series is covering the Art of Curating, Art and the Environment and Art as Social Commentary

To date we have delivered the *Art of Curating* which offered the teachers an opportunity to:

- gain insights into the role of contemporary curators and their impact on the world and broader society
- explore the curatorial decision-making process and learn how curators create cohesive and meaningful experiences
- discuss the diverse approaches and practices of professional curators, and how they adapt to changing social, political, and cultural contexts

The session was hugely successful as is evident below and it also provided us with the opportunity to request suggestions for further sessions.

Youth Residency

The Youth Residency programme is back with Artist in Residence Aoife Doherty. Aoife is working with youth groups in the Drum Youth Centre Foróige and Ossory Youth delivering a 6-week Art programme.

This programme aims to engage young people in new ways of making art, including sculpture making, printmaking, magazine collage and bookmaking, taking inspiration from art movements throughout history. The residency programme was developed to create a safe space for young people to explore their creativity and to encourage curiosity. It gives the participants the space to experiment and focus on the process of making rather than the end result. Aoife has designed the programme to enable alternative ways of making by using different materials to encourage a fun and playful approaches to creative practices.

Throughout this 6-week residency the young people will engage in artmaking as well as taking a trip to Kilkenny's Butler Gallery to further enhance their experience and understanding of creative possibilities. This art programme will continue for four more weeks and will continue to explore similar themes to enable the young people to play and engage with creative practices.

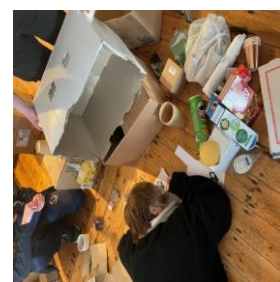

Johns Green House Window Gallery

The Window gallery currently displays the Brat Bride Project. This female empowerment printmaking project was developed by artist Michelle McMahon. To date, approximately seventy women have taken part in the printmaking workshops, where they created a print of a Goddess, matrilineal figure or feminine symbol of power that resonated with them on a piece of fabric – i.e. a Brat Bríde. Traditionally, a Brat Bríde was a piece of cloth, usually red or white, that was left outside the house on Brigid's Eve to collect dew. The Brat was then believed to have curative powers (Duchas.ie).

The Brat Bride project was curated and delivered by Michelle McMahon in partnership with Kilkenny Arts Office, The Butler Gallery, Kilkenny Carlow ETB Kilkenny, Kilkenny One Parent Community, Home Focus and SG Education Art Supplies.

The students all took part in the Kilkenny Final on Wednesday, 8th March which was held at Lyrath Hotel. Over 1,000 students from 12 schools took part in the annual programme with 130 students making it to the County final.



In the Junior Category, the students representing Kilkenny at the National Finals are Jane Kelly and Isabelle Doheny from Worry Not at Coláiste Abhainn Rí. They sold polished stones that consumers could use for meditation or to ease anxiety by rubbing. Cian Holohan and Jack Dooley from HD Horseshoe Designs at St. Kieran's College will be representing the County

at the Finals in the Intermediate Category. This company sold a variety of ornaments made from repurposed horseshoes.

In the Senior Category Kilkenny will be represented on 5th May by Michael Bookle, Conor Monks, Darragh Dack, Conor Kelly and Isaac Magnez from The Gaming Guard at Grennan College. 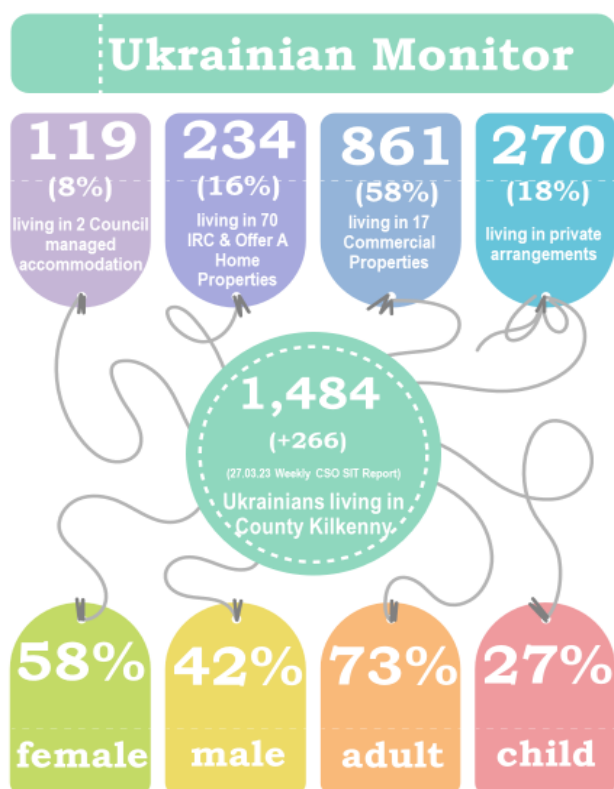

Thirty five residents in total from Upper Court Manor, Freshford and Clone Manor, Ballyragget attended the event. Forty-one residents attended the event at the St. John of God Convent with some Ukrainians participating in playing instruments and singing.

HOUSING

New Homeless Prevention Measures

As a result of the decision to lift the “Eviction Ban” Government have announced a suite of measures to prevent homelessness for households impacted directly by the activation of a notice to quit or notice of termination.

These measures include:

The Tenant In-Situ Acquisition Scheme – Social Housing Tenants HAP/RAS

Where a Valid Notice to Quit has been served and the person or household is eligible for social housing supports

Kilkenny County Council will assess the person's position on the social housing list, provide advice on the Housing Needs Assessment process and on the level of Housing Assistance Payment (HAP) that they may be eligible to receive. In some cases,

Kilkenny County Council will assess if they can acquire the property in which the tenant currently resides, if it is being offered for sale, under the tenant in situ scheme.

The Tenant In-Situ Acquisition Scheme – Non Social Housing Tenants

Where a Valid Notice to Quit has been served and the person or household is not eligible for social housing supports

Kilkenny County Council can provide advice and direct the person to the appropriate service, including supports to help with home purchase (www.firsthomescheme.ie, www.localauthorityhomeloan.ie)

We are aware that the Government is examining the implementation of a “First Refusal Scheme” for tenants to purchase their homes, as well as a cost rental in-situ scheme, where the Housing Agency will be resourced to purchase homes for rental to tenants in-situ. Kilkenny County Council will direct persons affected to the most appropriate service.

We would like to assure all potentially impacted that emergency accommodation will be a last resort only, where no other alternative can be identified.

A dedicated email address NTQEnquiries@kilkennycoco.ie has been set up to respond to queries and should be used by tenants who may have received a notice of termination or by landlords who have issued notices of termination to their tenants and who may wish to sell their property to the Council. Full contact details are now provided on our website.

The primary role of the Housing Department is to prevent homelessness. Every effort will be made to secure appropriate alternative accommodation to meet the assessed housing need of any household impacted by an active notice of termination of tenancy. All decisions will be based on need not preference and the acquisition of properties will only be considered when no other alternative is available. Kilkenny County Council has been approved to purchase 25 properties under the Tenant In-Situ Purchase Scheme. The Department have confirmed that this number may be increased subject to demand.

Croí Cónaithe, Vacant Homes Refurbishment Grant

Announcements have also indicated that the Government intend to revise the terms and conditions of the Croí Conaithe/Vacant Homes Refurbishment Grant Scheme. It is expected that the amount of the grant, the age of the property and the requirement for owner occupancy will be amended. These changes will not come into effect until a new grant scheme is formally announced. Applications submitted before a new scheme is implemented will be given the option to wait for the new scheme to be activated or to proceed on the terms of the current grant scheme. Housing Capital

The Housing Capital Delivery Team continue to develop new projects for commencement to achieve and exceed the targets included for Kilkenny under Housing For All. We are actively pursuing land purchases to bring more projects to design and planning stage.

Opportunities to activate vacant and brownfield sites are being considered at a number of locations.

The CALF Scheme for AHB delivery has been reviewed and a number of new AHB projects are now being brought forward for consideration.

The Team also intends to progress affordable housing options including affordable purchase, serviced sites and CPO projects.

FIRE SERVICES

Capital Projects

A site has been identified for a new Fire Station for Kilkenny City. Negotiations with the owners of the site are at an advanced stage at present.

The construction of a new Fire Station for Urlingford is due to be completed in June 2023.



Fire Safety Certificates

- 37 applications for Fire Safety Certificates were received to-date.
- 25 applications were received for the same period last year.

Fire Services Acts 1981 and 2003

- Fire Prevention staff made targeted inspections of premises both to provide advice and to enforce legislation.
- 5 Licence Applications were processed under Section 24 of the Fire Services Acts 1981 and 2003.
- 8 Fire Safety Inspections of premises have taken place so far this year.

Community Fire Safety

Fire Service Personnel call to houses by appointment and give fire safety advice to the occupants. A Home fire Safety Visit (HFSV) is usually carried out by two uniformed operational Fire Service Personnel.

The primary aim of these HFSVs is to reduce the numbers of fires, deaths and injuries in the home by firstly preventing fires occurring and to ensure that when fires do occur, the occupiers are given early warning and they know how to react quickly and safely.

Fire Brigade Operations

The Brigades have attended 136 incidents to date in 2023. These incidents included a number of road traffic collisions, public road hazards,

domestic fires, automatic fire alarm activations chimney fires and an increasing number of ambulance assists in recent weeks.

Fire Service Training

Breathing apparatus wearers undertake a two-day refresher course every two years. These courses reflect the breathing apparatus operational requirements of our Firefighters. This includes training on the safe working practices, equipment use and maintenance, set duration, operational testing to enable a firefighter to safely enter a building on fire, use of guidelines, distress signal and entry control procedures.

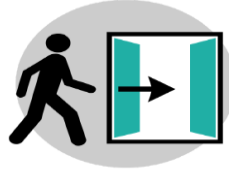

Citizen Science Kit



Kilkenny County Council Library Service is one of 10 library services nationwide involved in a pilot programme with the Heritage Council to offer access to a range of specialised equipment to members of the public.

The Citizen Science Kit initiative is designed primarily to enable local groups and members of the public to conduct their own studies on wildlife and assist people in contributing to the preservation of our biodiversity both locally and nationally. The Kits offer manuals, guides and equipment to assist people. The kit can be borrowed from Loughboy library by adults for up to 3 weeks.

Seachtain na Gaeilge

For Seachtain na Gaeilge we ran Beginners Irish Conversational classes in Graiguenamanagh and Thomastown libraries, funded by the KCETB. Both sessions were booked out and ran to great success. Ferrybank and Loughboy libraries also continued to run their Ciorcal Comhrá groups encouraging people of all levels to come and converse as Gaeilge. Our mobile library staff have commenced a series of outreach community programmes, bringing the library service to a wider audience.

Residents and staff of Tinnypark, Archersrath and Crosspatrick nursing homes have recently enjoyed *picture bingo games* as Gaeilge. Friends and family gathered with them on the day. In total, over fifty residents took part. Plans are underway to facilitate Poetry Workshops, to mark National Poetry Day on April 27th also. There was very positive feedback and it is hoped that more nursing homes will get involved with these outreach events over time.

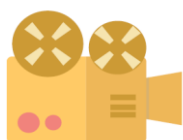

Finance Update

The bank overdraft facility was not utilised during the three-month period to the end of March 2023. The draft unaudited financial statements for 2022 were finalised and presented to Council at the March Plenary Council Meeting. The Local Government Auditor has commenced the Audit for 2022. The annual rate demands for 2023 were sent to all rate payers in February.

Rates Revaluation

Further to Revaluation 2017, 197 customers with a total rate demand value of €4.5m appealed their new valuation to the Valuation Tribunal. To date 193 appeals have been completed. The following is a breakdown of the appeal outcomes to date:-

<i>Decrease in Revaluation on Appeal</i>	149 cases
<i>Appeal Withdrawn</i>	34 cases

<i>No change to Revaluation on Appeal</i>	10 cases

The total annual Income lost to date stands at €853k.

Commercial Rates Vacancy

The commercial rates vacancy remains at 90% for 2023. A 90% vacancy strike off will be applied to eligible commercial rate accounts for 2023 where the customer formally applies, provides proof of vacancy and clears any outstanding rate arrears, where applicable.

Rates Incentive Grant Scheme 2023

The 2023 "Rates Incentive Grants Scheme" is available to all Rate payers subject to certain terms and conditions. As approved at Kilkenny County Council's 2023 Budget Meeting, Rate payers can avail of a grant of 5.8% of the value of their 2023 Rate Demand (excluding arrears) to a maximum value of €250. The terms and conditions of the 2023 "Rates Incentive Grants Scheme" are as follows. There are two payment options:

Option 1 – Pay in 2 Moieties

Pay your first moiety & arrears, plus any outstanding Property Entry Level (PEL), before the end of May 2023. Pay your second moiety before the end of October 2023 at the latest, and deduct 5.8% up to the maximum from your 2023 Demand.

Option 2 – Monthly Payment Plan

Pay your Rates & Arrears plus any outstanding PEL, in full in equal consecutive monthly instalments by standing order/ direct debit or by other consecutive monthly arrangement before the end of October 2023 and deduct 5.8% up to the maximum from your 2023 Rate Demand. **Your monthly payment plan must commence prior to 31st May 2023.**
