

### MAJOR PROJECTS

#### N24 Waterford to Cahir Scheme

Date for Publication of the Option Selection Report is Q2 2024.

To date no funding has been provided in 2024 to extend the project beyond Phase 2.

### MINOR PROJECTS

#### N24 Tower Road (Safety Scheme)

#### N77 Ballyragget to Ballynaslee

Construction of the scheme commenced on Tuesday 6<sup>th</sup> February 2024 with an expected 12-month time frame. Works are progressing well and are on schedule.



#### N24 Carrick Road

Kilkenny Council has received formal notification that An Bord Pleanála has approved the 177AE planning application subject to conditions and has confirmed the CPO without modifications as of the 20<sup>th</sup> March 2024. An eight-week period now applies to allow applications for leave to apply for judicial review. Should no applications issue a notice of the making of a confirmation order will be published within 12 weeks of the making of the order.

## Pavement Schemes

The design work is ongoing in respect of the N76 Callan By Pass Pavement Scheme. Design work and the preparation of tender documentation are on-going. The overall cost of the scheme is expected to be in excess of €4m with varying sources of TII funding necessary to deliver the scheme.

#### FREE Gardening for Biodiversity & Climate Action Workshop



## Kilkenny County Council Reduce Your Use Campaign




Kilkenny County Council's Reduce Your Use campaign has been a great success. The campaign (October 2023 to March 2024) consisted of promoting energy efficiency within the organisation with a particular focus on the Thomastown and Callan Area Offices.

[Reduce your Use](#) is a joint initiative of SEAI and the Office of Public Works which supports public bodies to run a winter energy awareness and energy reduction programme. The target is 15% energy reduction. The Kilkenny County Council project achieved 24% energy reduction in two buildings in the Callan/Thomastown MD. This was achieved with a combination of behavioural change and a small investment in energy reduction measures. ## ENVIRONMENTAL AWARENESS

### Litter Management Plan

The public consultation process for the Litter Management Plan 2024 – 2026 closed on 15<sup>th</sup> March 2024 and on the 22<sup>nd</sup> April 2024, the Litter Management Plan 2024 – 2026 was approved by the Plenary.



### Tree Care Webinar

Aoife Munn, a horticulturist completed a one hour webinar on the 1st of May and give tips on how to improve your tree care skills. Topics included staking, tree tie management, mulching, watering, pruning, and protecting young trees from pests and diseases. This was a collaborative project undertaken by the Environmental Awareness Officer, the Biodiversity Officer and Heritage.

### Air Quality Campaign

In conjunction with the Enforcement Team in Environment, the EAO is coordinating a targeted campaign throughout the city and county on air quality and the continued use of smoky coals. The campaign seeks to raise awareness amongst the wider public, stakeholders, businesses and schools about the health and environmental impacts of poor air quality and the ways individuals can help reduce pollution. This will be a 4-6 week campaign commencing the week of the 15<sup>th</sup> of April 2024.

## Council's call to action on air pollution



Solid fuel combustion releases harmful particles and gases into the atmosphere, leading to elevated levels of pollution

Kilkenny County Council says it is taking steps to monitor air quality and tackle air pollution, against a backdrop of Ireland facing a growing concern over harmful pollutants and fine particulate matter arising from burning solid fuels, such as coal, peat and wet wood.

One of the significant contributors to air pollution in Ireland is the burning of solid fuels for heating purposes. Solid fuel combustion releases harmful particles and gases into the atmosphere, leading to elevated levels of pollution.

Recognising this issue, the Irish government implemented new solid fuel regulations in 2012 to curb emissions from domestic heating sources.

The new regulations set stricter standards for the types of solid fuel

make a meaningful impact on air quality and reduce the health risks associated with poor air.

"Kilkenny County Council plays a vital role in implementing and enforcing these regulations, as well as taking additional measures to improve air quality within its jurisdictions. Here in Kilkenny, efforts are being made to monitor air quality levels, identify sources of pollution, and develop action plans to protect emissions and reduce public health.

## A call to action: addressing air pollution and poor air quality in Kilkenny



Ireland has been facing a growing concern over air pollution and poor air quality. According to statistics from the Environmental Protection Agency (EPA) and the World Health Organisation (WHO), the levels of harmful pollutants in the air have been on the rise, posing significant risks to public health and the environment.

One particulate matter arising from burning solid fuels such as coal, peat and wet wood, remains the biggest contributor to poor air quality in Ireland, with "worrying towns and even villages, according to the 2021 report in Ireland report reveals that multiple pollutants, such as nitrogen dioxide (NO2) and particulate matter (PM2.5), are exceeding the recommended limits in many urban areas across the country. These pollutants are known to cause a range of health issues, including respiratory diseases, cardiovascular problems, and even premature death.

Furthermore, the WHO estimates that air pollution is responsible for approximately 1,500 premature deaths in Ireland each year. These figures highlight the urgent need for action to address the root causes of air pollution and improve air quality nationwide.

One of the significant contributors to air pollution in Ireland is the burning of solid fuels for heating purposes. Solid fuel combustion releases harmful particles and gases into the atmosphere, leading to elevated levels of pollution. In response to this issue, the Irish government has implemented new solid fuel regulations in 2012 to curb emissions from domestic heating sources.

Francis Brophy, Executive Engineer for Air, Noise and Water in Environment, Kilkenny County Council commented: "The new regulations set stricter standards for the types of solid fuels that can be used for heating, aiming to reduce the emission of harmful pollutants and protect public health. By phasing out the use of high-polluting fuels and promoting cleaner alternatives, the government hopes to make a meaningful impact on air quality and reduce the health risks associated with poor air."

## Anti-Litter and Anti-Graffiti Grant 2024

Kilkenny County Council is offering community groups an opportunity this year to promote anti-litter and anti-graffiti awareness in their local community. The grant is to mobilize community groups to care for their local environment by decreasing the impact of litter by its removal and to promote a social message locally to encourage everyone to put litter in its rightful place – in a bin.

As funding comes directly from the Department of Communications, Climate Action & Environment there are funding restrictions which must be adhered to.

This grant **cannot cover**:

- the purchase structural items such as street furniture
- the purchase of litter bins
- the purchase of dog bag dispensers
- the purchase of signage
- the purchase or rental of CCTV cameras

The grant **can** cover expenses such as:

- The purchase of bags for dog bag dispensers if dispensers are already installed and are under the care of the group
- The expense of litter disposal resulting from litter picks and the expense of disposal of rubbish from public street bins which are under the guardianship of the community group
- Awareness events highlighting the issue of litter and dog fouling in your local community

## Team Up to Clean Up-Together for Kilkenny



The formal launch of the “Team Up to Clean Up-Together for Kilkenny” will take place on the week of the **27<sup>th</sup> of May, 2024**. An online portal will open for registrations on **Monday 27<sup>th</sup> of May**.

This year’s “**Team Up to Clean Up**” will take place on the **20<sup>th</sup>-22<sup>nd</sup> of September**.

Kilkenny has a wow factor that is the envy of other Irish counties. Kilkenny City is recognised nationally as a litter free location, regularly winning medals in the IBAL and Tidy Towns competitions and even being awarded the much-coveted title of overall Tidy Towns national winner on two occasions.

The County-Wide Clean Up initiative brought together residents, businesses, and local organizations to collaborate in a mass effort to enhance the cleanliness and sustainability of our county. Last year we saw over 200 groups register with over 500 volunteers participate. This culminated in a collection of just over 24 tonnes of litter.

The “Team Up to Clean Up” event created a sense of community ownership and pride by engaging participants in a variety of cleanup activities, awareness campaigns, and environmental educational programs. It created a sense of ownership and focus for many communities, with significant additional interest by many groups and individuals outside of national campaigns such as the annual National Spring Clean which takes place during the month of April. All cohorts of society engaged resulting in the “Team Up to Clean Up” exemplifying best practice in the areas of social inclusion and environment.

We aim to take this event one step further this year by investing in the next generation of stewards through the Green Schools Programme and developing a series of education and awareness workshops.

## **WASTE**

### **Bring Banks Usage**

The Council provides and manages 46 Bring Centers across the City and County. A total of 684 tonnes of recyclables were collected from our Bring Centers so far in 2024. This represents that the 1% decreased to the prior year during the same period. Aldi - Kilkenny city (16 tonnes collected), Lidl - Johnswell, Kilkenny City (13 tonnes collected), Loughboy shopping center - Kilkenny City (12 tonnes collected), and are the busiest locations in the City. Aldi - Ferrybank (8 tonnes collected), Lidl - Thomastown (8 tonnes collected) and Aldi - Callan (7 tonnes collected) are the busiest outside of the city. Environment staff are continuing to work very closely with our service providers to ensure the collection service is in keeping with demand, especially around long weekends and holiday periods.

### **Dunmore Civic Amenity Site**

The Dunmore site continues to provide an excellent and essential service to the greater Kilkenny community and has cemented its place as one of Kilkenny County Council’s leading service providers with the addition of the Kilkenny Countryside Park on the closed Landfill site. This combined amenity has seen many recycling conscious people combine their trip to the Dunmore CAS with a healthy walk in the Countryside Park during March 2024.

## **AIR NOISE WATER**

### **Water Quality - Farm Inspections**

Inspections are ongoing with regards to Agricultural & Domestic Wastewater Treatment Systems in the county in order to reach our RMCEI targets for 2024. We will also be conducting call backs in the coming months on inspections carried out in 2023 to ensure issues around non compliances have been rectified.

A meeting was recently held with the Environment Section of Kilkenny County Council and the Oversight & Reporting Team in the EPA for Agricultural Inspections. Various issues were discussed including the total number of National Agricultural Inspections that Kilkenny County Council have to complete in 2024 and reporting requirement for each inspection. A number of new staff are currently being recruited to specifically carry out these attentional farm inspections and the training courses are being set up in Gurteen Agricultural College next month for staff to get the appropriate training.

### **Air Quality**

The Environment Section of Kilkenny County Council will start a media campaign with regards to air quality in the county and how we can improve it. The burning of fossil fuels releases particulate matter emitting an array of pollutants that reduce air quality and harm life, especially Sulphur Dioxide, Nitrogen Oxides, and airborne particles such as soot.

In conjunction with the Enforcement Team in Environment, the EAO is coordinating a targeted campaign throughout the city and county on air quality and the continued use of smoky coals. The campaign seeks to raise awareness amongst the wider public, stakeholders, businesses and schools about the health and environmental impacts of poor air quality and the ways individuals can help reduce pollution. This will be a 4-6 week campaign commencing the week of the 15<sup>th</sup> of April 2024.

## Environment Complaints

All Environmental complaints received are logged on the CRM (Customer Relations Management) System. The number of complaints that have been received and logged for April 2024 is 81 compared to 70 for the same period last year, an increase of 16%. The nature of these complaints ranged from littering, illegal dumping, burning of waste and abandoned cars. The majority continue to be related to littering and illegal dumping. Whilst every effort is made to bring unacceptable environmental practice into compliance, Environment Enforcement staff continue to manage significant enforcement cases progressing through prosecution cases.

## Community Monuments Fund

The Environment Section of Kilkenny County Council submitted Community Monument Fund Applications for Stream 1,2 & 3 projects in 2024.

The Council recently received notification of €572,057.48 being awarded under the 3 Streams

### The Community Monuments Fund has 3 Streams:

*Stream 1* will offer grants up to €100,000 aimed at essential repairs and capital works for the conservation and repair of archaeological monuments

*Stream 2* will offer grants of up to €30,000 for development of Conservation Management Plans/Reports that are aimed at identifying measures for conservation of archaeological monuments and improving public access.

*Stream 3* will offer grants of up to €30,000 for enhancement of access infrastructure and interpretation (including virtual/online) at archaeological monuments.

## PARKS & SPECIAL PROJECTS

### South East Greenway

#### Lot 5a Ferrybank to Curraghmore

Glas Civil Engineering Ltd., commenced works on Lot 5A (c.5.5km section from Ferrybank to Curraghmore) in November last and works continue to advance to schedule. Works are currently progressing at Glenmore carpark and fencing has also started along the site. Works at a number of agricultural crossing locations are also well underway, online works also continue with c. 90% of the greenway sub-base completed along this Lot and the anticipated contract completion date remains the end of this year.



#### Adjoining Landowners

The Project Landowner Liaison Officer is continuing to engage with landowners adjoining the greenway in relation to boundary treatment and crossing points. The parameters for these discussions are set out within the Charter for South East Greenway Accommodation Works.

#### Technical Consultants

Three tenders were received following the tender process for the provision of Technical Services for a multi-disciplinary engineering consultancy team to complete all remaining phases of the greenway. The Tender Assessment and Recommendation Report has been finalised and issued to Transport Infrastructure Ireland (TII) for approval and it is expected to have this appointment process concluded in May.

#### Land Acquisition from Córas Iompair Éireann (CIÉ)

Legal contracts have now been signed by both the Local Authority and CIÉ and the final conveyance works are progressing to conclude the acquisition of the lands along the abandoned rail corridor.

### Outdoor Recreation Instructure Scheme (ORIS)

#### Millennium Forest - Trail Enhancement and Accessibility Scheme

A contract was recently awarded to Shay Power Ltd., to carry-out trail enhancement and accessibility works in the Millennium Forest just outside the city. This contractor was procured using Coillte's Works Framework. Works are expected to commence in May and will include carpark and entrance enhancements, significant upgrading of the existing Green Loop to include 2.1km's of trail rehabilitation to facilitate universal access with a particular focus on wheelchair users. Other works include improvements to the longer Red Loop, the provision of universal and age friendly accessible amenity spaces, delineated disabled and age friendly car parking spaces. The wheelchair accessible toilet (Dry loo) which was installed last year under this scheme will be opened to the public in tandem with the completion of the overall project, which includes an access path to same. Funding of €200,000 to facilitate the above was secured under the ORIS Measure 2 and with match funding from the Council's own resources the completed project will see an investment of €227,000 into this public amenity.

### **Lacken Boardwalk Replacement Scheme**

Following a competitive tender process the works contract for the Lacken Boardwalk Replacement Scheme was awarded to Triur Construction Ltd. The recycled plastic component's for the boardwalk have been signed off by the design team and the contractor has ordered same with works expected to commence in the coming weeks. It is noted to facilitate these works sections of the boardwalk will be closed to the public during this period.

The completed project will see the replacement of the existing 1.2m wide timber boardwalk with a c.3.6m wide boardwalk made from recycled composite materials. Funding for this project was secured under Measure 3 of the Outdoor Recreation Infrastructure Scheme in the amount of €500,000 which will be supplemented from the Council's own funds.





### **Jeninstown Wood Enhancement Scheme**

All works associated with the Jeninstown Wood Enhancement Scheme are now completed with the exception of new signage which is designed and at manufacture stage. It is expected that the signage will be ready for installation in the coming weeks.

The completed work provides for a new 1.2km trail around the Deerpark area within close proximity to the carpark and amenity area. This new walk will be called the *"Last Rose of Summer Walk"* in acknowledgment of Irish writer and poet Thomas Moore who wrote his poem the *Last Rose of Summer* while staying at Jeninstown House in 1805.

Other works completed include c.2km of upgrades in the form of trail reconstruction and drainages provision to existing walks, significant enhancements at the picnic area to make this amenity space more attractive and accessible, the provision of bike parking, installation of hand rails and landscaping.



Funding of €200,000 to facilitate the above was secured under the ORIS and with match funding from the Council's own resources the completed project will see an investment of c.€227,000 into this public amenity.

### **Kilkenny Countryside Park**

The inaugural Kilkenny Junior Park Run took place on Sunday 21<sup>st</sup> April in the Kilkenny Countryside Park at Dunmore. The event was a great success with 175 participants and 26 volunteers in attendance. This free, fun and friendly 2km event, which will be held every Sunday morning, is suitable for children of all abilities aged from 4 years to 14 years old. These events offer families the opportunity to get involved and get active in the outdoors. Kilkenny County Council are delighted that our new Countryside Park was identified by Parkrun Ireland and the local volunteer group as the location for the Kilkenny Junior Park Run, and numbers attending to date have been very positive with the expectation the event will grow week on week.



The Library Services have also rolled out their Slí Na Scéalta outdoor family reading experience in the Kilkenny Countryside Park. This fun learning experience, featuring author Brendan McDonald's story "The Elephant on the Farm", is displayed across story panels located around the 1.3km accessible trail, so you can follow the story from beginning to end as you walk! The trail was previously located within Woodstock Gardens and proved very popular with our younger visitors.



## Woodstock Garden & Arboretum

### Tea Room

Both offerings will open 7 days a week in July and August, returning to weekend opening only during September until the end of the season.




### Woodstock House - Historic Structures Fund

Having secured funding, earlier in the year, under the Historic Structure Fund, to help secure the external walls of Woodstock House and remove vegetation, a tender competition was run to engage a specialist consultancy team to prepare the works contract for same. This process is now completed and a conservation consultant engineering firm were recently appointed. It is expected work will be undertaken in Q4 this year and Q1 in 2025.

## Tracks & Trails

The South Leinster Way from Graignamanagh to Inistioge featured on the Tracks and Tails programme on Friday the 3<sup>rd</sup> May at 7.30pm on RTE One. The programme also focused on Woodstock Gardens where host Dr. Ruth Freeman discussed the story of the gardens with Head Gardener John Delaney. Kilkenny Tourism and the Parks Office have been working with the producers of this programme since last year and the show, which also featured the Nore Valley Walk from Kilkenny City to Bennettsbridge, attracts a huge audience and we hope to see an increase in visitor numbers to the city and county over the coming months on back of same.



## Playgrounds

Enhancement works and repairs were carried out in a number of playgrounds across the City and County during the month of April. Some of the works included the painting of the timber play components in the playgrounds in Johnstown and Kells. A large new biodiversity mural was also painted on the wall within the playground in Stoneyford. This mural was painted by local artist Dan Leo in conjunction with Street Art Ink. The Project was co-funded by the Parks Department and the Environment Section with the latter securing funding through the Anti-litter and Anti-graffiti Awareness Grant.

## FORWARD PLANNING

### Masterplans:

#### Abbey Quarter

A variation to the Kilkenny City and County Development Plan 2021 – 2027 (CDP) is required to incorporate the Abbey Quarter Masterplan User Guide into the CDP. Work will commence on this in Q1 2024. The Variation will require approval by the elected members. The publication can be accessed at:

#### St. Canice's Campus

A draft masterplan has been completed and the necessary environmental reports prepared and all documentation is being currently proofed. It is anticipated that the draft masterplan and environmental documents will be presented to the Kilkenny City Municipal District members mid 2024, before being placed on public display for a round of public consultation.

#### Ballyragget/Paulstown/Kilmacow

Masterplans are also being prepared for the settlements of Ballyragget, Paulstown and Kilmacow. Three public meetings, one for each town, have taken place. The feedback / inputs from these meetings have been incorporated into the draft Masterplans. The draft masterplans for Ballyragget and Paulstown were presented to elected members at the March Castlecomer MD meeting and placed on public display for a 4 week period from Friday 5<sup>th</sup> April until close of business on Friday 3<sup>rd</sup> May. A total of 9 submissions were received in relation to the draft Paulstown Masterplan and a total of 12 submissions were received for the draft Ballyragget Masterplan. A public drop in session was held in Paulstown on Monday 22<sup>nd</sup> April, from 5-9pm and in

Ballyragget on Tuesday 23<sup>rd</sup> April from 5-9pm. Approximately 60 people attended on each night.

The submissions on both these plans are now being assessed and a report currently being prepared and it is anticipated that these plans will be presented to the elected members at the Castlecomer MD meeting in June for adoption.

The draft Masterplan and associated environmental documents for Kilmacow were circulated to the elected members in the Piltown MD. The elected members will now arrange a workshop to discuss the plan, prior to it being presented. This workshop will be scheduled before the end of May, and depending on the outcome of this workshop, the draft plan and associated environmental documents will be presented at the June Piltown MD meeting, prior to the draft masterplan being placed on public display for a 4 week period. A Walk-in public meeting will also be scheduled for Kilmacow during the public display period.

### **Local Area Plans**

#### **Ferrybank / Belview Local Area Plan**

Tenders have now been assessed and consultants, namely KPMG and Future Analytics have been appointed. An inception meeting has been held with the consultants and they have advised they expect to meet the timeline of a new LAP in place by Q1 2025.

The consultants will shortly prepare an issues paper and arrange for public consultation on same. The drafting of the LAP also provides for the preparation of environmental reports and publication of a draft plan, statutory public consultation and the final LAP to be presented for approval by the Council.

#### **Castlecomer Local Area Plan**

The Castlecomer Local Area Plan (LAP) is at pre-draft stage, with an issues paper currently being finalised and consultants being appointed to carry out a Flood Risk Assessment. It is estimated that a draft LAP will be advertised in Q3 of 2024 and a public consultation event will be held in Castlecomer once notification of the Councils intent to carry out this LAP is advertised.

#### **Cluster Housing Design Guidelines for Co. Kilkenny**

Consultants, Place +Urbanism Ltd, have been appointed to carry out Cluster Housing Design

Guidelines for County Kilkenny. An induction meeting was held with the consultants in February and after several weeks of gathering data, they have presented a potential format for the document, which they are finalising presently. A workshop will then be held with the Development Management Section of the Planning Dept. in June at which the document and its format will be presented and discussed. It is anticipated that a draft document for public consultation will be ready by Q3 2024.

### **Taking in Charge**

Lime Grove in Ferrybank has progressed through initiation stage and the developer is progressing final works. Works are also continuing on various estates throughout the City and County.

### **Active Land Management**

A Draft Annual Map of lands in scope for the new Residential Zoned Land Tax (RZLT) was published on the 31<sup>st</sup> January 2024. The first submission period has now closed, and 8 submissions were received on inclusions or exclusions to the land in scope for the tax. The second submission period, for landowners to make requests regarding a rezoning of their land, is still open until the 31<sup>st</sup> May.

There are 23 Vacant Sites on the Vacant Sites Register, and the number of cancelled entries due to site activation or improvement is 24. The Vacant Site levy (VSL) will be replaced by the RZLT from 2025, but any outstanding VSL's will remain due to the Council.

### **Conservation**

The Conservation Office manages all protected structures in Kilkenny County and City. These structures are recognised for the following special interest: Architectural, Historical, Archaeological, Artistic, Cultural, Scientific, Technical, Social.

An advisory service on conservation matters is provided to the public and colleagues, while the conservation grants and funding applications are also delivered.

**Built Heritage Investment Scheme:** Meetings have taken place with owners and project agents. Projects will now be tendered to suitable contractors.

#### Local Enterprise Office - Summary of 2024 Awards to Businesses

- €160,412 in direct financial assistance was approved for manufacture/export service businesses in located in throughout the county (€130,750 in Business Expansion Grant assistance and €29,662 awarded in feasibility study grant assistance).

- 4 Technical Assistance for Micro Exporter grant awarded to support them in exploring new export market opportunities.
- 14 Businesses have commenced LEAN one to one consultancy programmes to investigate possible resource efficiencies and process improvements their businesses.
- 8 Business is availing of the Digital Start programme to prepare and implement a plan for the adoption of digital tools and techniques across the enterprise.
- 6 business have been approved a Trading Online Voucher totalling €14,136 to support the enhancement of their online trading capacity.
- 6 Green for Micro Grant awarded. This scheme supports businesses to becoming greener and environmentally friendly.
- 4 applicants have been supported to make loan applications to the Micro Finance Ireland loan fund.
- 532 people participated on focused small business training, including 23 people participating on the Starting Your Business programme.
- 211 businesses have availed of specialised business specific mentoring on a variety of topics including finance, marketing, social media marketing and HR.

#### Broadband/ Digital Update

Digital Strategy Consultants Ltd, have complete a final report on the digital audit of assets, services and processes within Kilkenny County Council which is the first step in preparing a 3-year digital strategy for Kilkenny. The second phase of the process in the development of a digital strategy for the citizens of County Kilkenny.

Digital Strategy Consultants Ltd have been appointed and will carry out a stakeholder engagement process both internally and externally over the coming months with the final digital strategy due to be completed in Summer 2024.

Kilkenny County Council hosted the Telecommunications Action Group Meeting (TAG) on 25<sup>th</sup> April in the Council Chamber. Representatives from the Department of Rural and Community Development (DRCD) and Local Authority Broadband Officers attended the meeting.

A number of attendees availed of the opportunity to visit the new Mayfair Library.

## Night Time Economy

The Kilkenny City pilot Night Time Economy plan was launched in St Canice's Cathedral on Tuesday 30<sup>th</sup> April. The plan was published in tandem with the launch of Fáilte Ireland's Destination Experience Development Plan. The Action Plan offers a structured framework to continue nurturing Kilkenny's vibrant night time economy. Built upon four strategic pillars – placemaking, mobility & accessibility, safety & security, evening & night time activity and marketing and promotion, the 24-point plan sets out objectives and actions aimed at collectively strengthening and invigorating Kilkenny's night time economy over the next 18 months.



### CLÁR (Ceantair Laga Árd-Riachtanais)

CLÁR is a targeted investment programme for rural areas that aims to provide funding for small infrastructural projects in areas that have experienced significant levels of de-population. The funding works in conjunction with local/Agency and other Departmental funding programmes and on the basis of locally identified priorities.

The CLÁR programme allocation has increased to €8.7million nationally in 2024. The CLÁR 2024 programme will be delivered through 3 separate Measures as follows:

- Measure 1:** Developing Community Facilities & Amenities
- Measure 2:** Mobility, Cancer Care and Community First Responders Transport and Meals on Wheels Transport.
- Measure 3:** 'Our Islands'

**Measure 1 is administered through Kilkenny County Council, and can be applied for by Kilkenny County Council in conjunction with groups in Local Communities. Measure 2 and Measure 3 is being administered through the Department of Rural & Community Development.**

Kilkenny County Council is seeking applications for the CLÁR 2024 funding scheme from Community Groups. Measure 1 will support a variety of capital interventions that contribute to the enhancement of existing, and/or the development of new, accessible Community Recreation Facilities. The list below provides an indication of the types of interventions that may be supported, but is not exhaustive:

*Multi-Use Gaming Areas (MUGAs)/Astro-Turf Facilities, Skateboard Parks, Playgrounds, Handball Alleys, Tennis Courts, Basketball Courts, Community*

*Gyms, Community Cinemas, Sensory Gardens, Community Gardens, Outdoor Bowling areas, Walking/Running Tracks, Outdoor Toilet Facilities, Car Parking, Public Lighting.*

Measure 1 applications can also include small scale renovation works to community facilities. In addition, Measure 1 will support projects which develop and enhance access to unique local heritage sites and/or areas of natural beauty in local communities e.g. Walkways to important local sites. The Department is encouraging and promoting an enhancement of biodiversity when reinstating/landscaping areas e.g. native pollinator plants under Measure 1 of the CLÁR 2024 programme.

### Grant Aid

A minimum grant of €5,000 and a maximum grant of €50,000 for projects will be available. The maximum grant payable will be 90% of the project cost or a maximum of €50,000, whichever is the lesser. The remaining 10% or balance of the cost should be provided through local authority/community/other resources with a minimum of 5% cash contribution from the Community. Philanthropic contributions may be accepted as full or part of match funding costs.

### **Kilkenny Swift Programme**

Kilkenny County Council in conjunction with BirdWatch Ireland hosted a Swift Online talk targeting local builders, engineers and architects to promote the integration of swift nest bricks into new construction builds. Over 40 people attended online. The Saving Swifts Publication and Birthday Wall Calendar was distributed to local firms to highlight the upcoming webinar and the wall calendar was designed to highlight the special habitats and floral species on Kilkenny City's Historic Stone Walls.

**A Discussion Paper on Biodiversity** The Biodiversity Officer continues to promote the Biodiversity Discussion Paper, inviting people to express their views on what should be included in the County's Biodiversity Action Plan which will be prepared over the summer. The consultation period is open until the 28<sup>th</sup> May, 2024.

### **Biodiversity Week 2024**

Keep an eye out for the range of Biodiversity activities which are being planned for around Biodiversity Week which runs from the 17<sup>th</sup>-26<sup>th</sup> of May. Events are running countywide, from the 16<sup>th</sup> of May - 5<sup>th</sup> of June. Activities will include library talks, bat walks, a moth identification workshop and a number of different organisations are also organizing their own events. Spot the 6 different art pieces from the Creative Ireland Leave the Long Grass Grow project which will be displayed across the City.

### Oral History Ireland Networking Event

The Oral History Network of Ireland in partnership with the Heritage Office hosted a Networking Event on Saturday 13<sup>th</sup> April at Kilkenny City Library. The event was well attended and provided an opportunity for oral historians in the South East to meet in an informal setting to discuss ideas and meet other people involved in oral history in region.

### Bees for Biodiversity Project

The Heritage Officer, Regina Fitzpatrick spoke at the launch of "Bees for Biodiversity Project" at Rothe House organised by Kilkenny Volunteer Centre on Thursday 25<sup>th</sup> April, 2024. For the past year volunteers from all around Kilkenny, Carlow and Waterford have been knitting and crocheting bees, flowers and insects with Bernadette Roberts who retired from Kilkenny County Council Heritage and Arts Office last year. All the work will be curated by artist Sheila Jordan for National Biodiversity Week and National Volunteering

Week - 20<sup>th</sup> to 26<sup>th</sup> May and will be on display in St. Canice's Credit Union window and John's Green House Gallery window from 13<sup>th</sup> May.



### **Creative Ireland Heritage Office/Library Service Programme**

This year marks the 700<sup>th</sup> Anniversary of the Kilkeny Witch Trials, during which Alice Kyteler became the first person in Europe to be condemned to death for Witchcraft and Petronella de Meath became the first person to be burned at the stake for witchcraft. Funded by Creative Ireland, the Heritage Office in partnership with the Library Service will curate a programme of initiatives to commemorate this iconic event in our history and will engage a wide audience (primarily focused on younger people) in creativity and heritage in County Kilkeny through this story. This will include author talks, an educational resource pack and creative workshops for primary school children, history workshops for secondary school children, a video shorts series for young adults and a witch trial tour for the general public.

### **Public Commemoration Programme 2024**

Kilkeny County Council received an allocation of €15,000 from the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media under the new Public Commemoration Programme. This programme follows on from the highly successful Decade of Centenaries Programme. The Public Commemorations Committee have allocated this funding towards two projects: the production of a podcast on the Kilkeny Witch Trials which will be broadcast on the anniversary of the trials 700 years ago. The second project *Mná Feasa/Wise Woman* is an inter-generational story telling project facilitated by Artist Helena Byrne and involving female transition year students and older women in Kilkeny. The theme of women and power will be explored in this project to commemorate the women convicted in the

Kilkeny Witch Trials. The project will give voice to older women in Kilkeny by recording their stories and empower young women to interpret these stories through performance. The collection will be then archived in the Kilkeny Digital Archive and edited into a podcast for broadcast to a wider audience.

## **ARTS**

### **Poetry Broadsheet**

The 2024 Kilkeny Poetry Broadsheet editor James Harpur has made his selection of poems for the 2024 publication. He has chosen thirteen poems from thirteen different poets, who include: Cathy Hogan, Fergal Canton, Ian Chambers, Janis Woodgate, Alice Bennett, Gobnait Kearney, David Kirby, Susie Lamb, Noel Howley, Carmel Hogan, Angela Esmonde, Aoife Riach and Paddy Doyle. All selected poets are delighted to have their poem selected and published in our twenty fourth edition of this very popular Arts Office publication. Illustrator Tim Harper will design and illustrate the final Broadsheet.

### **Professional Development Opportunities for Artists.**

On April 10<sup>th</sup> expert facilitator and life coach Anne Tannam ran a very successful workshop for artists of all disciplines on practical skills required to design and deliver workshops. The group was diverse, and all were very engaged throughout. There was opportunity for group discussion and connection as Anne shared methodologies for effective facilitation.

On April 9<sup>th</sup> Richie Egan delivered the first of Career Development Talks for Emerging Musician in Cleeres Bar. Eight people attending which created an imitate discussion followed by a Q & A session with Richie.

On April 10<sup>th</sup> Liz McMahon ran a CPD workshop for artists whose practice is focused on working with children and young people. Liz led the participants through two project she ran in primary schools, one of which was a Percent for Arts Project. There was great interest in her work and participants were keen to hear about her approach, with lots of questions and discussion. Two participants highlighted how vital these opportunities to connect with other artists and hear about their work.

### EDI Bursary

We received eleven applications for our new bursary - Equality, Diversity and Inclusion (EDI). The EDI Bursary will offer financial support of €5,000 for an artist across all artforms who is from under represented background, including those based on age, civil or family status, disability, gender, membership of the Traveller Community, race, religion, sexual orientation, and socioeconomic status. Assessment will be commencing in early May.

### Performing Arts

The Arts Office are currently undertaking a Performing Arts Needs Analysis with Kilkenny's sector. This is being undertaken in collaboration with the Irish Theatre Institute. The current supports that are available to the performing arts in Kilkenny are being evaluated in order to refine how we can support career development for performing artists and organisations and provide opportunities to nurture the sector at this time. The Needs Analysis will consist of an online survey, a session with Kilkenny based key informants and four in-depth interviews with national and internationally based performing arts professionals.

### Climate Action Collaboration project

As part of our commitment to climate action we are working collaboratively with the Local Authorities of Wexford, Cavan, Clare, Galway and Offaly on a research phase with a view to developing an artists assembly. The Creative Sector is essential for climate adaptation. It is critical to use this time to learn what the ecology of our own community is, where the interdependencies lie, and what unique opportunities for collective action could emerge through a specific Climate Art Assembly.

Art is a critical pathway because it does not rely on language alone, communicating through emotion and the senses.

### Rhyme Rag - Youth Arts

Ten poems have now been selected by Rhyme Rag Editor Colm Keegan. Four of these poems have, to date, been published on our Rhyme Rag Instagram page and our other social media platforms. This year the editor produced audio feedback for the students to listen to, giving it a personal touch.

### The Art of Change - Youth Arts

Four workshops for the project have now taken place with a group of 7-10 young people attending each session. So far, they have attended an information session on Climate Change by Education for Sustainability, a workshop on sustainable fashion by The Rediscovery Centre, an illustration and food experience with artist Rudi-Lee McCarthy and workshop with Alan James Burns creating brain wave imagery which naturally reflect shapes and images found in nature.

### Climate Action Community Arts - Waste Not Want Not

As part of our Community Arts and Climate Action 2024 programme Waste Not Want Not. The Arts Office will be running another set of sewing workshops after the successful and very positive feedback of participants in the 'Sewing Machine Basics Classes' at St. Canice's Community Hall and Thomastown over the past few months. This set of 'Upcycling Sewing' classes will take place at Harry's Bar in Langtons, John Street, Kilkenny for anyone who have a passion for transforming and repurposing textiles

and fabrics saving clothing from landfill and giving new life. The classes will take place across May and June with three time slot options. This programme is part of our Climate Action programme plan for 2024



A new phase of the Waste Not Want Not programme has commenced in the City working with participants to make a collaborative piece from recycled denim in partnership with our local St Vincent de Paul charity shop.

## HOUSING

The Directorate of Housing incorporates a wide range of services for applicants and tenants to facilitate and support the provision of independent and supported accommodation.

The following information gives the up to date progress for 2024 under the various support services.

### Affordable Homes:

Applications Open for 45 new affordable homes in Kilkenny. 35 at Nyne Park, Callan Road & 10 at Cluain Glasan, Granges Road

Kilkenny County Council, working in partnership with Developers Cairn & Glenveagh Homes Ltd. and the Department of Housing, Local Government & Heritage is delighted to launch the first two schemes of Affordable Homes in Kilkenny City under the Local Authority Affordable Purchase Scheme.

The Cairn development, comprising a mix of A-rated 3-bedroom homes, is located at Nyne Park, Callan Road. Homes will become available on a phased basis from Q2 to Q4 of this year.

Successful applicants will be able to avail of up to €90,000 reduction on the full market price, depending on the price of the property and the applicant's own financial circumstances.

The houses in both Schemes are generally targeted at first-time buyers (exceptions apply) who need assistance bridging the gap between their own available funds (including the Help to Buy scheme), the mortgage that they can obtain and the cost of the new home.

Making these homes available for sale at discounted prices has been facilitated through the Affordable Housing Fund (AHF) which is a subsidy provided by the Department of Housing, Local Government & Heritage to Local Authorities as a direct subvention on housing development costs.

Under the Affordable Purchase Scheme, managed by Kilkenny County Council, eligible buyers will be able to purchase their own new home by availing of this shared equity scheme. Under the Scheme, Kilkenny County Council will retain an equity share and successful applicants have the option of buying out this share over time. Equity shares are calculated on an individual basis and are linked to an applicant's income, their savings and their mortgage capacity.

Applications which are incomplete or those not accompanied by the required documentation will be deemed invalid.

## HOUSING LOANS

The Tenant (*Incremental*) Purchase Scheme 2016, which allows local authority tenants to buy their homes is being revised as of from 29th January 2024. Changes to the scheme are as follows:

- **Minimum Income Requirements:** The minimum income required for an applicant to be eligible to apply under the scheme has been revised from €12,500 to €11,000 per annum. (*At least 50% of which must come from a reckonable primary source of income*).
- **Primary Sources of Income:** In addition to employment and the State Pension (*Contributory and Non-Contributory*) being considered as primary sources of income, the Widow's, Widower's, Surviving Civil Partner's (*Contributory and Non-Contributory Pension*), Blind Pension, Invalidity Pension and Disability Allowance are now also considered primary sources of income.
- **Time Receiving Social Housing Supports:** The period of time tenants will be required to be in receipt of social housing support to be considered eligible under the scheme remains at 10 consecutive years. However, in the case of joint tenancies only one tenant is now required to have been in receipt of social housing supports for 10 years.
- **Income Included / not included as a Secondary Income for Assessment:** Changes have been made to income that can be considered and not considered as secondary income when assessing for discount.



### Offer of Home Programme

The 'Offer a Home' programme is being managed by Local Authorities on behalf of Government. A Government tax-free recognition payment of €800 per month is available to property owners offering accommodation to those fleeing the Ukraine.

The 'Offer a Home' programme is currently seeking property owners who have a house, apartment or holiday home that is not currently being used to offer it to people and families from Ukraine who need a safe place to stay for short-term accommodation. When owners commit to a pledge of their vacant property, suitability is determined by Kilkenny County Council. When Ukrainian residents commence residing at the property, a licence agreement is signed by both owner and residents for minimum period of six months. The conditions attached to the pledge of a property are set out in the Licence Agreement.

For existing Licence Holders who have committed to the Offer of a Home Scheme, all licences can only be extended to March 2025 in line with the Temporary Directive. ### Local Area Integration Team (LAIT)

The LAIT continue to connect with residents in both Council managed properties, the 2 IPAS Centres, and have expanded their reach to the commercial properties with Ukrainians in residence. The team are currently in the process of meeting residents in all properties to establish needs.

An online Directory of Local Services is currently being developed to ensure accessibility. LAIT's are actively signposting individuals to the appropriate services and ensuring avoidance of duplication through maintaining strong communication with key agencies/stakeholders. The Community Integration Forum has issued the new terms of reference and has formally invited member organisations to nominate representatives to the Forum.

LAIT team attended a National Network of Integration Support Workers & Integration Support Coordinators in April focusing on the establishment of a national network for teams to ensure a streamlined approach across the board. Africa Day is being hosted in the Castle Park on June 1<sup>st</sup>. The LAIT are supporting the African community in coordinating this event. It is expected to be a fun day with music, dance and African cuisine.

## FIRE SERVICES

### #Capital Projects

Urlingford Fire Brigade will host the official opening of its new fire station on Wednesday 29<sup>th</sup> May 2024. Urlingford Fire Brigade will also be receiving their new Fire Engine in the 2<sup>nd</sup> week of May 2024.

The design of the new HQ fire Station for Kilkenny City is progressing well.

All major construction projects, including major refurbishment projects at Fire Stations require capital funding from the NDFEM. Ongoing day-to-day maintenance of Fire Stations is funded from the Council's revenue budget.

### Fire Safety Certificate Applications

- 34 applications for fire safety certificates were received to date.
- Ukrainian Response Unit - Fire Safety Certificate compliance
- A large number of risk premises throughout Kilkenny City and County have been subject to review and fire safety certification applications to ensure minimum standards.

### Fire Services Acts 1981 and 2003

- Fire Prevention staff made targeted inspections of premises both to provide advice and to enforce legislation during 2023.
- 9 Licence Applications were processed under Section 24 of the Fire Services Acts 1981 and 2003.
- 7 licence applications under the Dangerous Substances legislation were assessed to date.
- 27 Fire safety inspections of premises have taken place in 2024.

### Fire Brigade Operations

The Brigades have attended 373 incidents to date in 2024. These incidents included a number of road traffic collisions, house fires, ambulance assists, chimney fires and automatic fire alarm activations.

### Recruitment of Retained firefighters

A competition for the recruitment of Retained Firefighters is well underway for Kilkenny City, Castlecomer, Freshford, Urlingford, Thomastown, Callan and Graiguenamanagh. Shortlisting and suitability tests have taken place to date.

### Fire Appliances

Fire and Rescue Service maintain fire appliances in all seven (7no) fire stations throughout the County.

There are a variety of different types of appliances in operation i.e. Standard Class B Pumping Fire Appliance (normal fire appliance), Emergency Tenders, Combined Aerial and Pumping Appliances, Water Tankers, Incident Command vehicle and 4-Wheel Drive Vehicles with off road capabilities.

Kilkenny County Council Fire and Rescue Service have received the replacement of Graiguenamanagh 2<sup>nd</sup> Class B Fire Appliance. We will continue with a replacement programme and refurbishment programme as capital funding is made available.

### Primary School Programme

Fire and Rescue Service continue to deliver the National Directorate Fire and Emergency Management Primary Schools Programme. It is targeted at all 3<sup>rd</sup> Class Primary School children. The fire authority has delivered this programme from inception in 2006 and every year subsequently (*except during the recent pandemic*). Over 20,000 pupils have participated in the Primary Schools Programme to-date.



The Fire Authority has provided training and refresher training for a number of firefighters in each brigade to assist them to deliver this Programme to all school children in 3<sup>rd</sup> classes in Kilkenny City and County where the school management accept our invitation to visit their schools.

### Training

Fire and Rescue Service are obliged under the Fire Services Acts 1981 and 2003 and the Safety, Health and Welfare at Work Act 2005 to ensure that our Fire-fighters and Officers are adequately trained and competent to deal with tasks and varying roles they may encounter in the performance of their duties.

All personnel responding to Fire and Rescue Service incidents require a minimum level of training to meet core requirements. In addition, many personnel also require further training for specialist or supervisory roles. Furthermore, a number of Fire and Rescue Service personnel have completed Instructor courses in order that they in turn can instruct and direct delivery of training sessions / courses. Personnel also require appropriate refresher training in all of the above throughout their careers, generally delivered either through on-station training or through specific refresher courses.

Training has traditionally been delivered at varying levels (e.g. local station, fire authority, region, national and international) and through a variety of arrangements.




Firefighter specific awareness training for the LIFTS within Fennor Hill Care Facility was organised and offered by the premises owners for Urlingford Fire Brigade.

This awareness session provided practical training on the knowledge and skills that are required to enable firefighters to safely work on lifts.

A transportation incident training course was held in Castlecomer Fire Station., The aim of this 5-day course is to equip the learner with the relevant knowledge, skill and competence to effectively and safely operate at a transportation incident, as a member of a fire service team, cognisant of one's own safety, the safety of their team and the public. This course provides practical training on the knowledge and skills that are required to enable recruit firefighters to safely work at transportation incidents, within the incident command structure and procedural norms. # LIBRARY



### Opening of Mayfair Library

On April 24<sup>th</sup> Kilkenny County Council Library Service were delighted to welcome Heather Humphreys TD, Minister for Rural and Community Development to officially open our brand-new Mayfair Library. This 1,800 m<sup>2</sup> state of the art library offers a wide variety of opportunities for all ages and will provide significant cultural, community and educational opportunities for the local community.

Services in this bright and spacious building include community exhibition space, a meeting room, study spaces, young adult area, dedicated children’s area, a makerspace with access to 3D printers, sewing machines and more comfortable spaces to sit and browse, WiFi and PC access and printing, scanning and photocopying facilities.

The Mayfair Library will be accessible to the public Monday-Saturday including two late evenings on Tuesdays and Thursdays. This fantastic new facility has already been well used by the public with over 4,500 visits during the first week alone.



### Funding Announced for New Mobile Library Vehicle

During her visit, Minister Humphreys also announced an investment of €180,000 to go towards the acquisition of a next generation mobile library vehicle for Library Service. Our mobile library service currently serves over 60 schools, creches, nursing homes and community stops across the City and County on a monthly basis making this a very welcome announcement.





### Spring into Storytime 2024

This April, Libraries welcomed back Spring into Storytime. This annual literacy programme is a key strand of the Right to Read framework and is designed to encourage young children to develop a love for reading and storytelling. This year, we held 32 events with 531 participants.



### Alignment with the Sustainable Development Goals


Here are 2 ways in which Kilkenny County Council Library Service helped to further the United Nations Sustainable Development Goals in March:

## Finance Update

The bank overdraft facility was not utilised during the four-month period to the end of April 2024. The draft unaudited financial statements for 2023 were finalised and presented to Council at the March meeting. The Local Government Auditor has commenced the audit for 2023.

The annual rate invoices for 2024 were sent to all rate payers in mid February. In previous years, Commercial Rates were payable in two moieties, with the first 50% (*plus any arrears due*) being due on issue of the demand and the second 50% falling due on the 1<sup>st</sup> of July. Commercial Rates are now payable in full on receipt of the rate invoice.

## Rates Revaluation

Further to Revaluation 2017, 197 customers with a total rate demand value of €4.5m appealed their new valuation to the Valuation Tribunal. To date 192 appeals have been completed. The following is a breakdown of the appeal outcomes to date:

Decrease in Revaluation on Appeal .....	149 cases
Appeal Withdrawn .....	33 cases
Increase in Revaluation on Appeal.....	1 case
No change to Revaluation on Appeal .....	9 cases
Appeals Outstanding.....	5 cases

The total annual Income lost to date stands at €853k.

## Commercial Rates Vacancy

The commercial rates vacancy is 50% for 2024 as agreed at the Annual Budget Meeting. A 50% vacancy strike off will be applied to eligible commercial rate accounts for 2023 where the customer formally applies, provides proof of vacancy and clears any outstanding rate arrears, where applicable.

## Increased Cost of Business (ICOB) Grant Scheme

As part of Budget 2024, the Government signed off on a package of €257m for the Increased Cost of Business (ICOB) Grant as a vital measure for small and medium Enterprises. This rollout will be managed through the local authorities and funded by the Department of Enterprise, Trade and Employment (DETE). Eligible businesses will receive a once-off grant which will be based on the value of their Commercial Rates bill in 2023.

The milestones and timelines are as follows:

- Social Media Communications in relation to ICOB occurred in late February/early March.
- A letter detailing how to apply for the grant was sent to ratepayers in the week starting 12<sup>th</sup> March.
- Social media communications were ongoing up to the closing date.

The closing date for applications was 1<sup>st</sup> May 2024
