#### **ROADS**

#### **MAJOR PROJECTS**

#### N24 Waterford to Cahir Scheme

Date for Publication of the Option Selection Report is due by Q4 2024.

#### **MINOR PROJECTS**

#### N77 Ballyragget to Ballynaslee

Construction of the scheme commenced on Tuesday 6<sup>th</sup> February 2024 with an expected 12-month time frame. Works are progressing well and are on schedule.



#### **N24 Carrick Road**

Kilkenny Council has received formal notification that An Bord Pleanála has approved the 177AE planning application subject to conditions and has confirmed the CPO without modifications as of the 20th March 2024. An application for a Judicial review of the decision by An Bord Pleanala was lodged with the High Court by 3 no applicants in May 2024. Based on current information available the timeline for the Judicial Review process will extend into 2025.

#### **PAVEMENT SCHEMES**

#### N76 Callan Bypass Pavement Scheme and associated works

TII have advised that it is order to complete the design process and to proceed to tender.


#### **CAPITAL & URDF PROJECTS**

#### South North Access Road - Ferrybank

The closing date for submissions on the Part 8 application was the  $24^{th}$  October. The submissions are currently being reviewed and the final Part 8 report prepared.

The scheme is c.940m in length with


- Two signalised crossroad juntions,
- Segregated pedestrian/cycle facilities,
- Two zebra crossings
- Off-line bus stops
- Greenway car park (c.172 parking bays);
- Link to Greenway; and
- Accommodation works



#### Sustainable Links -Ferrybank

Consultants are appointed for the sustainable links, Ferrybank scheme for all stages of works (Design, Part 8, tendering for construction, Resident Engineer and handover).

The works will include traffic calming and active travel measures over c.3km of road on Belmont Road and Abbey Road.



#### N29 Belview Port Road

Consultants are appointed for the N29 Belview Port scheme for Design, Part 8 and tendering for construction.

This includes Traffic calming measures along c.900m of the N29 and junction improvements from the L3412 junction to the IDA business park south to the port access. It is intended that this will allow the reduction of the speed limit to permit access for developments onto the N29.



#### **CBS School**

Works on the road accessing the CBS are continuing along Talbots Court/Talbots Gate as per the Part 8 Loughmacask Link Road Phase 1(a).


The closure between the two estates will reduce the project timeline and see the majority of civil works between Talbots Gate and the school completed before the year end 2024.



#### Kilkenny City North Transport Project

A full package of Gateway 1 appraisal documents was submitted to the Department of Transport at the beginning of August 2024. This was submitted following consultation with the Department on the necessary documents for the submission.

A breakdown of project costs for years 2024-2027 was submitted to the department for the required funding allocation to progress the project.




#### **R7 & R5 Traffic Modelling**

The Department of Transport provided a specific improvement grant in 2024 for Kilkenny City traffic analysis (*Butts Green junctions*).

The grant was used to appoint Consultants to conduct traffic modeling assessment of the R7 (Kilmanagh Road to CBS school) and the R5 (Kilmanagh Road to Dean Street).


The findings of the assessment will be presented by the Consultants in November 2024.



#### Lousybush Lane link to CBS

Consultants are appointed for the Part 8 Lousybush Access Road Scheme for Detail Design and tendering for construction.

The scheme will link the houses to the northern extents of Lousybush Lane to the CBS link road which will in turn allow the existing Lousybush lane to be repurposed as a shared use facility for cyclists and pedestrians as per the Loughmacask masterplan.

#### FORWARD PLANNING

#### Variation 2 to the City & County Development Plan 2021

Variation 2 to the City & County Development Plan, Small Towns and Villages, was adopted at the Council meeting on the 21st October. The adopted Variation is now available on the Council's website.

#### Variation 3 to the City & County Development Plan 2021

This Variation seeks to rezone a small portion of green space in Loughboy to residential, for the purpose of a small number of Age Friendly and Disability Accessible houses. Work on this variation has commenced with the necessary environmental bodies, adjoining Local Authorities and the OPR being notified of this proposed Variation. It is estimated that the Variation will be placed on public display in the first week of December 2024.

#### **MASTERPLANS**

#### Ballyragget/Paulstown/Kilmacow

The Paulstown Masterplan was adopted at the Castlecomer Municipal District Meeting in September. A Director of Services Report on the submissions to the Ballyragget Masterplan was presented to the Castlecomer Municipal District Elected Members at their October meeting and approval of the Plan will be sought at their November meeting.

The Kilmacow Masterplan was adopted by the Piltown Municipal District Elected Members at their November Meeting.

Once all Masterplans are finalised, major objectives from all above Plans as well as the Urlingford Masterplan will be put forward as a Variation to the Kilkenny City and County Development Plan 2021 – 2027, in Q1 of 2025.

#### LOCAL AREA PLANS

#### Ferrybank / Belview Local Area Plan

A draft Local Area Plan document was received from the consultants appointed to carry out the Plan and this has been assessed and returned for further amendments. It is estimated that a Draft Plan will be published in late November 2024.

#### **Castlecomer Plan Review Process**

The Plan preparation process continues, with ongoing collaboration between the Community and Planning Sections in the production of the Castlecomer Health Check, to be published shortly. This will outline the baseline information for the Plan. The Draft Settlement Plan will be accompanied by various assessments, including an Infrastructural Assessment and Environmental Assessments. An excellent response was received to the pre-draft stage, with 17 submissions, and 123 responses to the survey. The Report on the pre-draft consultation process is also now being prepared.

#### Cluster Housing Design Guidelines for Co. Kilkenny

Consultants, Place +Urbanism Ltd, were appointed in February to carry out Cluster Housing Design Guidelines for County Kilkenny. The process initially involved several weeks of gathering data, site inspection and review and a pre-draft document presented to the planners and road engineers for discussion, with an associated workshop held in September. Further work is required following initial concepts on addressing the challenges facing all settlements within the County. A further workshop will be held late November along with staff from the Councils Roads section, Area Engineers and Environment section to further discuss the document and its concepts, with a view to progressing to a draft document for discussion in Q1 2025.

#### Taking in Charge

#### **Active Land Management**

There are 18 Vacant Sites on the Vacant Sites Register, and the number of cancelled entries due to site activation or improvement is 29. The Vacant Site levy (VSL) will be replaced by the RZLT from 2025, but any outstanding VSL's will remain due to the Council. For 2024 to date, a total of €142,200 has been received in levies, bringing the total income from developers to €667,200. The CPO of Vacant Site Ref. VSR21-7, on Father Hayden Road by the Council, is progressing.

A Draft Annual Map of lands in scope for the new Residential Zoned Land Tax (RZLT) was published on the 31st January 2024. The settlements currently liable are Kilkenny City, Rosbercon, Callan and Thomastown. Submissions were received, and determinations on these submissions were notified to the landowners. Four landowner made appeals to An Bord Pleanála, and all 4 appeals have now been determined, upholding the Council's determinations. The recent Budget announced a further opportunity for farmers to seek to have their land rezoned.

#### Conservation

The Conservation Office manages all protected structures in Kilkenny County and City. These structures are recognised for the following special interest:

- Architectural,
- Historical,
- Archaeological,
- Artistic

- Cultural,
- Scientific,
- Technical, Social.

An advisory service on conservation matters is provided to the public and colleagues, while the conservation grants and funding applications are also delivered.

#### **Built Heritage Investment Scheme 2024:**

Conservation grant funded projects are completed. Final inspections are underway by the Conservation Officer.

#### **Historic Structures Fund 2024:**

Conservation grant funded projects are completed. Final inspections are underway by the Conservation Officer.

#### **Architectural Conservation Area Trails 2024:**

On site meetings with local communities in Freshford and Castlecomer have taken place. A number of community and school workshops were completed in September.

#### **Built Heritage Stocktake 2024:**

A local conservation accredited consultant has been appointed to deliver a stocktake for the following settlements: Callan, Gowran, Inistioge, Johnstown, Thomastown. The stocktake will focus on the structures listed on the RPS and NIAH.

#### **ENVIRONMENTAL AWARENESS**

#### Anti-Litter and Anti-Graffiti Fund

This grant scheme helps community groups to carry out anti-litter and anti-graffiti awareness campaigns in their local area. It has a particular focus on voluntary initiatives, and on involving schools and young people in anti-litter and anti-graffiti activities.

- Examples of the kinds of initiatives supported by the grant scheme can include:
- Providing anti-littering campaign materials, like anti-litter posters and stickers
- Organising poster design competitions
- Arranging interactive talks or plays involving schools and young people in anti-litter activities
- Encouraging responsible dog owners to clean up after their pet in public places.

€28,550 in grant aid and programme costs was allocated under the Anti-Litter and Anti-Graffiti scheme for 2024. This included 4 community led murals in Graiguenamanagh, Mooncoin, The Butts and Stoneyford.





#### Team Up to Clean Up-Together for Kilkenny

The commencement of a Roadside Litter campaign as part of the "Team Up to Clean Up-Together for Kilkenny" brand will commence the week commencing the **25**<sup>th</sup> **November**. This is a targeted campaign to help eliminate roadside litter at source.

Many of our local and regional roads are heavily littered and are far too dangerous to litter pick with its heavy traffic volumes, dangerous bends and the absence of a hard shoulder. Like many other roads around the County, roadside litter is accumulating.

#### **Anti-Dumping Initiative 2024**

As part of the Anti-Dumping Initiative, Kilkenny County Council funded the development of a mural in Francis McManus Square which has become a blackspot for rubbish and dumping in recent years. The project was co-led by Keep Kilkenny Beautiful and Ossory Youth and is demonstrative of what can be achieve by good will, teamwork and environmental stewardship.





#### Savour Kilkenny Food Festival-Waste Baseline and Characterisation

Savour Kilkenny has been working on sustainability measures for almost half of its 16 year history. Waste related plans for 2024 included eliminating disposable cups through 2gocup, provision of a refill water point, and demonstrating use of mygug composting.

Through the Anti Dumping Initiative 2024, the Environmental Department procured consultants to undertake waste compositional analysis and an observational assessment of the Festival with a view to creating a report of recommendations identifying key waste prevention and management goals and policies for the development of the festival and an overall strategy with an incremental approach across many actions.

#### Kilkenny Groups Excel at Tidy Towns Awards 2024

The remarkable commitment and efforts of community organizations in Kilkenny have been celebrated at this year's Tidy Towns awards. These annual accolades honour communities dedicated to enhancing their local surroundings, showcasing the remarkable contributions of various groups throughout the County.

Inistioge Tidy Towns was honoured with both a Gold Medal and 1st Place in the County Awards category, while Coan Tidy Towns secured the Endeavour Award for the biggest improvement by an entrant in each County from the previous year.

Keep Kilkenny Beautiful continued its success by retaining its Gold Medal and finishing in  $2^{nd}$  place in the County Awards.

Tullahought Tidy Towns was awarded "Highly Commended" for their work under the National Pollinator Programme during the ceremony held at Croagh Park on November 1st, 2024. Their unwavering dedication to cleanliness, improving green spaces, and promoting community pride has distinguished them in this competitive field.

This year Kilkenny had two new entrants under the National Competition with Graiguenamanagh, and Owning demonstrating their exceptional efforts and work for their respective communities. All of whom scored strongly for their first time around.

#### **Green Teams National Programme 2024**

Green Teams in public sector organisations are essential for driving sustainability initiatives, reducing resource consumption, and fostering a culture of environmental responsibility across the workplace.

Over 60 organisations have already participated in the Green Teams National Programme, designed to empower workplace environmental champions and green team members in Ireland. It includes three interactive online sessions covering sustainability, resource efficiency, green team management, and staff engagement.

Led by the EAO in conjunction with the Climate Action Team, 8 staff members of Kilkenny County Council are participating in this EPA developed programme for Q4 of 2024.

This EPA Green Enterprise scheme, equips participants with the practical knowledge and tools to make sustainable practices happen on the ground. #### **WASTE**

#### **Bring Banks Usage**

The Council provides and manages 47 Bring Centers across the City and County. A total of **1703 tonnes** of recyclables were collected from our Bring Centers to date in 2024. This represents a 1% decrease from the same period in 2023. Aldi - Kilkenny City (15 tonnes collected), Loughboy shopping centre (11 tonnes collected) Lidl - Johnswell, Kilkenny City (10 tonnes collected) and are the busiest locations in the City. Aldi - Ferrybank (11 tonnes collected), Lidl - Thomastown (7 tonnes collected) and Graiguemanagh (6 tonnes collected) are the busiest outside of the City. Environment staff are continuing to work very closely with our service providers to ensure the collection service is in keeping with demand, especially around long weekends and holiday periods.

#### **Dunmore Civic Amenity Site (CAS)**

The annual Bulk Waste week at Dunmore ran for the first week of October 2024. This is an Ant-Dumping Initiative (ADI) which sets out to encourage the public to clean up their unwanted bulk waste and furniture in the correct manner at an authorised facility. Domestic loads of any size could be disposed of at Dunmore for a set fee of €5 for the duration of the Bulk Waste week. This resulted in almost 12 tonnes of bulky fabric covered furniture and almost 38 tonnes of timer deposited at the site. The month of October also saw 114 tonnes of Municipal Solid Waste, 86 tonnes of Municipal Dry Waste and 33 tonnes of green garden waste.

The various other recycling streams deposited at the Dunmore facility during the month of October and their respective tonnages can be seen in Table 1 below.

As part of the Landfill Aftercare the landfill gas flare continues to run 24hrs per day seven days per week extracting and burning approximately 35m3 of landfill gas per hour.

#### AIR NOISE WATER

#### Water Quality - Farm Inspections

Farm inspections are still ongoing and are on track to reach 241 inspections by the end of the year.

#### **Septic tank Inspections**

The Environment office has completed 61 inspections which is 10 more than the target of 51. We will be also closing out the remaining historical open advisory notices dating back to 2013 and this process is already in motion with people contacting us hoping to have them closed out after contact was made with letters. Septic tank grant approvals are currently ongoing. Upgrade works and work approvals are being carried out with various applicants who are applying for the grant. The Environment Office are still dealing with a large volume of queries in relation to the criteria for eligibility for the grant.

#### **Section 4 Discharge Licences**

The Environment office will be closing out all 25 section 4 discharge licenses in Q4.

#### Misconnections

The Council is currently in the process of investigating a serious misconnection in Thomastown. Investigation has been completed through review of cameras at local businesses. Review identified a truck pouring waste water into a manhole which is discharging into a river. The license plate of the truck has not yet been identified and more investigation will be required. Samples were taken and tested from the river showing very poor results.

#### **Environment Complaints**


All Environmental complaints received are logged on the CRM (Customer Relations Management) System. The number of complaints that have been received and logged for October 2024 is 85 compared to 82 for the same period last year. The number of complaints received in the ten months to the end of October 2024 is up 8% when compared to the same ten-month period in 2023. The nature of these complaints included littering, illegal dumping, burning of waste and abandoned cars. The majority continue to be related to littering and illegal dumping. Whilst every effort is made to bring unacceptable environmental practice into compliance, Environment Enforcement staff continue to manage significant enforcement cases progressing through prosecution cases.

#### Noise

Kilkenny County Council with support of Noise Consultants Limited have completed the draft Noise Action Plan 2024-2028. The *draft* Noise Action Plan is aimed at strategic long-term management of environmental noise from major roads. It does not apply to noise from domestic activities, neighbourhood noise, noise at workplaces or noise inside means of transport or due to military activities in military areas.

The plan is now at the public consultation stage between 30<sup>th</sup> October and 11<sup>th</sup> of November 2024 with submissions being accepted until 25<sup>th</sup> November 2024. The final plan is on target to be submitted to the EPA in December 2024.

During the month of November 2 submissions have been received. These will be reviewed and closed out appropriately following discussions with the noise consultant



## **PARKS & SPECIAL PROJECTS**

#### **South East Greenway**

Works are progressing well on Lot 5A of the Greenway, the surfacing works along this 5.5km section, from Ferrybank to Curraghmore, are now substantially completed. Fencing works and the installation of the timber screen fencing along Lot 2, Ferrybank, are also substantially completed. Works at the permanent greenway carpark at Ballyverneen, Glenmore, are also expected to be concluded this month thereafter a safety audit will be undertaken prior to the full opening of the 39 bay carpark. The programme remains on track for the works contract to be completed by the end of the year, thereafter, this section of Greenway will be subject to a safety audit and minor finishing out works to facilitate the opening of same to the public in Q1 2025.





The installation of the public lights within Lots 1 & 3, Roberson to Raheen, is programmed for mid-November and to facilitate these works this section of the Greenway will be closed to the public from Monday 11<sup>th</sup> to 15<sup>th</sup> November from 8.00 a.m. to 5.00 p.m. and from Monday the 18<sup>th</sup> to 20<sup>th</sup> November from 8.00 a.m. to 5.00 p.m.

Topographical survey works were also recently completed on Lot 4a Redbridge & Mountelliott, Lot 7 Aylwardstown and Lot 8a Rosbercon trailhead carpark.

A survey carried out on Phase One, the 6km opened section from Rosbercon to Glenmore, found that 41,260 trips were undertaken on the Greenway for the 12 month period from September 2023 to August 2024. This data is very encouraging and bodes well for the future Greenway when the full 24km scheme is opened to public and the associated marketing and promotion campaign is activated for same. #### Woodstock to South East Greenway Link

Following the preparation and submission of the Phase 0 Project Outline Document (POD), the Council has received formal approval from Transport Infrastructure Ireland (TII), to progress to Phase 1, Concept and Feasibility stage for the above scheme. This phase, which is programmed to take 3 to 4 months will develop and investigate in further detail the feasibility of the project and implement the project management structure. A Project Execution Plan (PEP) and a Feasibility Report will be produced at the end of this phase and presented to TII for approval to advance to Phase 2 Option Selection.

#### **Outdoor Recreation Infrastructure Scheme**

The Minister for Rural and Community Development, Heather Humphreys TD, recently launched the 2024/2025 Outdoor Recreation Infrastructure Scheme. An indicative budget of €20 million is available for successful projects nationally under the Scheme. Similar to other Schemes, funding will be provided under four different categories of project Measures based on the size of the investment requirement. A list of eligible activities is detailed below:-



Under the Scheme, Local Authorities can submit a maximum of applications under the following Measures:

- 6 (max) Measure 1, value €40k per application (increased from €30k in previous years);
- 3 (max) Measure 2, maximum value €200k per application;
- 1 (max) Measure 3, maximum value €500k;
- 2 (max) Project Development, maximum value €50K.
- Under the scheme applicants are required to provide a minimum of 10% match funding of the allocated grant.

The closing date for applications is as follows:

#### **Tree Maintenance Programme**

Each year, our office receives numerous inquiries from both Elected Members and the public regarding tree maintenance. This prompts an assessment of each tree's health and condition to determine the necessary maintenance, if any. The dormant period of trees is the optimal time for such work. Currently, we are committed to tree maintenance in Inistoige, Cuffsgrange, Paulstown, Ballyragget, Kilkenny City, and Thomastown. Our tree maintenance programme commenced in earnest at the beginning of November. The works are divided into geographical lots and the tendering process to engage the services of specialist tree surgeons is ongoing.

#### Woodstock Gardens & Arboretum

Autumn has marked the commencement of our key seasonal tasks. The wildflower meadow has been cut and gathered. Extensive pruning and mulching has been carried out in the playground area, including pruning of the willow tunnel and crown lifting of trees to allow more light into the playground. The woodland arboretum is also receiving a tidy-up around the base of the trees.

Planned renovation works will take place in the walled garden over the winter months, rejuvenating the fruit bushes and espalier fruit trees. Additionally, extensive weeding and mulching of the herbaceous border will ensure it looks its best for the coming year.

Season tickets for the 2025 season, costing just €50 for 12 months access, will be promoted as ideal Christmas gifts over the coming weeks.



#### Historic Structures Fund -Woodstock House

Works are continuing to secure the rear elevation of the house, fronting onto the Winter Garden, which entails the stabilisation of the window opes with steel frames and tie bars, as required. This work is programmed to be completed mid-November, but is weather dependant. The next phase provides for tree surgeons to recommence with the clearance of trees inside the house, which can now be accessed from the scaffolding, a mature beach tree adjacent to the house will also be removed. These works are in addition to the clearance of sapling trees and extensive vegetation to the rear of the house carried out earlier in the year.





#### Playgrounds



Ongoing maintenance continues around the County in our playgrounds and parks to maintain them to a high standard. This month, in our playgrounds, the focus was on the replacement of old or worn parts of play equipment and the re-mulching of soft play areas. In Ferrybank Neighbourhood Park footpath rehabilitation works were completed. In Goresbridge works were undertaken to redefine the walking trail which compliments the painting of the play equipment which was carried out earlier this year.

Key enhancements between now and the end of the year include the installation of a new accessible roundabout, associated pathways and a communication panel in both Graiguenamanagh and Thomastown playgrounds. In the latter safety surfacing and 2 rockers will also be installation.

In Coon playground, a new accessible roundabout and communication panel will be installed while in Castlecomer playground a new multi-use play-unit, communication panel and safety surfacing will be provided.

The above works, allows for the removal of old equipment that is no longer fit for purpose and will see an investment of circa. €127,000 in these four playgrounds this year over and above general maintenance works.

The Directorate of Housing incorporates a wide range of services for applicants and tenants to facilitate and support the provision of independent and supported accommodation. The following information gives the up to date progress for 2024 under the various support services.

#### AFFORDABLE HOMES

Kilkenny County Council continue to work in partnership with developers Whitebox, Cairn Homes & Glenveagh in delivering Affordable Homes across Kilkenny City and Ferrybank.

There are a limited number of homes available in all 3 developments. Under the Affordable Purchase Scheme successful applicants will be able to avail of a reduction on the full market price, of between up to 20% & 25%, depending on the price of the property and the applicant's own financial circumstances.

The Affordable Homes are generally targeted at first-time buyers (exceptions apply) who need assistance bridging the gap between their own available funds (including the Help to Buy Scheme), the mortgage that they can obtain and the cost of the new home. Under the Affordable Purchase Scheme eligible buyers will be able to purchase their own new home by availing of this shared equity scheme. Kilkenny County Council will retain an equity share and successful applicants have the option of buying out this share over time. Equity shares are calculated on an individual basis and are linked to an applicant's income, their savings and their mortgage capacity.

It is important that potential applicants familiarise themselves with the eligibility criteria and compile the requisite documents to complete their applications subject to them meeting the qualifying criteria. It is strongly recommended applicants have Mortgage Approval in principle prior to applying for this scheme, as applicants will be required to demonstrate their capacity to purchase. Only valid applications (i.e. applications with all required documentation submitted) will go forward for assessment. Applications which are incomplete or those not accompanied by the required documentation will be deemed invalid.

#### **HOMELESS SERVICES**

#### **Homeless Prevention Measures**

The Government have put in place a number of measures to prevent homelessness arising from the reactivation of notices of termination of tenancies in June 2023.

We are currently providing advice and directing Tenants to the appropriate services required to prevent homelessness. #### HOUSING LOANS

The Tenant (*Incremental*) Purchase Scheme 2016, which allows local authority tenants to buy their homes is being revised as of from 29th January, 2024. Changes to the scheme are as follows:

- Minimum Income Requirements: The minimum income required for an applicant to be eligible to apply under the scheme has been revised from €12,500 to €11,000 per annum. (At least 50% of which must come from a reckonable primary source of income).
- Primary Sources of Income: In addition to employment and the State Pension (Contributory and Non-Contributory) being considered as primary sources of income, the Widow's, Widower's, Surviving Civil Partner's (Contributory and Non-Contributory Pension), Blind Pension, Invalidity Pension and Disability Allowance are now also considered primary sources of income.
- *Time Receiving Social Housing Supports:* The period of time tenants will be required to be in receipt of social housing support to be considered eligible under the scheme remains at 10 consecutive years. However, in the case of joint tenancies only one tenant is now required to have been in receipt of social housing supports for 10 years.
- Income Included/Not Included as a Secondary Income For Assessment: Changes have been made to income that can be considered and not considered as secondary income when assessing for discount.

#### Age Friendly

Kilkenny County Council Age Friendly Programme, The Older People's Council, Kilkenny Recreation and Sports Partnership, HSE, An Garda and Kilkenny Library Service teamed up to develop a programme of events and activities. These events were free of charge and ran for 8 weeks fromn Friday, 6th September, 2024 until Friday, 1st November, 2024. Located in the new Mayfair Library, the events provided an opportunity for older people to receive useful information as well as providing the opportunity to chat and meet with people.

The events had very positive feedback with up to 70 people attending each week. The programme topics included Ageing Well in the Community, Dementia Awareness, Physical Activity for older people, Age Friendly Strategy Consultation, Age Friendly Healthy Homes presentation, Assisted Decision Making and Safeguarding, Minding Your Wellbeing Self Care workshop and Community Safety Talk.

Kilkenny County Council are currently developing a new Age Friendly Strategy. The new strategy aims to build on the progress of the Age Friendly Programme in recent years and to continue to make Kilkenny a more inclusive and age friendly place to live and visit. Community Consultations have taken place across the County in Thomastown, Castlecomer, Mullinavat, and in Kilkenny City. There was good attendance and engagement at each of the consultations contributing to the new strategy.

### **INTEGRATION**

The Local Authority Integration Team (LAIT) provides on-going integration supports to people categorised in any of the following groups living in the City and County of Kilkenny.

- International Protection (IP) Applicants,
- Programme Refugees,
- Beneficiaries of Temporary Protection (BOTP),
- Those with Refugee, Subsidiary Protection, or Permission to Remain status.

The LAIT's aim to link people in any of these groups with local service providers appropriate to the need of the person. We act as the direct point of contact to advocate, provide information, guidance and advice to queries, as they arise.

Currently, there are 177 International Protection Applicants (164 Male, 12 female and 1 baby girl), and 693 BOTP's in County Kilkenny. 65% IP's and 45% BOTP's are employed.

In October, the LAITs have worked with 48 International Protection Applicants, with 119 queries across health access; education including English language; traineeships; employment access; DSP supports; community engagement; bank account setup; independent living; youth support; transport; accommodation; legal/immigration.

Two group sessions, were held, with 27 attendees, covering topics on IPAS house rules and new residents connecting with partner organisations – KLP and KCETB.

We, also, worked with 49 BOTPs across 20 individual meetings and 2 group sessions addressing queries/topics such as health access; education; employment; DSP; independent living; evictions; legal/immigration, road safety and resettlement.

#### FIRE SERVICES

#### Fire Safety Certificate Applications

81 applications for Fire Safety Certificates were received to date.

- A Fire Safety Certificate is a Certificate issued by the Building Control Authority which states that the works or building to which the application relates will, if constructed in accordance with the plans and specifications submitted, comply with the requirements of Part B of the Second Schedule to the Building Regulations 1997.
- A large number of risk premises throughout Kilkenny City and County have been subject to review and fire safety certification applications to ensure minimum standards.

#### Fire Services Acts 1981 and 2003

- Fire Prevention staff made targeted inspections of premises both to provide advice and to enforce legislation during 2023.
- 58 Licence Applications were processed under Section 24 of the Fire Services Acts 1981 and 2003.
- 7 licence applications under the Dangerous Substances legislation were assessed to date.
- 91 Fire Safety Inspections of premises have taken place in 2024.

#### **Fire Brigade Operations**

The existence of a professional Fire & Rescue Service is fundamental to public and personal safety. The Fire Service plays a crucial role in making our communities safer, whether it be preventing and protecting people from fire and other risks or responding swiftly and effectively to the incidents and emergencies that occur 24 hours per day/7 days per week/365 days per year. The Brigades have attended 862 callouts to date in 2024. These incidents included a number of road traffic collisions, house fires, ambulance assists, car fires, chimney fires and automatic fire alarm activations. We received 6 calls on Halloween night and only one of those callouts were Halloween related.

#### **Recruitment of Retained Firefighters**

Our second in 2024 recruitment campaign has commenced to recruit Firefighters in Castlecomer, Freshford, Urlingford, Thomastown and Graiguenamanagh. Applications have been received and we are in the process of shortlisting. All new recruits will undergo extensive initial training to equip them with the skills to be a Retained Firefighter. As well as responding to emergency calls and undertaking community fire safety initiatives, Retained Firefighters attend weekly training nights to maintain competency levels and undertake routine checks on their equipment. Freshford and Callan have held an open night/day in their fire stations.

Retained Firefighters are men and women who are on call to respond to a range of emergencies. Many Retained Firefighters have other full or part-time jobs but when the call comes they are ready to drop whatever they are doing and become part of a team, ready to face any emergency. Although part-time, Retained Firefighters are fully trained and capable of saving life and property.

#### Fire Appliances

Kilkenny County Council's Fire and Rescue Service maintain fire appliances in all seven Fire Stations throughout the County.

Kilkenny County Council Fire & Rescue Service have a Command and Control vehicle, 2 seater electrical fire vehicle and a Class B fire engine being built at present. We will continue with a Replacement Programme and Refurbishment Programme as capital funding is made available.

#### **Community Fire Safety Programme**

Kilkenny Fire & Rescue Service continue to deliver the National Directorate Fire & Emergency Management Primary Schools Programme. It is targeted at all Third Class Primary School children. The Fire Authority has delivered this Programme from inception in 2006 and every year subsequently (except during the recent pandemic). Over 20,000 pupils have participated in the Primary School's Programme to date.

The Fire Authority has provided training and refresher training for a number of Firefighters in each brigade to assist them to deliver this Programme to all school children in Third Classes in Kilkenny City and County where the school management accept our invitation to visit their schools.

#### **Training**

Kilkenny County Council's Fire & Rescue Service are obliged under the Fire Services Acts 1981 and 2003 and the Safety, Health and Welfare at Work Act 2005 to ensure that our Firefighters and Officers are adequately trained and competent to deal with tasks and varying roles they may encounter in the performance of their duties.

All personnel responding to Fire & Rescue Service incidents require a minimum level of training to meet core requirements. In addition, many personnel also require further training for specialist or supervisory roles. Furthermore, a number of Fire and Rescue Service personnel have completed Instructor Courses in order that they in turn can instruct and direct delivery of training sessions/courses. Personnel also require appropriate refresher training in all of the above throughout their careers, generally delivered either through on-station training or through specific refresher courses.

Training has traditionally been delivered at varying levels (e.g. Local Station, Fire Authority, Region, National and International) and through a variety of arrangements.

A Compressed Air Foam System course was held in Castlecomer Fire Station. Instructors on the course are in-house. This course provides practical training on the knowledge and skills that are required to enable firefighters to safely operate a compressed air foam system on a fire engine.



We delivered Emergency Services Driving refresher courses to a number of our drivers. We also carried out Emergency Traffic Management training to 18 Firefighters.





6 Firefighters recently completed a two week Breathing Apparatus Course (QQI) in Hackettstown Fire Station. This course provides practical training on the knowledge and skills that are required to enable recruit firefighters to safely work as BA wearers at operational incidents, within the incident command structure and BA procedural norms.





Two Firefighters are attending a three week Firefighting skills course in Bandon Co. Cork. We have also commenced training in Water Awareness. This course is being held in Graiguenamanagh Fire Station.

This course provides practical training on the knowledge and skills that are required to enable firefighters to work safely and effectively on the fireground.



#### LIBRARY



#### **Bookville 2024**

The 8th Annual Bookville Festival took place from 10th to 16th October with over 70 events taking place to celebrate all aspects of storytelling including creative writing, history, comedy, music, illustration, Gaeilge, drama, music, storytelling and poetry. The programme featured 27 of the best children's authors and illustrators from across Ireland and the UK including Chris Haughton, Robin Stevens and Leona Forde with 3,596 people in attendance. There was a range of opportunities to engage with Bookville including events specifically aimed at schools and family resource centres, public events, virtual events, "The Adventures of Pinocchio" Bookville exhibition and our everpopular Bookville activity book which was delivered to every primary school in the County.







#### Kilkenny's Toil & Trouble Schools Activities Packs

On 23rd October, Kilkenny County Council Library Service were delighted to launch our "Kilkenny's Toil & Trouble" schools activities packs. The activity book, designed for 5 to12 year olds, was delivered to over 13,000 primary school children around the County in time for Halloween and includes information, activity sheets, crosswords, word searches, a witch wreath craft, fact sheets, puzzles and lots of other fun activities suitable for primary school children. This pack was developed by staff working in the Local Studies Department and was funded by Kilkenny County Council. A limited number of copies are available in our library branches and it can also be borrowed as an eBook on BorrowBox.



#### Fadó Fadó - Sparking Memories

Kilkenny County Council Library Service (in collaboration with Kilkenny Archaeological Society and Rothe House Trust) were delighted to launch "Fadó Fadó - Sparking Memories - Kilkenny Young Researchers Primary School Competition" in the Mayfair Library on October 16<sup>th</sup>. This competition invites students to become young researchers as they dig deep into history to learn more about their local heritage. Topics can range from an old building or ruin to local folk tales and stories, presenting an ideal opportunity for teachers to complement the history curriculum.

The winners will each receive a €100 Voucher and a perpetual trophy while the class of the winning entrant will enjoy an educational visitor experience at Rothe House and Gardens. Winning entries will be displayed in their local library and will be digitised for online viewing on the <u>Kilkenny Library Digital Archive</u>.

#### Mayfair Library Hits 100,000 Visits

In October the Mayfair Library hit an exciting milestone with over 100,000 visitors entering the doors since its opening in April. They have also registered over 6,500 members and loaned over 54,000 items. It continues to be an extremely popular service point with many events, workshops and meetings taking place every week, a number of exhibitions held and members of the public availing of the PCs, study spaces, WiFi and printing and photocopying services.



#### **Online Services Usage**





Library staff prepared, recorded, edited and published **265** posts and videos on our social media platforms in October. Our engagements for the month were **11,211** and our videos and reels had **3,747** views. Our virtual newsletter was sent to **7,643** email accounts.

#### Alignment with the Sustainable Development Goals

Here are 2 ways in which Kilkenny County Council Library Service helped to further the United Nations Sustainable Development Goals in October:

#### SDG 12: Responsible consumption and production

The Mayfair Library held a "Get the Most out of your Pumpkin" workshop with Denise Walsh to teach attendees how to get the best out of pumpkin flesh and seeds after Halloween was over.

#### SDG 11: Sustainable cities and communities

Local historian Fin Dwyer held a number of workshops in our library branches to commemorate and teach primary school children about a pivotal event in our City's history – the witch trial of Alice Kyteler.

#### **ARTS**

#### Community Climate Action - Repair to Care

On International Repair Day, 19<sup>th</sup> October, 2024 the Arts Office hosted an exciting and hands-on Textile and Clothing Mending and Repair Day. This fun and interactive event was all about inspiring positive changes that benefit both ourselves and the planet. The Arts Office explored the world of repair, reuse, and creativity, while learning how our everyday choices can help tackle climate change. The day was a rich and rewarding one on so many levels and the best way to illustrate its success is through some of the wonderful feedback received.

#### **Artists Professional Development - Performing Arts**

The Arts Office have forged a new partnership with the Irish Theatre Institute by way of a bursary which will support a local theatre-maker to join their 'Six in the Attic' Professional Development Programme. This year long programme provides playwrights and theatre makers with the space and resources to develop their practice and build a community of peers.

#### **Public Art**

Kilkenny County Council have embarked on a new phase in its Public Art Programme and put a call out for a series of commissions to commence in 2024 / 2025. The focus of these commissions will be on collaborations with communities in County Kilkenny. There were five artist-led projects sought which should seek to challenge, engage and innovate, through meaningful dialogue, research and engagement with communities. Kilkenny County Council accepted proposals from any recognised art form, from individuals or teams, who seek to devise and complete new work, developed in a collaborative setting. The response to the brief was very strong with eighty-four applications received from Ireland, the USA, Poland and the UK.

#### The Adventures of Pinocchio Exhibition

The Adventures of Pinocchio Exhibition presented the beauty and artistry found in a collection of illustrated editions of Pinocchio. The exhibition ran from 12<sup>th</sup> to 25<sup>th</sup> October in the Mayfair Library receiving 1,217 visitors made up of school's groups, their teachers and the general public. Each morning, schools availed of a guided tour and activity sheet with the opportunity to spend time in the interactive areas where they explored shadow puppetry in the belly of the whale as well as hosting their own marionette puppet show.

#### **Bookville Festival**

The Bookville Festival, funded by Creative Ireland and Kilkenny County Council had a total audience engagement of 22, 400 people. There were 13,000 books distributed to every primary school child in count Kilkenny, developing widespread awareness of Bookville. There were 66 live workshops held in the 8 County Kilkenny Library Branches and Family Resource Centres introducing children to their local library and exposure to authors and illustrators with an attendance of 1590 participants at the workshops. There were 5 virtual workshops held to increase accessibility and allow for unlimited audiences with total of 2,200 participants. Family Shows included comedy and theatre shows making the festival accessible to families with an audience of 200 people. The festival included online videos for increasing diversity. There was an Irish Sign Language video, Ukrainian Culture video and a video for children on the autism spectrum.

#### **Rhyme Rag**

Jessica Traynor and Anna Jordan delivered workshops in Colaiste Abhainn Rí and Loreto Secondary School. Poems have been submitted to the Rhyme Rag editor Seamus Cashman and selected poems will soon be published on the Rhyme Rag Instagram and website.

#### School Bus Subsidy 2024


A school bus subsidy was awarded to 12 primary schools to assist in attending the Barnstorm Theatre production 'The Play'. The subsidy supported a total of 874 children to attend.

#### **Your Voice Matters Programme: Positive Intelligence for Writers**

Creative writing coach and Your Voice Matters coordinator Anne Tannam facilitated a workshop on 'Positive Intelligence for Writers' on 30<sup>th</sup> October 2024 at St. Canice's Neighbourhood Hall. The workshop taught participants the foundations of Positive Intelligence and how to counteract self-sabotaging beliefs around their work. A total of 14 writers attended the workshop.

#### Creative Ireland Visit

The Creative Kilkenny team made up of Council staff from various departments hosted a visit from Creative Ireland and an external evaluator as part of a longitudinal study extending until 2026. The Creative Kilkenny Team presented comprehensive case studies that demonstrated the significant impact of the funding across various departments. The evaluation highlighted the evident deep and integrated connection within the broader team.

#### **Living Artfully**

Creative Health and Wellbeing project 'Living Artfully' is actively engaging groups across Carlow and Kilkenny. The work encompasses initial supports for artists including ongoing reflective practice, team meetings, outreach, weekly check ins and online specific training. Groups targeting service users include:

- Memory Clinics for Early Onset Dementia in Carlow and Kilkenny
- Involvement Centres in Carlow and Kilkenny
- Cois Nore Cancer Service
- KLP Migrant Group
- Forward Steps in Carlow working with 3 traveller groups including young men, women and middle-aged
- Delta Centre Group in Carlow
- Targeted community group at St. Canice's Neighbourhood Hall.

#### **HERITAGE**

#### Kilkenny Heritage Forum

The first meeting of the new Kilkenny Heritage Forum was held at the Pembroke Hotel, Kilkenny on 25<sup>th</sup> October 2024. The Heritage Forum is a non-statutory advisory group established by Kilkenny County Council to provide advice on the preparation, implementation and evaluation of the next County Heritage Plan. Membership of the Heritage Forum is drawn from representatives of bodies and groups with an interest in, or responsibility for, the care and protection of heritage in Kilkenny. The meeting marked the start of the process to develop a new County Heritage Strategy which will set out the overall vision and goals for the management and protection of natural, built and cultural heritage in the County.

At the end of our meeting, the Heritage Office were delighted to welcome Malcolm Noonan, Minister of State for Nature, Heritage & Electoral Reform; Virginia Teehan, CEO of the Heritage Council; Coilín O Reilly, Chair of the CCMA Rural Development, Community, Culture and Heritage (RCCH) Committee; and Tim Butler, Director of Service to announce that almost €1m in funding is being made available in 2025 for the recruitment of new heritage professionals in local authorities aimed at strengthening the protection of heritage assets across the country. This will include an Archivist for Kilkenny County Council.

#### Kilkenny Witch Trials Anniversary featured in The Walled Town Crier

Kilkenny's Toil and Trouble Festival was featured in the October edition of *The Walled Town Crier*, the publication of the Heritage Council's Irish Walled Towns Network. The ezine, which is circulated nationally and internationally features details of Kilkenny's newest festival and a short synopsis of the story of the Kilkenny Witch Trials, 1324. #### Phase 2 of the County Kilkenny Holy Wells Survey and Mass Path Survey Complete

Phase 2 of the Kilkenny Holy Wells and Mass Paths surveys is now complete. The survey of Kilkenny's holy wells was carried out by Shanarc Archaeology Ltd. for the Heritage Office. The survey provides a comprehensive report and map detailing all of the holy wells in the County, this information will enable to better protect these important heritage features in our landscape.

Phase 2 of the Kilkenny Mass Paths survey was carried out by Pat Reid, Heritage Consultant who recorded mass paths in ten parishes across the County providing us with valuable information on this previously unrecorded and valuable aspect of our cultural heritage which is highly at risk of loss. Both of these projects included four workshops across County Kilkenny training local communities in recording local heritage features. These projects were co-funded by the Heritage Council and Kilkenny County Council, under the County Heritage Plan Programme.

#### **BIODIVERSITY**

#### **Kilkenny Swift Project**

Swifts are a migratory bird and spend their summers in Ireland. Preferring to nest in cracks and cervices unfortunately their numbers are in decline due to the loss of nesting sites. Three sets of swift nest boxes were installed under the supervision of BirdWatch Ireland at the Councils Thomastown Area Office in October thanks to the support of area engineer Declan Murphy. A caller system was also installed to encourage the swifts to investigate these potential nesting sites when they return to Ireland next May.

This project was a recommendation out of the County Swift Survey and the installation was funded by the National Parks and Wildlife Service under the Local Biodiversity Action Fund. Various council properties across the County have been examined for their suitability and the plan is to have more installations in the future. The Biodiversity Officer is also collaborating with other agencies to identify suitable sites to encourage swift box installation as a positive biodiversity action.

#### **Southeast Nightjar Project**

BirdWatch Ireland promoted the results of the Nightjar Survey which took place over the summer in Wexford and Kilkenny. The mysterious and elusive Nightjar is a summer visitor, it can be incredibly difficult to spot, only revealing its presence after dark, when the male engages in it's hypnotic 'churring' song.



Nightjars were once more common and widespread in Ireland. However, the numbers completing the journey to Ireland from African wintering grounds each May have diminished dramatically. This is thought to be related to habitat loss and a decrease in large insects due to the use of pesticides.

The aim of the survey was to confirm whether Nightjar still remain in Ireland and to learn more about this enigmatic species to help inform its conservation. The Nightjar survey concentrated on some of the most suitable remaining areas for Nightjar in counties Kilkenny and Wexford.

The survey revealed two sites with nightjar's present. Subsequent monitoring of these sites provided confirmation that one of these pairs bred successfully. The survey was completed by BirdWatch Ireland, supported and promoted by the Biodiversity Officer and funded by the Local Biodiversity Action Fund from the National Parks and Wildlife Service.

#### **FINANCE**

The expenditure by service division to the end of October is set out in table 1. Total Expenditure for the period was €103.9m compared with the annual budget of €111m.

#### Increased Cost of Business (ICOB) Grant Scheme

As part of Budget 2024, the Government signed off on a package of €257m for the Increased Cost of Business (ICOB) Grant as a vital measure for small and medium Enterprises. This rollout was managed through the local authorities and funded by the Department of Enterprise, Trade and Employment (DETE). Eligible businesses will receive a once-off grant which will be based on the value of their Commercial Rates bill in 2023.

A total of 2,450 grants were paid out up to 31st October 2024 with a value of €4,394,000. The scheme closed on 27th September 2024 and the online portal closed on 25th October.

#### Power Up Grant

As part of Budget 2025, the Government has announced a new €4,000 grant called Power Up, to assist businesses in hospitality, retail and beauty sectors. This rollout will be managed through the local authorities and funded by the Department of Enterprise, Trade and Employment (DETE). The main eligibility criteria are the same as for the Increased Cost of Business Scheme:

- The business must be a commercially trading entity currently operating from a property that is commercial rateable.
- The business must be trading at the time of submission and intend to continue trading for at least three months from the date of your submission.
- The rates account must be up to date. Businesses on payment plans may be deemed compliant.
- Your business must be tax compliant and possess a valid Tax Registration Number.

To date 573 businesses have applied for the grant

#### **Rates Revaluation**

Further to Revaluation 2017, 197 customers with a total rate demand value of €4.5m appealed their new valuation to the Valuation Tribunal. To date 191 appeals have been completed. The following is a breakdown of the appeal outcomes to date:
