Draft Register 2022/2023.
The Draft Register of Electors for 2022/2023 is currently being compiled.

In order to register to vote and be included in the Register of Electors 2022/23 a form called an RFA 1 form needed to be completed for each individual voter and returned to Corporate Affairs before the 1st November, 2021. These forms are available from www.checktheregister.ie and in all Council Offices.

Currently the Franchise Section of the Council are carrying out a data cleansing process on the existing Register of Electors database in preparation for the national system to modernise the Electoral Registers across the Country. In order to maintain an accurate Electoral Register an essential element is address accuracy. In this connection, it has been agreed nationally that the allocation of EIRCODES to each property on the system will help to address this issue.

We will be carrying out a campaign in the coming weeks through leaflet drop, local media and social media to ask people to contact the Franchise Section to provide their Eircode details for updating to the Register of Electors database.



### **Kilkenny Ring Road Extension**



### **Forward Planning**

### City & County Development Plan

The City and County Development Plan was adopted on the 3rd September 2021 and came into effect on the 15th October last. On the 15th October 2021, the Minister for Planning, Local Government and Heritage issued a Draft Direction to Kilkenny County Council as regards certain aspects of the adopted plan in particular in relation to the Wind Strategy. The Draft Direction was put on display for a period of two weeks from the 29th of October 2021 to the 12th of November 2021. Written submissions or observations in respect of the Draft Direction may be made to the Planning Authority during this consultation period and these shall be considered by the Chief Executive in her Report to be submitted

to the Office of the Planning Regulator by 10th December, 2021. The OPR then makes a recommendation to the Minister on the matter.

### Masterplans:

An appointment has been made for consultants to assist the Project Steering Committee for the St. Canice's Masterplan to commence the drafting of a Masterplan for the HSE's St. Canice's Campus. A Steering Committee workshop is scheduled for early November 2021. Once a draft plan is available it will be presented to the Council and HSE before it is put out for public consultation.

Work is continuing with the preparation of masterplan for Loughmacask. A draft Loughmacask Masterplan has been prepared and is being internally reviewed before it

will be presented to Members in the coming weeks prior to public display of the draft.

The preparation of the Fair Green Masterplan will recommence shortly.

#### Conservation

All protected structures in Kilkenny County and City are recognised for the following special interest: Architectural, Historical, Archaeological, Artistic, Cultural, Scientific, Technical, Social.

### **Historic Structures Fund:**

The total funding assigned for 6 projects in Kilkenny is €312,000. Applicants have noted challenges in acquiring trades people as a result of pandemic. The Architectural Conservation Officer is working continually with applicants and agents to deliver the projects by DHLGH deadline.

### **Historic Town Initiative:**

Works to St. Mary's Church boundary iron railings and masonry elements have been completed. The project has been part funded by the Heritage Council's Historic Town Initiative. The following were also delivered in October:

- Three new Architectural Conservation Areas were agreed as part of the City and County Development Plan 2021 – 2027. They are Kells, Piltown and Stoneyford
- Saint Canice's Architectural Conservation Areas and Freshford Architectural Conservation Areas have been extended as part of the new City and County Development Plan 2021 – 2027
- Three more structures were added to Kilkenny's Record of Protected Structures as part of the new City and County Development Plan 2021 – 2027
- The Living City Initiative continues, with inspections and letters of consent being issued in a timely fashion.
- Conservation work have been completed on the Black Freren Gate in Kilkenny City.
- Tender has been received for the assessment of Old Ennisnag Bridge. Following assessment of same, an appointment will be made by the of November 2020

Minister of State for Heritage and Electoral Reform Malcolm Noonan at the Department of Housing, Local Government and Heritage visited two conservation funded projects, Rothe House and Tynan's Bridge Bar, in Kilkenny.

There has been a steady increase in funding for Kilkenny

under the Built Heritage Investment Scheme from €98,000 in 2020, €117,600 in 2021 to €156,800 in 2022.


# **PLANNING**

### Vacant Sites

- There are currently 31 sites on the Vacant Sites Register, two of which are under appeal to An Bord Pleanála.
- The number of cancelled entries due to site activation or improvement now stands at 16 sites.
- Payment demands were issued on May 10th for a total of 23 sites.
- Owners had an opportunity to appeal the payment demands to An Bord Pleanála and we have received notice of 9 appeals.
- Following the recent changes announced in the National Budget, the Council is considering the process of additions for 2022.

### **Building Control**

391 valid commencement notices submitted to 31st October, 2021.
289 valid commencement notices submitted for the first 10 months of 2020, representing an increase of approximately 35%.



### **Environmental Complaints**

The number of complaints received by Environment staff for investigation to the end of October this year is 1,093. The vast majority of complaints continue to be related to littering and illegal dumping. Despite the restrictions imposed due to Covid-19, our **Enforcement Officers remain** very active on the ground in dealing with these complaints while adhering to Government and HSE guidelines.

### **Anti-Litter Initiative - Picker** Pals Programme

Picker Pals is an innovative primary school programme, inspiring children to become the next generation of environmentalists by leading their families on local litter picking adventures. In September, the Mayor launched the Picker Pals Programme in association with VOICE Ireland in the City. Funding from the Department of the Environment, Climate

and Communications permitted a further 20 classes to participate in the wider county. Schools, both green schools and non-green schools were notified of the opportunity and all spots have been filled allowing over 1,000 families to experience the litter picking programme over this academic vear.

### **Anti-Dumping Initiative**

The final KCLR radio promotion under the Anti-**Dumping Initiative took place** on the run up to Halloween. Radio adverts aired to remind business owners and householders to keep their rubbish secure and not offer waste for bonfires as it impacts on local air quality. Kilkenny County Council will promote the illegal dumping campaign for the coming months and **Elected Members are asked** to share the enforcement video across their social media platforms networks to ensure this important message reaches communities across the county.



### **Conscious Cup Campaign**

This campaign aims to reduce and eventually eliminate single use cups in Ireland. An information webinar was jointly hosted by Kilkenny and Carlow County Council. Kilkenny Lions Club is championing the campaign in Kilkenny City. The Council canteen in County Hall is signed up and is running a special staff promotion in November to encourage staff to present reusable cups when purchasing a hot beverage.

### **Bring Banks Usage**

The Council provides and manages 46 Bring Centres across the City and County. of glass and metal cans was collected for recycling. This compared to the October last year.



In October almost 163 tonnes represents a 12.6% decrease

### Environment staff are continuing to work very closely with our service providers to ensure the collection service is in keeping with demand, especially around long weekends.

### **Draft Casual Trading Bye Laws 2021 for the Municipal Districts of Castlecomer, Callan-Thomastown and Piltown**

Kilkenny County Council proposes to make Casual Trading Bye-Laws in respect of the Administrative and Functional area of the Municipal Districts of Castlecomer, Callan -Thomastown and Piltown. The Draft Casual Trading Bye-Laws 2021 are available for public inspection and the public are invited to make submissions or observations on https://consult.kilkenny.ie/ or in writing in respect of these Draft Bye-Laws on or before Friday, 10th December, 2021.



#### **IBAL**

Set up in 1996, Irish Business Against Litter (IBAL) is an alliance of companies sharing a belief that continued economic prosperity - notably in the areas of tourism, food and direct foreign investment - is contingent on a clean, litter-free environment. As part of the IBAL Anti-Litter League, An Taisce monitors towns independently and in accordance with international grading standards.

The results of the IBAL Anti-Litter League, Round 1, 2021 was released in October and Kilkenny City retained its perennial status as Cleaner than European Norms, despite slipping down the league table to 6th out of 40 towns / cities surveyed nationally.

### **Tidy Towns**

A Tidy Towns Forum took place in Woodstock Gardens on the 9th of October. A small number of people gathered to experience forest bathing and an Autumnal nature walk. The Tidy Town results are set to be announced later this month.

### **Climate Actions**

Kilkenny County Council's Climate Action Team Members of the Council's Climate Action Team are currently undergoing a **Building Capacity training** course delivered as part of the Local Authority Climate Action training programme. The training supports the work of the Climate Action Team in delivering local climate action measures across all local authority functions to align and meet national obligations on climate change. The Training will also assist the Climate Action Team prepare for the forthcoming Climate Action Plan that the Council will have to prepare next year.

Kilkenny County Council's Climate Change Strategy The Climate Action Team updated this years Climate

Change Strategy report and a summary of the progress report was presented back to the Climate Action Team prior to it being sent for appraisal to the Department of Environment, Climate, and Communications. The Strategy lists 96 actions with 235 associated sub actions. In 2021, 41% of sub actions were completed, 38% of sub actions are ongoing and 21% of sub actions remained incomplete. Further examination of the incomplete sub actions (50 in total), reveals that 31 of the actions were not completed due to the lack of financial resources while the other 19 actions were not completed due to Covid restrictions.

#### **Reuse Month**

A webinar series of sustainable living talks by Elaine Butler an advocate for sustainable living took place in October to celebrate Reuse Month. The series was widely advertised and was well received by the general public.

Reuse is about valuing our stuff, by using and reusing it for as long and as often as possible. This avoids the need to extract raw materials, manufacture and distribute new stuff, and avoids waste thereby cutting down on greenhouse gas emissions.

# **ENVIRONMENT**

### **Historic Landfill Sites**

There are 14 Historic Landfill sites (or closed landfills) in County Kilkenny formerly used by the Council for the disposal of waste. Local Authorities are required to carry out an assessment of the risk of environmental pollution on historic landfills according to a Code of Practice issued by the EPA. which involves a framework of assessments ranging from Tier 1 through to Tier 3 (remediation works). The risk assessment and remediation work at historic landfills are fully funded by the Department. The sites at Sherman's Ballyragget and Gowran are fully remediated and validation reports have been issued to the EPA. The following table provides an update for each Historic Landfill location

# River Basin Management Planning (RBMP)

The draft RBMP is now on

public consultation and sets out the proposed measures that are necessary to protect and restore water quality in over 4,000 water bodies throughout the country to good status. The draft Plan will be subject to a period of public consultation until the end of next March. Carol McCarthy from the Local Authority Waters Programme Office (LAWPRO) presented to SPC4 on the draft RBMP which will assist Kilkenny County Council in making a submission. The official opening of Ferrybank Neighbourhood Park and Playground took place on Thursday the 21st of October. Developed by Kilkenny County Council with assistance from the LIHAF fund and match funding by both Kilkenny and Waterford Local Authorities, the park has been open to the public since 2020 but the official opening could not take place due to Covid restrictions. The event was well attended by Elected Members, Council officials, invited guests from the local community and most importantly children from the nearby St. Mary's Boys primary school. The park has proven a hit with the local community providing a much needed green space for outdoor activity both passive and active. The playground is particularly popular and is busy every day.

In advance of the opening some minor repairs were carried out and a new pollinator planting bed was planted. Plants were provided by our neighbours in Parkside Nursery which is operated by the Brothers of Charity as an employment facility for adults with special needs

A second playground was also officially opened in late October. This time it was the turn of the local community in Piltown to officially declare their new playground open. This is a community playground, developed thanks to the immense effort of the local community who spent many years fund raising and seeking the ideal site. Kilkenny County Council also provided technical and funding supports to make this community vision a reality. The playground is located to the rear of the old Garda Station on Main street in Piltown in a scenic location on the banks of the River Pil. This playground has a wide range of play equipment but a large focus of the committee was to provide a sensory area



to support the needs of local children with special needs, in particular those with autism. Sand and water play, musical chimes and plants which children are encouraged to touch and feel are all part of this element of the playground.

Elsewhere in the county our annual programme of playground repairs has been completed and the total budget allocated for 2021 has now been utilised. Annual playground inspections will take place in December which will inform our programme of works for next year.

### **South East Greenway**

Construction of the South East Greenway is commenced with works progressing well from Rosbercon to Glenmore and in the Raheen and Ferrybank urban areas. The project is being carried out in a number of sections or 'Lots' to break the project down into more manageable segments.

#### Construction:

Lots 1 – 3 are progressing well and are on schedule for completion before end January next year. Works to apply the final wearing course along Lot 3, Raheen to Glenmore, are advancing and this element of the works, some 6km's, is scheduled for completion weekending 12th November. Thereafter the surfacing works will continue on Lots 1 and 2 with same expected to be completed before the end of the month.

### **Tackling Invasive Species** at Silaire Woods and Woodstock

Kilkenny County Council have commissioned 2 plans to tackle invasive species at Silaire Wood (Graiguenamanagh) and Woodstock Estate (Inistioge). Invas Biosecurity and Flynn Furney will map the problem species (Himalayan balsam at Silaire Wood; Cherry laurel at Woodstock) and propose long term management and control measures. Co-operation with other agencies such as Waterways Ireland, Coillte and neighbouring local authorities will be the key to success. The plans are funded by the

### Pollinator and wildlife friendly projects

As partners to the All-Ireland Pollinator Plan, the Parks Department is working to manage open spaces in a more sustainable way. Mowing is being reduced where practical across the county in an effort to increase the biodiversity of grass areas in parklands and playgrounds. Where new planting is carried out it is chosen for its pollinator

friendly characteristics . The two large meadows at Dukesmeadows and Bishopsmeadows which have been managed for wildlife for some years now, have received their annual cut. Many other areas are now being maintained using this approach and with the support of the public. These small measures provide a valuable source of food and habitat for insects, in particular our pollinators.



2021 Outdoor Recreational Infrastructure Scheme (ORIS) Announcement of 2021 ORIS Measure 1 Funding Applications

In April, the Department of Rural and Community Development (DRCD) announced that Measure 1 applications under the Outdoor Recreation Instructure Scheme 2021 would be accepted from Local Authorities and that each Local Authority could submit up to a maximum of 7 separate applications.

We are delighted to advise that all 7 applications were successful and works will commence on same once the funding agreement is in place between the DRCD and the Local Authority. A condition of this agreement stipulates 10% match funded must be provided for by the applicants.

### 2020 Outdoor Recreational Infrastructure Scheme (ORIS)

Works on 2020 funded ORIS Measure 1 projects has now been completed and a grant claim to drawdown the funding from the DRCD was submitted recently. Some detail and images of the works completed around the county are provided hereunder.

Brandon Hill Summit Walk -The works consisted on the installation of trailhead mapboards and directional markers from both the Deerpark and Raheendanore carpark

As part of the project Coillte agreed to undertake significant works to improve the capacity of their carparks that are used by trail visitors.



Goresbridge - Cois Bearbha riverside looped walk upgrade. -The works provided for the restoration of walkways, new seating. picnic benches and tree planting.

Nore Valley Walk Upgrade - The works undertaken included the replacement and renewal of all waymarkers and signage, upgrade of trail furniture and repairs to fencing / stiles along this very popular 20km trail.



Freshford Loop Walk Upgrade - Works consisted of the rehabilitation of a 500m section of trail along with the provision of a small parking area.





Woodstock Estate Promotional and Marketing Campaign – A greater emphasis to promote and market Woodstock Gardens and Trails commenced in 2018 having secured funds under the ORIS to develop same. In the intervening period, a strong social media presence has been developed promoting this amenity and some notable results are listed below:

- Increased our Facebook following by 3k since January 2021.
- Set-up an Instagram Page and achieved a following of 1.7k to date.
- Set-up a Twitter Profile and achieved a following of 170 to date and 616 engagements.
- Achieved a Facebook Reach of 396k, 6.3k engagements and an Instagram reach of 38k and 2k engagements.

#### 2020 ORIS Measure 2

-In addition to the above the Woodstock ORIS Measure 2 project is progressing well and some of the high lights include the restoration of 1.8km of the 2.7km Victorian pathways identified under this application for improvement. The removal of a significant amount of invasive plants in the vicinity of the waterfall. This clearance work has opened up a whole network of historic paths dating to the Victorian era which will soon be sympathetically surfaced ensuring we maintain

the character of the local area. This clearance has allowed parts of the estate, including views of Brownsford Stream waterfall that were previously hidden under laurel to be revealed. When opened up to

the public we believe this will be one of the finest walks in the County.

### **National Women's Enterprise Day**

A virtual conference took place on Thursday 7th October to celebrate National Women's Enterprise Day with over 1,000 entrepreneurs in attendance nationally. The theme for this year's event was 'Build the Future' with MC Aine Kerr, co-founder of Kinzen and former RTE broadcaster; along with 16 other inspiring speakers including Kilkenny based entrepreneur Kay Lyng, K Kajoux Jewels. Kay represented the Local Enterprise Office Kilkenny as their "Leading Light" and launched her new autumn/winter collection in the run-up to the event.

#### **LEO Statistics**

- A total of €680,245 in direct financial assistance was approved for 31 manufacturing /export service businesses located throughout the county. This assistance is linked to the projected creation of 149 jobs over the next three years.
- €220,285 in Business Expansion Grant assistance was awarded to 12 existing businesses with a forecasted job creation of 33 jobs. Business Expansion grants assist businesses trading greater than 18 months to make investment in growing their businesses and employment numbers.
- €240,375 awarded in Priming grant assistance to 3 start-up businesses with a forecasted job creation of 113 jobs. Priming grants assist qualifying businesses with start-up investment costs.
- €56,111 awarded in feasibility study grants to 4 businesses.
- 6 Technical Assistance for Micro Exporter grants were awarded totalling €13,900. This scheme supports businesses to explore their export market opportunities.
- 3 Grad Start Grants were awarded of €90,000, assisting LEO businesses to take on graduates to work within their business.
- 6 Green for Micro Grants were awarded totalling €12,870 This scheme supports businesses to becoming Greener and environmentally friendly.

### **Careers Kilkenny**

The biggest issue facing businesses at present in the skills shortage and to this end, we intend organising Careers Kilkenny 2021. The event will be held on 28th December 2021 in The Medieval Mile Museum, showcasing jobs from Kilkenny businesses who are currently trying to attract talent back to Kilkenny. The aim is to target employees who are home for Christmas and who wish to come back home to Kilkenny to live and work. Further details will to follow.



### South East - Green for Micro Conference

Fifty businesses from across the South East logged into the virtual 'Green for Micro' Conference which took place on Friday 15th of October. The aim of the conference was to support small businesses in the South East to engage with environmental and sustainability challenges for their business. Key note speaker, Duncan Stewart shared his insights with the group on how vital it is for businesses to address environmental issues within their business. This Conference marked the conclusion of the South East Green for Micro pilot programme, funded under the LEO Competitive Fund, and from which the national Green for Micro programme was developed.

# FIRE SERVICES

### **Capital Projects**

Request for tenders for the construction of a new Fire Station in Urlingford is currently on the eTenders website. The closing date for receipt of tenders is 1st December, 2021.

Identifying and sourcing a new site for Kilkenny City Fire is still ongoing.

Funding for three 4-wheel drive jeeps was approved by the National Directorate for Fire and Emergency Management (NDFEM). These jeeps will be located in Castlecomer, Urlingford and Graiguenamanagh fire stations in Q2 2022.

Fire Safety Certificates 82 applications for fire safety certificates were received to 2nd November 2021. 101 were received for the same period last year.

#### Fire Services Acts 1981 and 2003

- Fire Prevention staff made targeted and to enforce legislation.
- 70 Licence Applications were processed under Section 24 of the Fire Services Acts 1981 and 2003.
- 7 Dangerous Substance licence applications were received and assessed to date.
- 58 Fire safety inspections of premises have been carried out to date during the pandemic.





### **Community Fire Safety**

A number of Home Fire Safety Visits were carried out by Kilkenny City Fire Brigade personnel during October. Home Fire Safety Checks (HFSVs) are a significant element of our Community Fire Safety strategy. Fire service personnel call to houses by appointment and give fire safety advice to the occupants. A HFSV is usually carried out by two uniformed operational fire service personnel. They use a checklist to ask questions, try to identify the fire safety hazards in the house and recommend solutions. Fire safety advice is given, fire safety leaflets handed out and smoke detectors may be provided and fitted, where necessary. They also discuss the occupant's response should a fire inspections of premises both to provide advice occur in their home. The fire fighters leave the occupier with further advice and information, to also make available to other members of the household. The primary aim of these HFSVs is to reduce the numbers of fires, deaths and injuries in the home by firstly preventing fires occurring and to ensure that when fires do occur, the occupiers are given early warning, and they know how to react quickly and safely.

Kilkenny Fire and Rescue Service participated in

this years National Fire Safety Week. Activities included radio interviews. in conjunction with Kilkenny County Council's Social Club a fire safety competition was run, home fire safety visits were carried out in a number of homes. increased use of social media.





#### Literature

Your Voice Matters

The Arts Office works to develop, co-ordinate, motivate, inspire and empower artistic activity through the City and County. As we emerge from COVID-19 and look ahead to 2022, we want to



ensure that our adult literature programmes and activities are continuing to meet evolving needs and to this end we hosted two workshops for Kilkenny writers. The first session was held online on 21st Oct and the second session, in person, was facilitated on 27th October with the intention of hearing the writer's voices regarding our future plans for the programme. Anne Tannam, writer and creative coach facilitated these workshops.

## **Local Writers selected for Words Ireland's National Mentoring Programme**

Darren Caffrey have been selected by Words Ireland to receive professional literary mentoring over the next eight months from an acclaimed Irish writer of their choice. After a national call out, over 40 writers were selected from a total of 339 applicants. The Arts Office funded the literary mentorship with the Arts Council of Ireland to guarantee that the best applicants from the county would be selected. Their support will ensure that the chosen mentees receives this potentially life-changing support free of charge. It is also an investment in the long-term literary reputation of the county.

The mentoring process involves four meetings between the selected 'mentee' and their chosen professional writer. The mentor reads up to 10,000 words of the awarded mentee's writing in advance of each, then shares their critical feedback and advice. The hope is that the chosen mentees will go on to become published writers or indeed write great works of literature to match or beat the quality of their mentors. It's a form of peer to peer teaching that is increasingly popular in literature, formalising the process whereby masters pass on their craft to students.

# **BOOKVILLE**

Bookville Festival for families and children age 0 to 12 years is a multi-disciplinary festival with events including reading, writing, storytelling, comedy, illustration, music and the visual arts. The Arts Office and Library Service worked together again for the 5th year to celebrate books, writing, animation, illustration, comedy and all those magical things that come together to create a good story!

The festival supports further engagement in the Arts for families, children and young people. This year's Festival once again featured some of the best contemporary children's authors and illustrators from Ireland and around the world. 12,400 Bookville activity books, were distributed to every primary school age child in Kilkenny County and surrounds and to every library branch within Kilkenny County. The Festival featured in the windows of St. Canices Credit Union, the Book Centre, High St, Khan Books, James St, Meubles window, John Street.

New for 2021 are our fifteen free online events for primary schools and the general public, including storytelling, creative writing, illustration and music. The festival also presented an interactive exhibition in the Arts Office Window Gallery space in Johns Green House. The festival will be evaluated in the coming weeks in partnership with Kilkenny Education Centre

### Kilkenny Skate Park Makeover

The painting of the Park was completed in line with our original schedule and it has made an enormous difference to the aesthetic of the park and feedback to date has been extremely positive.

### **Finance Update**

The Covid-19 restrictions in place for the first six months of 2021 have had a serious impact on the Council's income streams to date, especially commercial rates and car parking income. A significant number of businesses had to close due to Covid. The Government announced an extension of the commercial rates waiver for the nine months to the end of September for businesses impacted. The value of this waiver amounted to €5.2m and compensation will be provided by Government for this amount. The cost of the waiver is included under miscellaneous services in the October Accounts. A more targeted commercial rates waiver for quarter 4 was announced by Government on October 12th last to support certain sectors. This 3-month waiver has modified criteria and accordingly is a separate, standalone waiver scheme from previous schemes.

The waiver (October to December) will apply to eligible businesses and will take the form of a credit in lieu of rates. The value of the waiver is the equivalent value of 25% of the annual rate bill for 2021 and applies to the following broad list of business categories: -

- · Hospitality, including restaurants and cafes;
- Leisure;

- Miscellaneous entertainment:
- · Certain tourism related categories; and
- Airports.

Over the coming weeks the Rates Section will automatically apply a 100% credit in lieu of commercial rates, for a three-month period, to classes and categories of occupied rateable property where the occupying business is not in an excluded category.

Income from car parking is also significantly below budget with only 55% of the annual budget figure received to the end of October. The forecast shortfall for the full year is between €700k and €800k. A submission has been made by the sector to the Department of Housing, Local Government and Heritage seeking compensation for the shortfall. Confirmation of this support has not yet been provided.

As previously advised to Members a number of discretionary expenditure items in the 2021 Budget totalling €2m have been deferred until more clarity is available on the projected outcome for the year.

The bank overdraft facility was not utilised in the ten month period to the end of October 2021.

### **Budget 2022**

Work has commenced on the preparation of the Council budget for 2022. A number of meetings have been held with Elected Members during October and November to date. The statutory budget meeting is scheduled to take place on November 26th at 3pm.

#### **Rates Revaluation**

Following the full revaluation of all commercial properties carried out by the Valuation office in 2017, 197 customers with a total rate demand value of €4.5m appealed their new valuation to the Valuation Tribunal. To date 187 appeals have been completed. 147 of the 187 appeals have resulted in a decrease in rates. The total income lost to date stands at €836k. If this trend continues the total loss of income may be in excess of €1m once all appeal decisions have been completed by the Tribunal.

### **Kilkenny's Native Small Mammals**


The native wood mouse and pygmy shrew once common in the Kilkenny countryside are in decline and appear to have been replaced by non-native invasive species like the bank vole and the greater white toothed shrew. Funding for this research project is provided by the Heritage Office under the National Biodiversity Action Plan Grant 2021. Public engagement with the citizen science element of the project was very successful and provided invaluable data. The project will help inform future projects to protect our native biodiversity, including keystone species such as the Barn Owl.
