ROADS:

The following serves as an update to Elected Members on some of the Capital projects currently ongoing in County Kilkenny:-

CLÁR Programme

The Department of Arts, Heritage, Regional, Rural and Gaeltacht Affairs advised in October 2016 that funding would be made available to Local Authorities under the CLÁR Programme (Ceantair Laga Árd-Riachtanais). Funding was to be targeted at small infrastructural projects in areas that have experienced significant depopulation in the past. Funding applications could be made under the following three categories:

- Safety packages for Schools/Community Facilities (100% CLÁR funding);
- Outdoor Play Facilities Enhancement Scheme / support for the development of Multi Use Games Areas (MUGA) (80% CLÁR funding matched with 20% Council funding);
- Local Access Roads (80% CLÁR funding matched with 20% Council funding).

The Council submitted a funding application to the Department on the 2nd November. The Council was informed of the outcome of this application on the 1st December 2016, details provided hereunder:-

The cost to deliver Phase 1 of this Programme was €100,000 and funding was provided for same from the Council's own funds in 2013.

The Council has extended this Programme and funding will now be provided for the roll-out of Phases 2 and 3. The cost to undertake this work is estimated at €105,000 and monies will be set aside for same in the Council's Roadwork's Budget over the next three years.

- Brewery site - an invitation to tender was published in November for “Urban Design Criteria and Recommended Development Code for the Implementation of the Abbey Creative Quarter Masterplan”. Closing date for receipt of tenders is 21/12/2016.
- A number of development proposals have been forthcoming along the Hebron Road to redevelop former industrial zoned land. The 2014 Development Plan contains an objective to prepare an Urban Design Framework Plan. To facilitate development proposals, invitations to quote were issued in November for “Urban Design and public realm Guidelines – Hebron Road, Kilkenny City”. Closing date for receipt of tenders was 16/12/2016.
- 2 applications were made under the Local Infrastructure Housing Activation Fund for the Western Environs, Kilkenny City and the Park in Ferrybank.

Proposed Housing Scheme at Bolton, Callan

Kilkenny County Council proposes to develop a scheme of 38 houses at Bolton, Callan with an option to develop on a phased basis. Plans are on public display from 2nd December to 27th January 2017. Submissions can be made up to 10th February, 2017.

Kilkenny Strategic Plan for Housing People with a Disability

The Housing Agency requested an update of our draft Disability Strategy submitted in 2015 to reflect the changes in the recent Housing Needs Assessment carried out by Kilkenny County Council in October 2016 and to reflect the outstanding data submitted by the HSE on Emerging Need. This updated draft strategy is now submitted to the Housing Agency for inclusion in the overarching National Disability Strategy.

The core goal of the Strategy is to meet the identified housing needs of people with disabilities locally whether they are currently living in the community and or in a congregated setting.

Pride of Place Awards for Kilkenny

Development Association took runner up place in category two, which is for areas with populations of between 300 and 1,000 while Piltown Community Enterprise took runner up place in category seven, which is for Community Business Enterprise Initiatives. The winners of the Pride of Place award, were announced at the special gala event in Belfast Waterfront Hall in front of an audience of approximately 1000 guests and VIPs. The Castlecomer Discovery Park also represented Kilkenny.

ABBHEY CREATIVE QUARTER

Abbey Creative Quarter Update

Demolition works on the former Brewery site were completed in October 2016 and the agreement for the purchase of the site was completed in November, with Kilkenny County Council taking possession of the site on Friday 18th November, 2016.

Works have commenced on the Archaeological Assessment of the Masterplan Area. Whilst there are some concerns in relation to the suitability of the site for Geo Physical or Ground Penetrating Radar Survey, a trial section of GPR survey has been undertaken within the former Brewery site and the results of this trial are awaited. The success or otherwise of the trial survey will determine if the survey will be extended within the site.

Brewhouse Building

An Bord Pleanála made a decision in early November that an Environmental Impact Statement (EIS) is not required in respect of the proposed redevelopment of the Brewhouse Building.

Investigative Works have commenced within the Brewhouse Building, with site investigation and structural testing works currently in progress.

Mayfair Building

Work has commenced on the preparation of a conservation plan for the City Walls in the immediate area of the proposed redevelopment of the Mayfair Building. Work is also being progressed to facilitate the required archaeological test excavations for the Mayfair project.

A detailed update on the implementation of the Abbey Creative Quarter Masterplan will be provided to Members in the New-Year.

CORPORATE SERVICES

St. Patrick's Day Parade, Kilkenny

The Council decided that the St. Patrick's Day Parade in Kilkenny be a civic event, with a specific provision in Budget 2017. It is now proposed that 4 no. Councillors be members of the St. Patrick's Day Committee, together with the existing non elected members, reflecting the funding allocation. Whilst work will continue towards the organisation of the Parade, nominations will be sought at the January meeting.

Funding has also been approved for County parades, and applications for funding will be sought early in 2017 from organising committees.

Rural Economic Development Zones (REDZ) 2016

Kilkenny County Council made a successful bid for REDZ funding for Inistioge Village and Woodstock House and Gardens, Co. Kilkenny, and a grant of €200,000 was notified to us on 29th November 2016.

Project Proposal: To restore and improve local economic resilience, using the stunning location,

natural and built heritage of the village of Inistioge, and adjacent Woodstock House, Gardens and Arboretum, by providing a mix of local infrastructure and the development of a coherent heritage and tourism destination which embraces the economic opportunity presented by Fáilte Ireland's tourism proposition: Ireland's Ancient East.

- Inistioge, Co Kilkenny - Heritage Village

- Public car parking to be provided in co-operation with the local G.A.A. Club, creating a "Visitor Arrival" area – with directional/location maps/interpretation.
- Riverside Walking Route interpretation and signposting etc, unifying Inistioge and the Woodstock Estate along the riverside trails of the Poyntz road and Nore Valley Walk towards Thomastown.
- Provide local community workshop/training and development of the Inistioge/ Woodstock story, facilitated by Fáilte Ireland, ensuring that storytelling, interpretation and signage, are all consistent with Ireland's Ancient East concepts.
- Involve local Woodstock neighbours who have potential business ideas complementary to proposed themes from a business plan

- Woodstock House, Gardens and Arboretum-

50 acres owned by Kilkenny County Council – a potential driver of economic development in Inistioge and surrounding area which is a significant untapped resource, with an annual commitment of €245K from the revenue budget of Kilkenny County Council, currently attracting circa 40,000 visitors per annum. The ambition is to develop Woodstock further, building on work done to date, including:

- Restoration of the feature Winter Garden to the front of Woodstock House

Signage/interpretation and improved paths and visitor facilities in Woodstock – in the area owned by Kilkenny County Council.

- Project Planning for the provision of an iconic tourism project at Woodstock House and Gardens.

The Council will work with the community and other partners to progress delivery of the plan.

LOCAL & COMMUNITY DEVELOPMENT

Local Economic and Community Plan (LECP)

The deadline for the first reporting period for actions within the Community element of the LECP was November 30th. Stakeholders have been asked to complete an online reporting template. Once all templates have been submitted a collective report will be compiled and will be presented to the LCDC in the first quarter of 2017. In total reporting is being sought on 84 actions across 22 agencies/groups/departments.

Social Inclusion Community Activation Programme (SICAP)

The SICAP monitoring subgroup met with the Programme Implementer during the month to review the draft 2017 Annual Plan. Recommendations from the subgroup will go before the LCDC at their December meeting. An indicative allocation of €607,813 has been identified for the SICAP programme for 2017.

Public Participation Network (PPN)

Over the past 4 months membership of the PPN has increased by 13%. With its newly elected representatives in place a training programme for

representatives and members has been developed for 2017. The PPN is currently undertaking a piece of research to ascertain the barriers to engagement for groups that are the most distant from engagement in the community. Kilkenny LEADER Partnership and the PPN are now working together to develop the Kilkenny Volunteer Information Service in line with the PPN action in the LECF. The social Inclusion Pillar of the PPN has developed a working group to strengthen the pillar and support the representatives; the plan is to create a model of best practice for replication within the other 2 pillars.

Other Community & Culture Projects:

Community, Sports, Arts & Youth Facilities Audit:

The questionnaire for this project was piloted during this month with 19 groups being invited to participate in this pilot. The aim of this pilot is to inform any changes needing to be made to the final questionnaire in terms of ambiguities, omissions, clarity and layout etc. NEXUS the consultants undertaking the audit will run a workshop with pilot participants to discuss and capture the groups' experiences with the questionnaire.

Kilkenny Comhairle na nÓg:

In November, Kilkenny County Council issued a call for proposals from suitably qualified organisations / individuals for the Operation of Kilkenny Comhairle na nÓg on behalf of the Council for 2017 & 2018. The outcome of that process will be finalised in December.



Children and Young Peoples Services Committee (CYPSC):

CYPSC organised a workshop in Hotel Kilkenny on November 30th for staff of agencies and organisations working in the area of children, youth and family service provision in the county. The purpose of this workshop was twofold – to allow the opportunity for agencies and organisations to network and secondly to discuss key issues / priorities to be included in the Children and Young Persons Plan currently being developed by CYPSC.

LOCAL ENTERPRISE OFFICE

UPDATE TO 08.12.16

€490,671 in grant aid was approved to 25 business projects. These projects combined will create at least 53 new full-time jobs at a cost per job of approximately €9,250 in addition to sustaining existing jobs. €50,000 of this grant aid came from Kilkenny County Council funding.

527 people have participated in **enterprise training and management development programmes** in 2016. These range from Start your own Business through to Sales & Marketing and Financial training programmes as well as our flagship Management Development Programme.

316 clients availed of **Business Advisory Sessions** with LEO staff. These are typically people thinking of setting up in business or those in the early stages of self-employment that need advice.

8 Outreach Clinics in the library network providing business advice took place throughout the county in 2016 aimed at those thinking of setting up in business or those in the early stages of self-employment that need advice.

117 businesses attended **one-to-one mentor clinics** to help them address issues they face in their business.

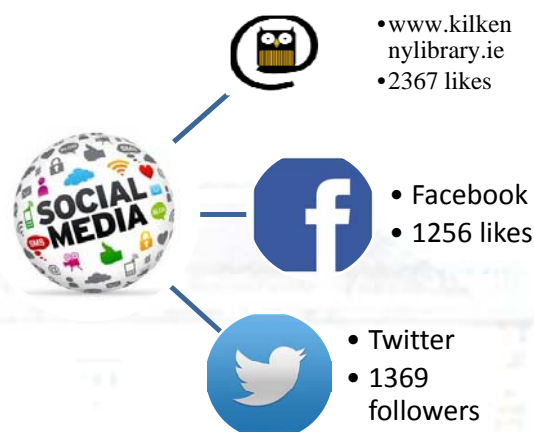

12 businesses were approved **Smart Option Business Loans** from St. Canice's Credit Union in conjunction with the Local Enterprise Office Kilkenny.

287 businesses were approved **one-to-one mentoring support** to help them address issues they face in their business. LEO Kilkenny has an extensive panel of local mentors with specialist skills to call upon to assist business owners.

26 businesses were approved **Specialist Support Grants** (of 50% of eligible costs up to €1,000) to attend Trade Fairs and Market Visits Abroad.

13 schools and **649** students are currently involved in the **Student Enterprise Programme** in the secondary schools throughout the County



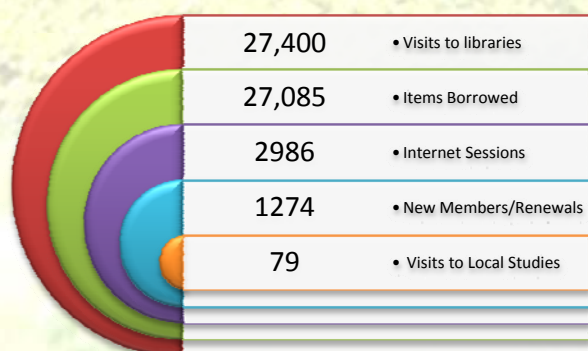

National Science Week

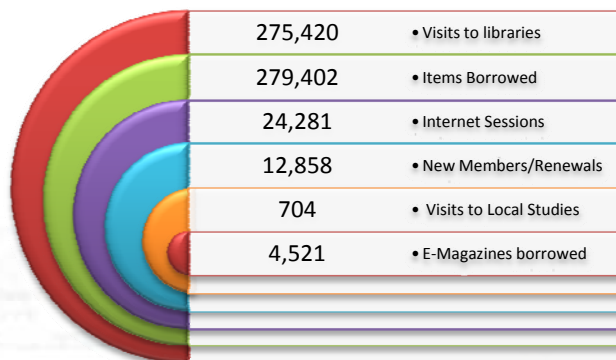

All men surveyed agreed that they felt more confident doing physical activity, 31% of men felt like a more active member of their community and 100% of men agreed that they are more opportunities for physical activity as a result of the Men on the Move programme. We are looking forward to the results of the survey in the remaining communities and hope the same benefits will be evident!

Finance Report – December 2016.

The expenditure by service division for the ten months to the end of October is set out in table 1. Total Expenditure for the period was €64.49m compared with the annual budget of €67.18m.

Cash collection for the main income streams has increased by €715k from the total collected at end of November 2015. Collection levels for Commercial Rates have improved by 2% from the same period last year. Kilkenny County Council is on course to meet its performance indicator targets for cash collection in 2016.

The bank overdraft facility was utilized on 155 days to the end of November 2016 and the maximum overdrawn balance was €6.2m.

The term loan of €13.5m approved by Council in September has been drawn down in the week ending December 9th.

The Valuation Office has commenced the detailed work on the full revaluation of all commercial properties in Kilkenny. It is important that all property owners respond promptly to any communications they receive from the Valuation Office.
