### **Community Enhancement Scheme 2018**

Kilkenny Local Community Development Committee (LCDC) has awarded €136,300 to Community Groups under the 2018 Community Enhancement Scheme.

The funding was allocated by the Department of Rural and Community Development and is administered by Kilkenny LCDC for the purposes of addressing disadvantage areas and targeted groups as identified in the Kilkenny Local Economic Community Development Plan.

30% of the funding was directed towards small capital grants of  $\epsilon$ 3,000 or less and the remaining 70% was directed at medium capital grants to a maximum of  $\epsilon$ 10,000.

Kilkenny LCDC has awarded 47 grants in total, 29 under the small grants scheme and 18 under the medium grants scheme.

# Men's Shed Funding

A separate allocation of €8,696 has been made available to Kilkenny LCDC in respect of Men's Shed that are affiliated to the Irish Men's Shed Association. There are 6 such Men's Sheds in Kilkenny and the allocations will be made by Kilkenny LCDC shortly.

There were many contributors to this project including the local KBK Community group which has to be applauded for this project. Kilkenny County Council also contributed by providing the local community with the original property, with a grant under the Community and Cultural Facilities Grant Scheme 2017, pavement improvement works and advice and guidance.

Thomastown Community Helpers officially opened their recycling shop in Logan Street in Thomastown. The group pride themselves on helping local people & families who are in need of furniture, clothes, electrical goods, food, vouchers, hampers and other good causes. Kilkenny County Council provided advice and guidance and other assistance to this community project at different stages

Kilkenny County Councils contribution was acknowledged at the recent opening of Mullinavat Park and Playground which was provided with the assistance of a grant under the Council's Community and Culture Facilities Grant Scheme 2017. The Council's grant under the 2016 Community and Cultural Facilities Capital Grant Scheme and other assistance was also acknowledged at the opening of Mooncoin GAA new astro-turf pitch.

#### ROADS

N25 New Ross Bypass

The design and construction phase of the PPP Contract is approximately two-thirds complete, and the scheme remains on programme to open in 2019.

The construction of the main spans has commenced from Pier 4 (river pier) using "form travellers". These moveable steel frames were initially assembled side by side on top of the pier and contain the formwork system that casts the concrete deck. The travellers have now separated and moved out in opposite directions from either side of the pier to cast the first deck segments. By this incremental method, the deck is launched, segment by segment, as the separate form travellers move out and away from both sides of the pier. Similar traveller systems will be launched from the piers on the opposite sides of the main spans (i.e. piers 3 & 5) and the separate decks will thus cantilever out incrementally from each pier until they meet in the middle of the span. This process will continue to progress over the coming months. The approach spans on the western (Kilkenny) side continue to progress towards completion, while span 6 on the eastern (Wexford) side is also nearing completion. Night time works on the bridge have commenced following completion of the necessary consultation and approval processes.

The full roundabout on the N25 at Glenmore became operational under temporary traffic management on May 29th. This traffic management will remain in operation until final finishing works are completed which is expected by mid September. At that stage the roundabout will continue to operate without traffic management.

Bulk earthworks are now substantially complete and drainage works are over 75% complete. Pavement foundations are also well advanced and pavement layers have continued to be constructed over the summer months.

Monitoring, maintenance and emergency regimes continue to be operated as necessary on public roads at interfaces with the site to ensure that road surfaces, temporary management systems etc. continue to operate safely and as required. The site continues to be monitored for the generation of noise, vibration and dust. The dry summer weather has created challenging conditions for the generation of dust and mitigation measures are being closely monitored to minimise any impacts neighbouring properties.

The project website <a href="www.n25newross.ie">www.n25newross.ie</a> continues to provide progress updates as well as information on traffic management and road works, and also provides contact details for the project. The 24 telephone hotline continues to operate to deal with any queries or complaints from the public. The number is 1800 815672, and this number has been posted on both the newsletter and website. The Project Liaison Office will continue to liaise and consult with all landowners and other interested parties for the duration of the project.

### **B12** Maintenance

The Municipal District Offices log defects on the national roads via the NRA Geo App. Kilkenny County Council was successful in obtaining funding of a total of €208,681 from TII to address defects identified at 7 locations on the N24, N78 and N77. The Municipal District Offices are addressing these defects with a view to completing all before mid November.

#### Capital Maintenance

Kilkenny County Council has been successful in obtaining funding of a total of €313,500 from TII to address defects identified at Kilbride, Kilamery and Kiltallaghan on the N76 Callan to Clonmel Road. The works at each location will involve planning out the existing wearing

course, laying a regulating course, reinstatement with HRA and replacement of road markings and studs. These works shall be completed via an external contractor before the end of November.

## Pavement Schemes.

- 1. N78. The N78 pavement overlay scheme with a contract value in excess of €2 million is approximately 50% complete. This scheme involves repairs to the existing pavement, a structural overlay, road markings, drainage and footpath works over an extent of approximately 6km between Castlecomer and Crettyard. The works are being completed by LAGAN.
- 2. **N25**. The N25 pavement scheme over two sections totalling approximately 4km, Gaulstown to Graiguenakill and Luffany to the Rhu Glenn is presently out to tender.

# Local Infrastructure Housing Activation Fund Schemes (LIHAF)

# Kilkenny Western Environs Phase 1 Infrastructure Scheme

The procurement process for the construction of the Western Environs enabling infrastructure has been completed and the successful contractor identified. Approval to proceed with the contract on the basis of the lowest tender received is currently being sought from the Department of Housing, Planning, Community, and Local Government (co-funders of project with Kilkenny County Council). It is envisaged that this approval will be forthcoming in early October, followed by the appointment of the the contractor and commencement construction prior to Christmas.

### Ferrybank Neighbourhood Park

A preliminary design for the park prepared by the appointed designers Cunnane Stratton Reynolds Landscape Architects was approved in June. The detailed design and contract documents for the construction are due to be completed in September, with a view to conducting the procurement process, obtaining Departmental approval to proceed, and appointing a contractor for the park construction prior to Christmas. This park will be funded by a combination of Department of Housing, Planning, Community, and Local Government LIHAF funding, and Kilkenny and Waterford County Councils.

## Northern Ring Road Extension

As advised to members on 17th August, 2018, there is a case in the High Court taken by landowners adjoining the proposed An Bord Pleanala decision relating to the Kilkenny Northern Ring Road Extension. The High Court referred certain questions concerning the application of EU Directives by national authorities to the CJEU for clarification, before the High Court takes a decision in the case. No decision has yet issued from the CJEU. However an opinion was issued by the Advocate General in the first week of August, 2018, as is normal in these cases. The CJEU will issue it's decision in due course, whereupon the High Court will then make it's finding in the matter.

#### HOUSING

### Capital Delivery 2018

The Minister for Housing by letter dated 18th April 2018 notified Kilkenny County Council of its revised delivery targets under Rebuilding Ireland i.e. 599 units for the period 2018 to 2021 and a specific target of 133 units for 2018.

During the summer months of 2018 a number of schemes advanced as follows;

- Rural house at Barna, Freshford completed in August 2018.
- Construction in progress on the conversion of Greensbridge B&B and adjoining house to 5 self contained 1 bed units. Expected to be completed in September 2018.

#### FORWARD PLANNING:

## County & City Development Plans:

The Council published the statutory notice on the 20th April signifying the commencement of the review of the County and City Development Plans. The public consultation stage included publication of an Issues Paper and three public consultation meetings in addition to other meetings. Fifty three submissions were received and a Chief Executive's report has been prepared for consideration by the Council.

The Planning and Development (Amendment) Act 2018 includes a provision to suspend the Development Plan making process until after the making of the Regional Spatial and Economic Strategy(RSES). This section (s.12) of the Amendment Act has not been commenced to date, but it is understood that it will be commenced shortly. Once the Section (s12) is commenced it will allow the process of making the Development Plan to be suspended until 13 weeks after the adoption of the RSES. A draft RSES is expected to be published in October of this year.

# Local Area Plans: CALLAN

Work continues on the pre-draft stage of the Callan Local Area Plan. A total of 9 submissions were received to the pre-draft consultation process, and in addition many issues were raised at the public consultation event on the 27th June. An update on the progress of the LAP will be presented to the Kilkenny Municipal District meeting on the 14th September.

#### **THOMASTOWN**

Work continues on the pre-draft stage of the Thomastown Local Area Plan. A total of 9 submissions were received to the pre-draft consultation process, and in addition many issues were raised at the public consultation event on the 11th July. An update on the progress of the LAP will be presented to the Kilkenny Municipal District meeting on the 14th September.

### **Vacant Sites**

Work is continuing on the administration of the Vacant Sites Levy. There are now 19 sites on the Register, following another cancellation due to site being activated in August. This brings the total number of sites cancelled due to activation to four. Section 11(1) notices were issued in May, with all the details of the sites currently on the Register. Six submissions were received to these notices. Following that, six Section 11(3) notices were issued in July, and there are currently three appeals with An Bord Pleanála on foot of these notices, for sites ref. VSR11 Callan Rd/Circular Road, VSR16 Chatsworth St, Castlecomer and VSR20 Oak Ridge, Ferrybank. Responses to the appeals have been forwarded to the Bord.

The Planning and Development (Amendment) Act 2018 brought in three main changes to the Vacant Site Levy. The first was to increase the amount of the levy to 7% from 2019. The second was removing the provision for reductions in the levy for sites in negative equity. The third was clarification on agricultural land, that if the site is being farmed and was purchased prior to its designation as residential land, the owner cannot be levied.

# Local Agenda 21 Environment Partnership Fund 2018

Details of the awards under the Local Agenda 21 Environmental Partnership Fund (LA 21) were issued by the Department of Communications, Climate Action and Environment (DCCAE) over the summer. 18 Kilkenny projects received the green to start their environment themed projects centred on sustainable development.

These include projects aimed at supporting and complementing national environmental policies on Waste, Biodiversity and Sustainable Development. Projects will be co-funded between the DCCAE and Kilkenny County Council and the total fund is €21,850. The successful applicants have been notified and will receive 50% of their grant before the end of September with the second half of the grant due on receipt of their completion report before end of April 2019.

# Anti Litter & Anti Graffiti Awareness Grant 2018

Details of the Anti-Litter & Anti-Graffiti Awareness Grant Scheme (ALAGS) was issued on the 26th April 2018 by the Department of Communications, Climate Action and Environment (DCCAE). DCCAE provided a grant of €23,000 which is 70% of the total contribution, the remaining 30% is to be met by local authority contribution.

The DCCAE provided guidelines on eligible projects to include; projects highlighting awareness of issues regarding dog fouling, plays, puppet shows, interactive workshops, art projects mainly aimed at schools, provision of anti-litter awareness materials, local advertising and projects/activities should seek to promote greater public awareness and education in relation to litter and/or graffiti.

Kilkenny County Council allocated €15,000 towards a community Anti Litter and Anti Graffiti Awareness Grant. The remaining allocation funded activities in 2018 such as anti litter murals, the tidy towns forum, the national spring clean, roadside litter campaign, supported anti dog fouling & litter initiatives and primary schools educational activities.

After advertising the community grant, 19 community Anti Litter and Anti Graffiti Awareness Grant applications were approved for funding.

The European adjudicators arrived in Inistioge on 20<sup>th</sup> July to a rapturous welcome. The village was in full bloom and the adjudication team was given a warm welcome. The partnership forged in recent months between the community and Kilkenny County Council will leave a lasting

legacy. The European awards ceremony taking place in Tullamore this September and is eagerly awaited.

# Update on the River Basin Management Plan for Ireland

On 17th April 2018 Minister Eoghan Murphy TD published the River Basin Management Plan for Ireland 2018 – 2021. This sets out the approaches to be taken over the next four years to protect and restore good water quality in our rivers, lakes, estuaries, groundwater and coastal waters. The processes behind developing this plan involved extensive consultation with the public, water stakeholders, public agencies and Local Authorities.

The Plan establishes a framework for coordination between local authorities and public agencies to achieve water quality improvements that will protect public health and amenities, wildlife, and our economy. A reliable supply of good water quality is vital for industries like agri-food, pharmaceuticals and tourism, across the entire country.

Public consultation on the Plan in Kilkenny was led by Ann Phelan, Community Water Officer with the Local Authority Waters & Communities Office, through public meetings held in Kilkenny (3rd May 2017), Thomastown (4th May 2017), Mooncoin (8th May 2017), Ballyragget (17th May 2017) and Graiguenamanagh (13th June 2017). Members of the public and community groups were invited to make written submissions on local water interests and issues and these were collated and sent to the Department of Housing, Planning and Local Government and have informed the measures set out in the new River Basin Management Plan.

In addition, a South East regional workshop took place in June 2017, organised by the EPA and Local Authorities. Here, representatives from the relevant public agencies and Local Authorities discussed in detail water quality in

every catchment, and a total of 34 Priority Areas for Action (PAAs) were identified in the South East Region for action under this Plan. 7 of these areas for Action are located in County Kilkenny. The Environment Section held a public engagement and feedback session on these 7 Areas in Kilkenny on 16th October, 2017. A separate session for elected members was held on 23rd October 2017.

The lead Local Authorities (Kilkenny and Tipperary County Councils) have now finalised the recruitment of 35 scientists for the country, who have specific responsibility for the local assessment of water catchments and the design of specific site and field scale actions to be taken to ensure implementation of the River Basin Management Plan. This new science team is called the Local Authority Waters Support and Advice Team and they are based in ten different locations across the country, including here in Kilkenny.

The Catchment Manager for the South East Region is Ruth Hennessy, and she and her team work closely with local authority staff, the Waters and Communities Office, the EPA, and other public agencies to drive implementation. In addition, the teams work closely with the 30 advisors in the Agricultural Sustainability Support and Advice Programme (ASSAP) which is being led by Teagasc and the dairy industry.

The advisors will provide a free service to farmers in the Areas for Action. The teams are currently preparing Implementation Programmes for each region and commencing desk top studies of each of the Areas for Action. It is anticipated that field work will commence in October.

Before commencing work in each Area for Action, there will be engagement with the local communities and stakeholders to explain the process of local characterisation and to share knowledge about the water bodies in the Area. Additional engagement will occur with the farming community, led by the ASSAP advisors.

There will be periodic reporting on progress to the Environment SPC.

Ann Phelan Community Water Officer for South East continues to work with communities on awareness campaigns around water quality and meeting the objectives of the water framework directive.

LAWCO collaborated and participated in the Entente Floral in Inistioge 20th July 2018, to showcase to the judges the level of awareness in the community, and the importance of community involvement in river basin management. LAWCO is now working with LAWSAT Teams.

The KCLR Big Spring Clean-up took place in April 2018, this was a collaboration with local radio, LAWCO Kilkenny County Council and Carlow County Council. The purpose of the imitative was to focus attention on cleaning up our rivers. The Saturday Show ran four outside broadcasts from various river clean up locations. Campaign ran over six weeks, involving sports clubs, young people and schools. There also was a colouring competition in the schools using the

colour of LAWCO office. The schools that participated received their awards in the studio of KCLR and the programme has been nominated for an IMRO award on 3<sup>rd</sup> Oct on social mobilisation.

There has been a schools' engagement campaign about water quality issues taking place in schools in the Priority Water Bodies of Duiske Graignamanagh and Breagagh, Kilkenny.

In conjunction with Heritage Council, Heritage Officer Dearbhala Ledwidge, there were several events taking place for Water Heritage Day, which is now firmly established, and allows LAWCO to bring a national focus to our natural Water Bodies, getting community engagement while raising awareness of the RBMP. Several events took place in the Outdoor Activity Centre Graignamanagh, Castlecomer Discovery Park and Thomastown on the River Nore.

Two projects were successful under the community Water Development fund (grant scheme developed by LAWCO) Keep Kilkenny Beautiful invasive species control, and Outdoor Activity centre for engagement of expert in natural flood methods.

### Historic Landfill Sites- Up-date

In August, following a competitive tendering process, Consultants Fehily Timoney & Company were appointed to undertake an environmental risk assessment on the five historic landfill sites listed below:

- Thorpes
- Skehana
- Seven-Houses
- Oldcourt
- Talbotsinch

Site investigation works have now commenced at Skehana and Seven-Houses and works on the other three sites is due to start over the coming weeks. The completion of this stage of the process will determine if further investigation works are required and/or remediation measures necessary.

It is also anticipated that remediation works will commence this year at the landfill site in Rockfield, Gorwan. In addition, the Part 8 Planning process will also commence to facilitate remediation works at Sherman's landfill site which is located south of Ballyragget.

#### **Bring Centres**

The Council has recently mapped the Bring Centre locations within the City and County, which includes details on the recycling services provided at each site and when the site was last inspection by the Council or its agents. This information will be available shortly to members of the public through the Council's website via the Environment Section portal.

Works are due to commence on the replacement of the Bring Centre in Bigwood in the coming weeks and a number of new sites are currently being assessed for suitability.

As new Bring Centre sites are rolled out and funding becomes available to upgrade the existing facilitates, the Environment Section intends to replace the existing signs with newly designed signs which translate a more positive recycling message. These new signs will include an image of a Bee (Bumbus Hortorum), the agreed emblem, to raise awareness of the importance of Bees which is a key action in the recently adopted Council's Pollinator Action Plan.

# ENTERPRISE IRELAND - REGIONAL ENTERPRISE DEVELOPMENT FUND:

Both applications submitted to Enterprise Ireland for funding under the REDF last June (involving Kilkenny County Council as partners) have undergone the initial assessments and have been successful in progressing to stage two of the process which a competitive pitch. Bid teams involved in the application processes for the development specialist of Enterprise Development / Innovation Hub (Centre for Design) and A Centre of Excellence for Precision Agriculture (PACE) will have an opportunity to meet with the Enterprise Ireland Evaluation Panel over the coming weeks to pitch the projects.

# URBAN REGENERATION & DEVELOPMENT FUND:

A new Urban Regeneration and Development Fund (URDF) has been announced as part of Project Ireland 2040, to support the compact growth and sustainable development of Ireland's five cities and other large urban centres. The Department of Housing, Planning and Local Government (DHPLG) has responsibility for implementing the URDF, which has an application of €2 billion in the National Development Plan up to 2027. A call for proposals is currently open.

Two applications are currently being prepared by Kilkenny County Council namely, to develop public realm infrastructure and related projects as part of the regeneration of the Abbey Quarter and surrounding areas; and in conjunction with Waterford City & County Council for the provision of critical infrastructure in the Ferrybank / Belview area. The closing date for receipt of applications is 28th September next.

# **Adult Writing Workshops Autumn 2018**

As part of our on-going commitment to Kilkenny writers, the Arts Office and Kilkenny Library Service hosted autumn workshops in Poetry Writing for Beginners in Urlingford Library and Journalling for Beginners in Thomastown Library. Tutor Lani O'Hanlon, a writer, dance and movement artist/therapist facilitated the Poetry Writing course and helped the participants explore how their own sensual memories could become contemporary poems.

Tutor Tara Heavey, published novelist and short story writer, facilited the Journalling for Beginners course and helped the participants discover the writer within themselves and led exercises such as the character sketch, captured moments, guided imagery and dream logs. These six week courses started in Thomastown on 5<sup>th</sup> September and in Urlingford on 18<sup>th</sup> September and will finish in October.

Blackstack Studio invite visitors to get some ink and try some live, hands on screen printing, mono printing or relief printing. The bank overdraft facility was utilized for three days during the eight months to the end of August 2018.

Collection rates to the end of August on all the main income streams are approximately 3% higher than the comparable figures for the previous year. It is too early to predict if this performance will hold through to the end of the year.
