Notice is hereby given, that at a meeting of the Council to be held after the expiration of 10 days from the date of this notice, it is the intention of Kilkenny County Council, in accordance with Section 183 of the Local Government Act, 2001, to dispose of its interest in a plot(s) of land at Shankill, Paulstown, Co. Kilkenny – as identified on the attached map - to Mr Sean Esmonde, Graiguenaspodogue, Nurney, Co. Carlow for Nil Consideration. Kilkenny County Council to be responsible for all legal fees relating to this matter and will arrange Boundary Amendment with Land Registry to minimize legal fees and charges. Plot(s) combined measures 80.94m<sup>2</sup> (0.02 acres). The Consent of the Minister for Housing, Local Government and Heritage is not required.

### **BACKGROUND**

These plot(s) of ground were originally acquired as part of the development of the M9 Motorway and were subject to a previous S183 approved by the Members at the meeting on 20<sup>th</sup> July, 2020 for a land exchange with Mr Sean Ryan. However, the contracts for sale were not completed and Mr Sean Ryan is now deceased and the new beneficial owner will be Mr Sean Esmonde.

Plots 536-Z1, Z3 and Z4 were acquired for recessed field gates, but were not used. Plot 536-Z5 was acquired for a watercourse realignment but again not used as the watercourse was realigned on the other side of the road. The total combined area of the four plots is 80.94m<sup>2</sup> (.02 acres).


Mr. Esmonde has agreed to transfer Plot 536-2 to Kilkenny County Council in an exchange for the above four mentioned plots.
