1. Reception of Deputation

(a) Deenside Wheelers Cycling Club

Mr Martin Delaney & Mr Peter Ring attended on behalf of Deenside Wheelers. They thanked the members for affording them this opportunity and spoke of the many dangers cyclists encounter as a result of lack of cycling infrastructure and investment, traffic volumes, appropriate signage, driver behaviour and the need for increased enforcement and education.

Ms Catriona Corr, Sustainable Mobility Officer with Kilkenny County Council attended. Ms Corr updated members on funding streams utilised and recommended the establishment of a Steering Group to look at both available funding streams and individual cycling routes.

Contributions were received from the members as follows:

- The many benefits to be gained from cycling and the importance of encouraging safe cycling.
- The Schools Programme as a possible base to educate and raise awareness.
- Challenges with cyclists sharing our roads with large machinery.
- The need to look at cycling facilities in Castlecomer Town where Deenside Wheelers have no cycle lanes to access their base at the Old Fire Station.

Members agreed a letter would issue from the Castlecomer MD to the Transportation Policy / Mobility Management & Infrastructure SPC asking that they consult with Ms Catriona Corr, look at the issues raised by the deputation and report back to the Plenary meeting.

It was also agreed Garda Paul Donoghue, a member of the Waterford, Kilkenny and Carlow Divisional Roads Policing Unit of An Garda Siochana would be invited to attend a meeting of the Castlecomer MD.

Details of the various in person events held were provided. Ms Moloney also provided details together with examples of the 6 objectives contained in the Action Plan.

Ms Moloney was thanked for the presentation provided, members acknowledged her engagement with communities, her commitment and enthusiasm.

(b) Environment update

Ms Catherine Cunningham updated members on complaints received to the Environment Department in 2024 as follows:

- 756 complaints received
- 43 carried over from 2023
- 786 closed
- 598 related to illegal dumping
- Complaints received are split between two enforcement officers for the County
- 30 complaints received in respect of the Old Ballyragget Road
- 70 enforcement cases in 2024, 20 so far in 2025
- Expenditure:- illegal dumping €31,000, City lanes €24,000 and clean up at bring banks €50,000

Contributions were received from the members as follows:

- The excellent work completed by the Environment Team was acknowledged by all.
- The need to portray a positive message to the media of the Council's determination to tackle illegal dumping.
- Amendments to relevant environmental legislation to ensure enforcement practices can continue will be welcomed by all.
